**Statement of Reasonable Cause for Late Filing of 2023 Form 5500  
for DB Plan 001 in 2024**

We request to have all penalties removed for late filing of Form 5500 for DP Plan 001 of the Institute for Community Research (ICR) for the year ending 12/31/2023. Late-filing of the plan in 2024 was inadvertent and was not previously realized for the following reasons.

ICR had two retirement plans for the year 01/01/2023 – 12/31/2023. One of them is a 403(b) (Plan 002) and the other one is the DB pension (Plan 001). The DB Plan 001 was terminated on September 1, 2023, and final distribution of all benefits was completed by December 23, 2023. The ICR Plan Manager works closely with agents at Mutual of America (MoA), who manage all of ICR's retirement accounts. MoA provides an online client portal, Sponsor Connect, to assist the ICR Plan Manager to file Form 5500 to both the Department of Labor and the IRS at the same time.

Due to the termination of DB Plan 001, MoA assigned a new Client Manager to ICR. The new MoA Client Manager only saw one active retirement plan, so worked with the ICR Plan Manger to file Form 5500 only for Plan 002 on October 14, 2024. The ICR Plan Manager was unaware that the DB Plan 001 also needed a Form 5500 for the year ending 12/31/2023.

We only recently came to the realization on October 22, 2024, that the terminated Plan 001 still needs a final Form 5500 filing. We currently have all data and forms prepared and filled on October 31, 2024.
