To Whom It May concern:

This letter is to explain the reason for not filing in a timely manner.

The TPA company that was hired to manage this plan dropped our company because we are not “considered heavy investor”. That left me and my wife to acquire the appropriate help to file the required forms.

During this period, my mother-in-law had a horrific car accident leaving her permanently disabled (fracture pelvic, femur, ribs, shoulder blade, wrist, forearm, collapse lungs, and a brain aneurysm) on impact. She was the passenger. My wife and I are her sole provider and caretaker. It took over 18 months of multiple surgeries and rehabilitation to get her to be able to perform the basic life skills. I have attached pictures

Trying to see the light at the end of the tunnel, then, our youngest daughter tried to commit suicide and was hospitalized, which sent my wife into deep depression. Both are getting the help they need. As a husband, father, and business owner, I put my family health and needs first. I understand there are penalties for not filing in a timely manner, I am asking for pardon and clemency. You can check my credit report to verify from all this that has transpired, I am struggling to keep ahead but I am determined to get my family and business back on track. I am a law-abiding citizen but due to my family medical needs, I was the only one who was of a sound mind to try to keep everything going. I have filed all the reports to be up-to-current.
