**INDEPENDENT AUDITOR'S REPORT**

**Scope and Nature of the ERISA Section 103(a)(3)(C) Audit**

I have performed audits of the financial statements of the Bethlen Home 403(b) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2023 (in liquidation) and 2022 (on-going), and the related statement of changes in net assets available for benefits for the year ended December 31, 2023 (in liquidation), and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Bethlen Home 403(b) Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), my audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2023 and 2022, and for the year ended December 31, 2023, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

**Opinion**

In my opinion, based on my audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section—

- the amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- the information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

**Basis for Opinion**

I conducted my audits in accordance with auditing standards generally accepted in the United States of America (GAAS). My responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of my report. I am required to be independent of the Bethlen Home 403(b) Plan and to meet my other ethical responsibilities in accordance with the relevant ethical requirements relating to my audits. I believe that the audit evidence I have obtained is sufficient and appropriate to provide a basis for my ERISA Section 103(a)(3)(C) audit opinion.

### **Emphasis of Matter – Plan Termination and Liquidation Basis of Accounting**

As further discussed in Note 7 to the financial statements, the board of directors of Bethlen Home of the Hungarian Reformed Federation of America, the Bethlen Home 403(b) Plan Sponsor, entered into a membership agreement (Agreement) with Concordia Care Network (Concordia), a Pennsylvania nonprofit corporation. As part of the Agreement the Plan will be terminated as of October 31, 2023. As a result, Bethlen Home 403(b) Plan changed its basis of accounting from the going-concern basis of accounting used in presenting the 2022 financial statements to the liquidation basis of accounting used in presenting the 2023 financial statements. My opinion is not modified with respect to this matter.

### **Responsibilities of Management for the Financial Statements**

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

Management is also responsible for maintaining a current plan instrument, including all plan amendments; administering the plan; and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

### **Auditor's Responsibilities for the Audit of the Financial Statements**

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of my report, my objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes my opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

In performing an audit in accordance with GAAS, I:

- Exercise professional judgment and maintain professional skepticism throughout the audit.
- Identify and assess the risks of material misstatement of the financial statements, whether due to fraud or error, and design and perform audit procedures responsive to those risks. Such procedures include examining, on a test basis, evidence regarding the amounts and disclosures in the financial statements.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

I am required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control related matters that I identified during the audit.

### NOTES TO FINANCIAL STATEMENTS

#### 1. DESCRIPTION OF PLAN

The following is a brief description of the Bethlen Home 403(b)(7) Plan (Plan) and provides only general information. Participants should refer to the Plan document or the Summary Plan Description for a complete description of the Plan's provisions.

##### General

The Plan is a defined contribution 403(b)(7) plan established for the benefit of the employees of Bethlen Home of the Hungarian Reformed Federation of America (Organization), the Plan Sponsor. The Plan is intended to satisfy all of the requirements for a qualified retirement plan under the appropriate provisions of the Internal Revenue Code (IRC) and similar state tax laws. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

##### Eligibility

Employees are eligible to participate in the Plan and receive employer contributions immediately upon being hired by the Organization.

##### Contributions

Eligible employees may contribute pre-tax annual compensation as defined in the Plan up to the maximum amount allowed by the Internal Revenue Code. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. The Organization may make a discretionary matching contribution. For the years ended December 31, 2023 and 2022, the Organization matched 100% of employee deferrals up to 3% of an employee's compensation. Participants may roll over amounts representing distributions from other qualified defined benefit or defined contribution plans. Contributions are subject to certain limitations.

##### Participant Accounts

Each participant account is (a) credited with the participant's contributions, (b) credited with the Organization's contributions, (c) credited (reduced) with an allocation of investment income (loss) and appreciation (depreciation) in the fair value of investments, (d) reduced by the participant's withdrawals, and (e) reduced by administrative expenses. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. Allocations to individual participant accounts are based upon share values at specified valuation dates.

##### Vesting

Participants are immediately vested in their contributions, rollover contributions, and Organization matching contributions as defined by the Plan document plus actual earnings thereon.

##### Payment of Benefits

Upon termination of service due to death, disability, retirement, or other reason, a participant may elect to receive a lump-sum distribution or installments of his or her vested account balance. The Plan Sponsor may initiate a mandatory distribution for those terminated participants whose vested account balance is \$1,000 or less. Hardship withdrawals are also permitted in the Plan.

##### Investment Options

Participants are allowed to invest in a variety of investment choices as more fully described in the Plan's literature. Participants may change their allocation on a daily basis.

1. DESCRIPTION OF PLAN – (Continued)

Forfeiture / Expense Account

The Plan has a forfeiture account included in the Lincoln Stable Value Account and holds old canceled checks. This account is to be used to offset future employer contributions. As of December 31, 2023 and 2022, the forfeiture account totaled \$-0- and \$2,013, respectively. In addition, for 2023 \$5,927 was used to reduce employer contributions. The Plan also has an expense account included in the Lincoln Stable Value Account. This expense account is to be used for Plan expenses. As of December 31, 2023 and 2022, the expense account totaled \$-0- and \$58,219, respectively. In addition, for 2023 \$60,325 was used to pay Plan expenses.

2. SIGNIFICANT ACCOUNTING POLICIES

The accounting policies followed by the Plan and the method of applying those policies which materially affect the determination of net assets available for benefits and changes in net assets available for benefits are as follows:

Basis of Accounting

The financial statements of the Plan are prepared under the accrual method of accounting for 2022 and the liquidation basis of accounting for 2023, in accordance with accounting principles generally accepted in the United States of America.

Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets available for Plan benefits and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments are stated at fair value (except for the fully benefit-responsive investment contract, which is reported at contract value (Note 5)). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants as of the measurement date. See Note 4 for discussion of fair value measurements. Purchases and sales of investments are recorded on a trade-date basis. Dividend income from registered investment accounts is recorded on the ex-dividend date. Interest income is recorded on the accrual basis. Net appreciation (depreciation) includes the Plan's gains and (losses) on investments bought and sold as well as held during the year.

Payments of Benefits

Benefits are recorded when paid.

Administrative Expenses

The Plan's administrative expenses, except for withdrawal fees, are paid by the Plan Sponsor.

3. INFORMATION CERTIFIED BY LINCOLN

The following is a summary of the investment information as of December 31, 2023 and 2022, and for the year ended December 31, 2023, included throughout the Plan's financial statements and supplemental schedule, that was prepared by or derived from information provided by the Trustee and furnished to the Plan Administrator. The Plan Administrator has obtained certifications from the Trustee that the information provided to the Plan Administrator by the Trustee related to the following investments is complete and accurate to the best of their knowledge. Accordingly, as permitted by 29 CFR 2520.103-8 of the DOL's Rules and Regulations for Reporting and Disclosure under the ERISA, the Plan Administrator instructed the Plan's independent auditor not to perform any auditing procedures with respect to information which appears throughout the financial statements and supplemental schedule related to the following investments as of December 31:

The Trustee also certified to the completeness and accuracy of \$16,604 of net gains and \$55,961 of dividends related to the aforementioned investments, and \$8,957 of interest on general account for the year ended December 31, 2023.

4. INVESTMENTS AND FAIR VALUE MEASUREMENTS

Authoritative guidance regarding *Fair Value Measurements* establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level I measurements) and the lowest priority to unobservable inputs (Level III measurements). The three levels of the fair value hierarchy under the authoritative guidance are described below:

Level I            Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the plan has the ability to access.

Level II            Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level II input must be observable for substantially the full term of the asset or liability.

Level III            Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

4. INVESTMENTS AND FAIR VALUE MEASUREMENTS – (Continued)

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following are descriptions of the valuation methodologies used for assets measured at fair value. The methodologies changed from the on-going basis at December 31, 2022 to the liquidation basis for December 31, 2023:

**Registered investment accounts:** Valued at the closing price reported in the active market in which the individual funds are traded.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement as of the reporting date.

#### 5. FULLY BENEFIT-RESPONSIVE INVESTMENT CONTRACT

The Plan has a traditional investment contract with The Lincoln National Life Insurance Company d/b/a Lincoln Financial Group. The Lincoln Stable Value Account meets the fully benefit-responsive investment criteria and is, therefore, reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. The issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan. The contract value as of December 31, 2023 and 2022, amounted to \$-0- and \$546,130, respectively.

The crediting interest rate is based on the earnings of the underlying assets in the entire medium-long term new portfolio compared to the minimum interest crediting rate, as stated in the contract, and prevailing market conditions. The minimum guaranteed interest crediting rate is reset quarterly. Withdrawals are permitted at any time without penalty. The guaranteed investment contract does not permit the insurance company to terminate the agreement prior to the scheduled maturity date.

Certain events limit the ability of the Plan to transact at contract value with the contract issuer. Such events include the following: (i) amendments to the Plan documents (including complete or partial Plan termination or merger with another plan); (ii) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions; (iii) bankruptcy of the Plan Sponsor or other Plan Sponsor events (e.g., divestitures or spin-offs of a subsidiary) which cause a significant withdrawal from the Plan; or (iv) the failure of the Plan to qualify for exemption from federal income taxes or any required prohibited transaction exemption under the ERISA. The Plan Administrator does not believe that the occurrence of any such events, which would limit the Plan's ability to transact at contract value with participants, is probable.

#### 6. RELATED PARTY TRANSACTIONS

A certain Plan investment is a general account managed by Lincoln. Lincoln is the Trustee, as defined by the Plan and, therefore, these transactions qualify as party-in-interest transactions. Fees paid by the Plan for administrative services and/or investment management services amounted to \$17,135 for the year ended December 31, 2023. Certain administrative functions are performed by officers or employees of the Organization. No such officers or employees receive compensation from the Plan. Certain other administrative expenses are paid directly by the Organization for which it is not reimbursed.

#### 7. PLAN TERMINATION

Effective March 31, 2023 Bethlen Home of the Hungarian Reformed Federation of America (Organization), the Plan Sponsor, entered into a membership agreement (Agreement) with Concordia Care Network (Concordia), a Pennsylvania nonprofit corporation. Under the terms of the Agreement, Concordia assumed all assets, liabilities, and ongoing operations, and became the sole member of the Organization. Additionally, under the terms of the Agreement, Concordia terminated the Plan as of October 31, 2023 and moved current employee participants to a new Plan and participants who are no longer employed by the Plan Sponsor had their funds distributed to them.

8. TAX STATUS

The Plan terms have been written and designed to comply with the final regulations under Internal Revenue Code Section 403(b)(7). The Plan is required to operate in conformity with the IRC to maintain the exclusion from tax for Plan participants. Plan management believes the Plan is currently designed and operated in compliance with the applicable requirements of the IRC.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the plan and recognize a tax liability (or asset) if the plan has taken an uncertain position that more likely than not would not be sustained upon examination by the appropriate taxing authority. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

9. RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities and the level of uncertainty related to changes in the value of investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported on the statements of net assets available for benefits.

10. SUBSEQUENT EVENTS

In preparing these financial statements, the Plan evaluated events that occurred through October 28, 2024, the date the financial statements were available to be issued, for potential recognition or disclosure.
