Plan Termination and Liquidation Basis of Accounting

As discussed in Note 1 to the financial statements, the governing body of the Plan approved to terminate the Plan, and all assets of the Plan were distributed on November 14, 2023. As a result of the Plan's termination, the Plan's financial statements have been prepared on the liquidation basis. Our opinion is not modified with respect to this matter.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for one year after the date that the financial statements are available to be issued.

Management is also responsible for maintaining a current Plan instrument, including all Plan amendments, administering the Plan, and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditors' Responsibilities for the Audit of the Financial Statements

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditors' report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

In performing an audit in accordance with GAAS, we:

- Exercise professional judgment and maintain professional skepticism throughout the audit.
- Identify and assess the risks of material misstatement of the financial statements, whether due to fraud or error, and design and perform audit procedures responsive to those risks. Such procedures include examining, on a test basis, evidence regarding the amounts and disclosures in the financial statements.
- Obtain an understanding of internal control relevant to the audit in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of the Plan's internal control. Accordingly, no such opinion is expressed.
- Evaluate the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluate the overall presentation of the financial statements.
- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for a reasonable period of time.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

NOTE 1 – PLAN DESCRIPTION

The following description of The InfiLaw System 401(k) Plan (the Plan) is provided for general information purposes only. More complete information regarding the Plan's provisions may be found in the Plan document.

General

The Plan was a defined contribution plan which was established on January 1, 1997 and most recently restated on February 24, 2021. The Plan was sponsored by InfiLaw Corporation (the Company). Substantially all employees of the Company, who had completed three months of service were eligible to participate in the Plan. Most employees could enter the Plan immediately following the date on which service requirements were satisfied. The Plan was subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Plan Termination

In November 2022, the governing body of the Plan determined that the Plan would be terminated. The final liquidation of Plan assets took place on November 14, 2023, with all existing participant balances transferred into individual trust accounts at that time.

Administration

The Plan was administered by the Company. Among other duties, it was the responsibility of the administrator to interpret the Plan, decide on questions of eligibility, determine the amount and manner of benefit payments and maintain administrative records of the Plan. The Plan's custodian for all assets as of December 31, 2022 and for the period from January 1, 2023 through November 14, 2023 was Fidelity Management Trust Company (Fidelity).

Trustee

The trustee of the Plan was Fidelity. The primary duties of the trustee were to authorize investments and monitor payment of contributions and benefits as directed by the Plan administrator.

Participant Accounts

Each participant's account was credited with the participant's contribution and the Company's contribution, when applicable, as well as an allocation of Plan earnings. Participant accounts were charged with an allocation of administrative expenses. Allocations were based on participant account earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant was entitled was the benefit that can be provided from the participant's vested account.

Notes Receivable from Participants

Participants could borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50 percent of their vested account balance. Such borrowings were secured by the balance in the participant's account and bore interest at a rate commensurate with local prevailing rates at the time of borrowing, as determined by the Plan administrator. Principal and interest were paid ratably through semi-monthly payroll deductions.

Contributions

Participants – Prior to the termination of the Plan, the Plan permitted each participant, at the participant’s option, to elect to contribute up to 100 percent of pre-tax compensation as a basic contribution to the Plan, not to exceed the Internal Revenue Service (IRS) limitations. For the period from January 1, 2023 through November 14, 2023, the maximum pretax salary deferral was limited to \$22,500. Participants who had attained age 50 before the end of the plan year were eligible to make catch-up contributions. Participants were also permitted to make Roth contributions to the Plan, not to exceed IRS limitations, and contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollovers). Participants directed the investment of their contributions into various investment options offered by the Plan. During the period from January 1, 2023 through November 14, 2023, the Plan offered various mutual funds and an interest-bearing cash account as investment options for participants. Participants were fully vested immediately in their contributions plus actual earnings thereon.

Employer – The Company could make discretionary employer matching contributions. During the period from January 1, 2023 through November 14, 2023, there were no discretionary employer contributions made by the Company. Total contributions for each participant were subject to certain IRS limitations. All contributions made by the Company were fully-vested immediately.

Payment of Benefits

Participants could receive distributions from their accounts upon attainment of age 59½, retirement as a result of disability, incurrence of a financial hardship (as defined), termination of their employment with the Company, death, or termination of the Plan. The participant could elect to receive either a lump-sum amount equal to the vested value of the participant’s account balance, or installments over a period not to exceed the participant’s assumed life expectancy.

Forfeitures

Forfeitures arise when a participant terminated employment before becoming entitled to 100 percent of the amounts derived from the employer’s contributions. The Plan provided for 100 percent vesting at all times and therefore no forfeitures arose under the Plan.

NOTE 2 – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Presentation

Accounting records of the Plan were historically maintained on the accrual basis of accounting. As a result of the Plan’s termination discussed in Note 1, the accompanying financial statements have been prepared on the liquidation basis.

Investment contracts held by a defined-contribution plan are required to be reported at fair value. However, contract value is the relevant measurement attribute for that portion of the net assets available for benefits of a defined-contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants would receive if they were to initiate permitted transactions under the terms of the Plan. The Plan did not have any fully benefit-responsive investments.

Investment Valuation and Income Recognition

The Plan's investments were stated at fair value, as determined by Fidelity. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date.

Purchases and sales of securities were recorded on a trade-date basis. Interest income was recorded on the accrual basis. Dividends were recorded on the ex-dividend date. Net change in fair value includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Note Receivable from Participant

The Plan's sole note receivable from a participant was measured at its unpaid principal balance as of December 31, 2022, and there was no allowance for credit loss recorded against it. If a participant ceased to make loan repayments and the Plan administrator deemed the participant loan to be in default, the participant loan balance was reduced and a benefit payment was recorded.

Administrative Expenses

Plan investments were subject to certain investment fees based on a percentage of invested assets. Such fees are included within the net change in fair value of underlying investments in the accompanying statement of changes in net assets in liquidation. The Plan also paid fees to Fidelity for recordkeeping services and to other third parties for advisory and audit services; such fees were allocated to participant accounts on a pro-rata basis and are included within administrative expenses on the accompanying statements of changes in net assets in liquidation.

Estimates

The preparation of financial statements requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Subsequent Events

Plan management has evaluated subsequent events through the date of the auditors' report, June 7, 2024, which is the date the accompanying financial statements were available to be issued.

NOTE 3 – FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs. The three levels of the fair value hierarchy under the Financial Accounting Standards Board's *Accounting Standards Codification (ASC) 820* are described as follows:

- a) Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the plan has the ability to access.

b) Level 2 Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

c) Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

Following is a description of the valuation methodologies used for investments measured at fair value at December 31, 2022.

Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-ended mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Interest-bearing cash: Interest-bearing bank account valued at the daily cash balance.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The following table sets forth by level, within the fair value hierarchy, the Plan's investments at fair value as of December 31, 2022. Classification within the fair value hierarchy table is based on the lowest level of any input that is significant to the fair value measurement:

NOTE 4 – CERTIFIED INVESTMENTS

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements, including investments and notes receivable from participants held at December 31, 2022, net decrease in fair value of investments, dividends, and interest income from investments for the period from January 1, 2023 through November 14, 2023, was obtained by management and agreed to or derived from information certified as complete and accurate by Fidelity.

NOTE 5 – PARTY-IN-INTEREST TRANSACTIONS

Participant loans qualified as party-in-interest transactions. In addition, certain Plan investments were managed by Fidelity and were subject to transactions which also qualified as party-in-interest transactions.

During the period from January 1, 2023 through November 14, 2023, the Plan paid fees of \$6 to Fidelity for services. Such fees are included within administrative expenses on the accompanying statement of changes in net assets in liquidation.

NOTE 6 – TAX STATUS

The IRS had determined and informed the Company by a letter dated November 5, 2018, that the Plan and related trust were designed in accordance with the applicable sections of the Internal Revenue Code (IRC). Although the Plan had been restated since receiving the letter, the Plan administrator believed that the Plan was designed and being operated in compliance with the applicable requirements of the IRC that the Plan was qualified and the related trust was tax-exempt at all times prior to its termination.

NOTE 7 – RISKS AND UNCERTAINTIES

The Plan invested in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it was at least reasonably possible that changes in the values of investment securities would occur in the near term and that such changes could have materially affect participants' account balances and the amounts reported in the statements of net assets in liquidation.
