INDEPENDENT AUDITORS' REPORT

To the Plan Administrator

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

Auditors' Responsibilities for the Audit of the Financial Statements

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditors' report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

In performing an audit in accordance with GAAS, we:

- Exercise professional judgment and maintain professional skepticism throughout the audit.

Our audit did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of GAAP.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with GAAP.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings and certain internal control-related matters that we identified during the audit.

1. DESCRIPTION OF THE PLAN

The following description of Electric Supply 401(k) Retirement Savings Plan (the Plan) provides only general information. Participants should refer to the Adoption Agreement and Plan documents for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan covering all employees of Electric Supply (the Sponsor or Company). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). To be eligible to participate in the Plan, an employee must be full-time, have attained the age of 21, and have completed 90 days of service.

Effective July 5, 2024, the Plan was merged into the Sonepar USA 401(k) Plan. The Plan merger is reflected as a Plan transfer for the period January 1, 2024 to July 5, 2024.

The following provisions of the Plan are reflective prior to the Plan merger.

Administration

The Company is the Plan Sponsor and Plan administrator. As the Plan administrator, the Company controls and manages the operation and administration of the Plan, except with respect to investments, which are managed by the designated custodian, John Hancock Trust Company, LLC (John Hancock), and recordkeeping, which is performed by John Hancock Retirement Plan Services.

Contributions

The Plan allows for participants to contribute from 1% to 30% of pre-tax annual compensation, as defined in the Plan, subject to annual limitations as defined by the Internal Revenue Code (IRC). Effective October 1, 2023, the Plan added a Roth feature to the Plan. Participants may also contribute amounts representing distributions from other qualified plans.

The Plan document allows participants of the Plan to be automatically enrolled, once meeting eligibility requirements, at a deferral percentage of 3% of eligible compensation. Plan entry is allowed on the first day of the Plan quarter coinciding with or following the date requirements are met.

The Company may make matching contributions equal to a discretionary percentage of the participant's elective deferrals. A participant shall share in the allocations of the matching contributions whether or not the participant is actively employed at the end of the Plan year and regardless of hours of service. For the year ended December 31, 2023, the Company elected to match 50% of participants' deferrals up to 3% of the participants' eligible compensation.

Investment Options

The Plan permits participants to direct the investment of their elective deferrals and Company contributions into various investments offered by the Plan.

Participant Accounts

Each participant's account is credited with the participant's contributions and the Company's matching contribution, as well as allocations of any profit-sharing contribution and Plan earnings (losses). Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings (losses), account balances or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are immediately vested in their contributions plus actual investment income thereon. Safe harbor contributions allocated under the Frontier Lighting, Inc. 401(k) Plan are 100% vested. Effective October 1, 2023, participants are fully vested in Company contributions and earnings thereon. For participants who terminated prior to October 1, 2023, and were not rehired on or after October 1, 2023, the following vesting schedule applies to Employer matching contributions: 0-1 year - 0%, 2 years - 20%, 3 years - 40%, 4 years - 60%, 5 years - 80%, 6 years - 100%.

Investment Options

The Plan permits participants to direct the investment of their elective deferrals and Company contributions into various investments offered by the Plan.

Notes Receivable to Participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The loans are secured by the balance in the participant's account and bear interest at market rates at the time of the loan. Loan terms range from one to five years unless the loan is for the purchase of a primary residence. Principal and interest are paid through payroll deductions.

Payment of Benefits

The Plan provides for the payment of benefits upon retirement, total and permanent disability, termination of employment and financial hardship by way of a lump-sum distribution, substantially equal installments, or an annuity equal to the value of the participant's vested interest in his or her account. Benefits are recorded when paid.

Forfeitures

Any nonvested amounts remaining after the distribution of a terminated participant's vested account balance are forfeited. Forfeitures are applied to future employer contributions or administrative expenses. Forfeitures in the amount of \$0 and \$27,876 at July 5, 2024 and December 31, 2023, respectively, were available to offset future employer matching contributions or administrative expenses. No balances were used to offset administrative expenses or employer match contributions during the period January 1, 2024 to July 5, 2024.

Hardship Distribution

The Plan allows participants to withdraw a portion of their elective deferral account, rollover contributions, and the vested portion of the Company's contribution account in the event of immediate and heavy financial need. Any hardship withdrawal is limited to the amount needed to meet the financial need and must qualify with respect to Plan provisions.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The financial statements of the Plan are prepared under the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (GAAP).

Use of Estimates

The preparation of financial statements in conformity with GAAP requires the Plan's management to make estimates and assumptions that affect the reported amounts of net assets available for benefits and changes therein. Actual results could differ from those estimates.

Notes Receivable from Participants

Loans to participants are reported at their unpaid principal balances plus any accrued but unpaid interest.

Investment Valuation and Income Recognition

Investments are stated at fair value.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is accrued when earned. Dividend income is recorded on the ex-dividend date. The net appreciation in fair value of investments includes both realized gains and losses on investments sold during the year and unrealized gains and losses on investments held at the end of the year.

Risks and Uncertainties

The Plan provides for various investment options in any combination of investment securities. Investment securities are exposed to various risks, such as interest rate, market and credit. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and amounts reported in the statements of net assets available for benefits.

Administrative Expenses

Significant administrative costs related to the Plan are incurred by the Company and are not reflected in the operations of the Plan. The fees related to recordkeeping and investment advisory services are paid by the Plan and reflected as administrative expenses within the statement of changes in net assets available for benefits for the period January 1, 2024 to July 5, 2024.

3. CUSTODIAN CERTIFICATION OF PLAN INVESTMENTS

Certain information related to investments from participants disclosed in the accompanying financial statements and the ERISA-required supplemental schedule, including investments held as of July 5, 2024 and December 31, 2023, and net appreciation in fair value of investments and interest and dividend income for the period January 1, 2024 to July 5, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by John Hancock, the custodian of the Plan.

4. TAX STATUS

The Plan has adopted a prototype plan under John Hancock Retirement Plan Services. The prototype plan obtained its latest opinion letter on June 30, 2020, in which the Internal Revenue Service (IRS) stated that the prototype plan, as then designed, was in compliance with the applicable requirements of the IRC. The prototype plan has been amended since receiving the opinion letter. However, the Plan administrator and the Plan management believe that the prototype plan is currently designed and being operated in compliance with the applicable requirements of the IRC. Therefore, no provision for income taxes has been included in the Plan's financial statements.

GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

5. PLAN TERMINATION

Although it has not expressed any intention to do so, the Company has the right under the Plan to discontinue its contributions at any time and to discontinue the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

6. FAIR VALUE MEASUREMENTS

Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) Topic 820, *Fair Value Measurement*, establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under ASC Topic 820 are described below:

- Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
- Level 2 – Inputs to the valuation methodology include: Quoted prices for similar assets or liabilities in active markets; Quoted prices for identical or similar assets or liabilities in inactive markets; Inputs other than quoted prices that are observable for the asset or liability; Inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability. The following is a description of the valuation methodology used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2023.
- Level 3 – Inputs to the valuation methodology are unobservable and significant to fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to fair value measurement. Valuation techniques used need to maximize use of observable inputs and minimize use of unobservable inputs.

Following is a description of valuation methodologies used for assets measured at fair value:

Registered Investment Companies: Valued at net asset value (NAV) based on quoted market prices of shares held by the Plan at year-end.

Common Collective Trust Fund: Valued at the NAV as practical expedient as determined by the collective trust custodian as of the valuation date. There are no unfunded commitments or redemption restrictions related to the fund.

John Hancock is the Custodian as defined by the Plan, and therefore, transactions between the Plan and John Hancock qualify as party-in-interest transactions. These Plan expenses are included within the statement of changes in net assets for the period January 1, 2024 to July 5, 2024. Participant loans are considered party-in-interest transactions, as defined in Section 3(14) of ERISA, because they are transacted with Plan participants. These transactions qualify as party-in-interest transactions, as defined in Section 3(14) of ERISA; they are, however, expressly exempted from the prohibited transaction rules.
