I received a Notice CP-403 from you recently bringing to my attention that we failed to file a Form 5500SF for the plan year ending December 31, 2022.


I am writing to ask that this letter be considered for Reasonable Cause under Section 301.6724-1 (b)(2). I am also requesting that you waive any potential penalty related to the late filing. If you review our filing history, you will see the company has never been charged penalties or been found out of compliance with regards to the filing of the Form 5500.

The above referenced plan terminated prior to plan year end December 31, 2022. All assets were paid 100% and transferred to an MEP or about 05/10/2021. Prior to that, we relied on the services of our TPA to prepare the Form 5500 for our Plan each year, but we terminated their services mid-year when we terminated the Plan. As soon as I received your Notice that the 5500 had not been filed, I requested our former TPA to help with preparing the Form 5500 for immediate filing.

We hope that you will find this situation to satisfy Reasonable Cause based on the above referenced section of Title 26 of the Federal Register. We also certify that the above statements are true and accurate under the Penalty of Perjury.
