Note A – Description of the Plan

The following description of the Plan provides only general information. Interested persons should refer to the Plan agreement or the Summary Plan Description for a more complete description of the Plan's provisions.

General

The Plan was established on January 1, 1991. The Plan has been amended since inception to comply with tax law changes and to make other changes in the Plan's design.

Employees (other than excluded employees) are eligible to participate in the Plan after completing three months of service and attaining age 18. Employees are automatically enrolled once becoming eligible.

The Plan provides assistance toward meeting an eligible employee's retirement needs by: 1) allowing Orthopaedic and Neurological Rehabilitation, Inc., Orthopaedic and Neurological Rehabilitation of Texas, Inc., and ONR National, Speech Pathology, Inc., (collectively, the "Company") to make discretionary contributions; and 2) allowing eligible employees to defer a portion of their compensation. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA) and subsequent laws.

During September 2022, the Company entered into an acquisition agreement with EmpowerMe Wellness LLC. On March 31, 2023, the Plan transferred all assets to EmpowerMe Wellness LLC Retirement Savings Plan and terminated the Orthopedic and Neurological Rehabilitation, Inc. Profit Sharing Plan.

Non-Elective Discretionary and Employer Matching Contributions

Non-elective discretionary Company contributions, as determined by the Board of Directors on a year-to-year basis, are accrued in the Plan financial statements once declared by the Board of Directors. As of the period ending March 31, 2023 and for the year ending December 31, 2022, the Company has made no non-elective discretionary contributions to the Plan.

Non-elective discretionary contributions vest over six years (20% after two years in the Plan, 40% after three years, 60% after four years, 80% after five years, and 100% after six years). Full and immediate vesting occurs upon termination of the Plan, retirement, death, or total and permanent disability. Unvested non-elective discretionary account balances for participants who terminate employment are forfeited. At March 31, 2023 and December 31, 2022, forfeited non-vested matching accounts totaled \$0 and \$105,006, respectively. These accounts will be used to reduce future employer contributions or pay plan administrative expenses. The forfeiture balance was transferred to the new plan, with the plan termination.

Participants direct the allocation of the employer matching contribution segment of the Plan assets. Distributions of vested balances are made upon employee termination or retirement by a participant. In the case of a participant's death, distribution is made to the designated beneficiary.

Employee Deferral Contributions

Employee deferral contributions to the Plan are intended to qualify under Section 401(k) and related provisions of the Internal Revenue Code. Participants may also make deferral contributions to a Roth account under Section 401(b) and related provisions of the Internal Revenue Code.

Note A – Description of the Plan (Continued)

Employee Deferral Contributions (continued)

Eligible participants may elect to contribute up to the statutory limits of their compensation to the Plan through payroll deductions. The Plan permits participants to make certain tax-free transfers (rollovers) of lump sum distributions received from other tax-qualified plans subject to code regulations. Eligible employee contributions are fully vested when contributed.

Participant Accounts

Each participant's account is credited with the participant's contributions, Company contributions, Plan earnings or losses, and rollovers from other qualified plans in accordance with the participants' directives and the terms of the Plan. Plan earnings or losses are allocated based upon each participant's account balance. Certain fees are charged to the fund investments and are offset against Plan investment income and loss as presented on the statement of changes in net assets available for benefits. Participants should refer to the prospectuses of these funds for details on the various types and amounts of investment fees charged to the Plan and their individual accounts.

Payment of Benefits

Upon a participant's termination of employment, attainment of the normal retirement age, death, or disability, the participant (or the participant's beneficiary in the event of death) may elect to receive a lump sum distribution equal to the value of his or her account, partial payments, or direct trustee to trustee rollovers. If the participant's account balance is less than \$5,000, a lump sum distribution will be made without regard to the consent of the participant or the participant's spouse. In-service distributions may be made to a participant who has attained age 59-1/2. All distributions elected by terminated participants during the Plan year have been paid by the Plan at March 31, 2023 and December 31, 2022.

Notes Receivable from Participants

Participants may borrow against their vested balances for any reason. The loan provisions are structured to allow access to vested balances without incurring distribution penalties. The loan amount, length of loan, repayment terms, and interest rates are limited by statutory restrictions incorporated in the Internal Revenue Code and related regulations.

The Plan allows participants to borrow not less than \$1,000 and up to the lesser of \$50,000 or 50% their vested account balance. The loans are secured by the participant's vested balance. Such loans bear interest at the available market financing rates and must be repaid to the Plan within a five year period, unless the loan is used for the purchase of a principal residence in which case the maximum repayment period may be repaid over 15 years. The specific terms and conditions of such loans are established by the Plan Administrator. Outstanding loans through March 31, 2023, carried interest ranging from 4.25% – 8.75%.

Plan Administration

The Company has delegated certain responsibilities for the operation and administration of the Plan to Fidelity Management Trust Company, as the Plan Trustee, through March 31, 2023. Certain administrative and recordkeeping services were provided by Fidelity Workplace Services, LLC (Fidelity). For the period ending March 31, 2023 and the year ending December 31, 2022, a portion of the Plan's loans were held at Corebridge Financial (formerly AIG Retirement Services). The Plan participants absorb some costs of the Plan administration, including recordkeeping and investment fees.

Investment Management Fees and Operating Expenses

The Company pays the cost of administering the Plan such as recordkeeping, accounting, legal and trustee services. Investment fees are generally assessed as a percentage of assets invested, and are deducted directly from investment returns.

Administrative Expenses

Most administrative expenses of the Plan are paid by the Company. Separate transaction-based fees are associated with optional services offered by the Plan, and are charged to individual participant's accounts.

Note B – Summary of Significant Accounting Policies

Basis of Accounting and Accounting Period

The accounting records of the Orthopaedic and Neurological Rehabilitation, Inc. Profit Sharing Plan (the Plan) are maintained on the accrual basis in accordance with accounting principles generally accepted in the United States of America ("U.S. GAAP"). The Plan has adopted a calendar year.

Valuation of Investments and Income Recognition

Investments consist of mutual funds which are stated at aggregate fair value, as measured by quoted prices in an active market. Shares of registered investment companies are valued at quoted market prices, which represent the net asset value of shares held by the Plan at year end. See Note H for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade date basis. Interest income is recorded on the accrual basis. Net appreciation/(depreciation) includes the Plan's gains and losses on investments bought or sold as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Defaulted participant loans are reclassified as distributions based upon the terms of the plan document.

Use of Estimates

The preparation of financial statements in conformity with generally accepted accounting principles requires management to make estimates and assumptions that affect the amounts reported in the financial statements and notes to financial statements. Actual results could differ from those estimates.

Fair Value Measurements

The Plan performs fair value measurements in accordance with Financial Accounting Standards Board (“FASB”) Accounting Standards Codification (“ASC”) 820, Fair Value Measurements and Disclosures. Refer to Note H for the fair value measurement disclosures associated with the Plan’s investments.

Note C – Income Tax Status

The Company has adopted a prototype non-standardized Profit Sharing Plan with a cash or deferral arrangement which received its latest determination letter from the Internal Revenue Service on June 30, 2020, which stated that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code (IRC). The Company believes that the Plan is currently designed and is being operated in compliance with the applicable requirements of the IRC. Therefore, no provision for income taxes has been included in the Plan’s financial statements.

The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan administrator believes the Plan is no longer subject to income tax examinations for years prior to 2020.

Note D – Plan Termination

The Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA.

Effective March 31, 2023, the Orthopaedic and Neurological Rehabilitation, Inc. Profit Sharing Plan was merged into the EmpowerMe Wellness Retirement Savings Plan. The full value of each participant’s account shall, to the extent funded, be 100% vested on the date of such plan termination.

All assets were transferred to the EmpowerMe Wellness Retirement Savings Plan with the exception of the loan collaterals held with the custodian, Corebridge Financials. These loans were previously defaulted in 2012 and 2013, and have been formally written off instead of transferred to the new plan.

Note F – Related Party and Party-In-Interest Transactions

Certain administrative functions are performed by officers or employees of the Company, Fidelity, and Corebridge Financial. No such officer, employee, or trustee receives compensation from the Plan.

Certain Plan investments in mutual funds are managed by Fidelity Management Trust Company, the plan administrator. Any purchases and sales of these funds are performed in the open market at fair value. Such transactions, while considered party-in-interest transactions under ERISA regulations, are permitted under the provisions of the Plan, and are specifically exempt from the prohibition of party-in-interest transactions under ERISA.

Note G – Fair Value Measurements

Accounting Standards Codification (ASC) 820

Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) 820, *Fair Value Measurements and Disclosures*, provides a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described below:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at March 31, 2023 and December 31, 2022.

Mutual funds: Valued at the net asset value (“NAV”) of shares held by the Plan at year end.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.


