Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of 403(b) Thrift Plan of Hospice of Central Pennsylvania (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C). The financial statements comprise the statements of net assets available for plan benefits as of February 29, 2024 (in liquidation), and December 31, 2023 and 2022 (ongoing), and the related statement of changes in net assets available for benefits for the period of January 1, 2024 through February 29, 2024 (in liquidation), and for the year ended December 31, 2023 (ongoing), and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA (ERISA Section 103(a)(3)(C) audit). As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held were prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from qualified institutions as February 29, 2024, and for the period of January 1, 2024 through February 29, 2024, and for the year ended December 31, 2023, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit Financial Statements section:

- The amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, were presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP).

Opinion (Continued)

- The information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards were further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We were required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Emphasis of Matter - Plan Termination and Liquidation Basis of Accounting

As discussed in Note 6 to the financial statements, the Board of Directors of Hospice of Central Pennsylvania, the Plan's sponsor, voted on December 22, 2023, to terminate the Plan, and management determined liquidation is imminent. As a result, the Plan has changed its basis of accounting from the going concern basis of accounting used in presenting the 2023 financial statements to the liquidation basis of accounting used in presenting the 2024 financial statements. Our opinion is not modified with respect to this matter.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with U.S. GAAP, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that were free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there were conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern within one year after the date that the financial statements were issued or available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the Plan, and determining that the Plan's transactions that were presented and disclosed in the financial statements were in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditor's Responsibilities for the Audit of the Financial Statements

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit of the Financial Statements section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements were considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

In performing an audit in accordance with GAAS, we:

- Exercise professional judgment and maintain professional skepticism throughout the audit.
- Identify and assess the risks of material misstatement of the financial statements, whether due to fraud or error, and design and perform audit procedures responsive to those risks. Such procedures include examining, on a test basis, evidence regarding the amounts and disclosures in the financial statements.
- Obtain an understanding of internal control relevant to the audit in order to design audit procedures that were appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of the Plan's internal control. Accordingly, no such opinion is expressed.
- Evaluate the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluate the overall presentation of the financial statements.
- Conclude whether, in our judgment, there were conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for a reasonable period of time.

Our audits did not extend to the certified investment information, except for obtaining and reading the certifications, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they were in accordance with the presentation and disclosure requirements of U.S. GAAP.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole were presented fairly, in all material respects, in accordance with U.S. GAAP.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control related matters that we identified during the audit.

NOTES TO FINANCIAL STATEMENTS

Note 1. Plan Description

The following description of the 403(b) Thrift Plan of Hospice of Central Pennsylvania (the Plan) provides only general information. Participants should refer to the plan document for a more complete description of the Plan's provisions.

General: The Plan was a defined contribution plan, established by Hospice of Central Pennsylvania (the Organization), and was subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (ERISA).

Plan Termination: Effective December 31, 2023, the Plan was amended to terminate the Plan as soon as reasonably possible and cease all contributions. All participants became 100% vested in their entire accounts including all Company contributions and earnings, thereon. Plan management has completed the standard requirements prescribed by ERISA and liquidated all assets as of February 29, 2024, by converting all participant account balances to fully paid-up individual insurance annuity contracts. Under the individual contracts, participants retain all the payout options they had under the Group Annuity Contract, including any right to withdraw or rollover their account balance. Effective February 29, 2024, all participant balances were converted to individual annuity contracts.

Eligibility: All permissible employees of the Organization were eligible to enroll on their date of hire. Participants aged 21 or older were eligible to receive discretionary employer matching contributions when they have completed 1,000 hours of service during the 12-month period following their date of hire. Participants were eligible to receive employer base contributions, whether or not they were making salary contributions, provided they have completed 1,000 hours of service during that plan year and were employed on the last day of the plan year.

Contributions: Participants could contribute up to 100% of pretax annual compensation as defined by the plan document, up to the maximum annual limitations imposed by the Internal Revenue Code (IRC). All employees hired on or after January 1, 2016, were automatically enrolled in salary contributions at a rate of 1% beginning 30 days following their date of hire. Employees were provided 90 days to opt out of participation in the Plan. Participants age 50 or over could have elected to defer additional catch-up amounts. Participants who completed 15 years of service were allowed to make additional contributions in accordance with the plan document, subject to certain limitations. Participants could also contribute amounts representing distributions from other qualified plans (rollovers).

Note 1. Plan Description (Continued)

Contributions (Continued): The Organization could make discretionary matching and/or discretionary base contributions. For 2023, the Organization made matching contributions equal to 50% of the first 3%, 4% or 6% of the employee's annual salary reduction contributions as follows:

<u>Years of Service</u>	<u>Plan Contributions as a Percentage of Salary Reduction Contributions</u>	<u>Percentage of Compensation</u>
1 completed year of service but less than 3 years	50%	3%
3 completed years of service but less than 5 years	50%	4%
5 completed years of service or more	50%	6%

The Organization's contributions for any participant were subject to certain IRC limitations.

Participant Investment Options: Participants directed the investment of contributions into various investment options offered by the Plan. Participants could change their investment allocation at any time.

Participant Accounts: Each participant's account was credited with the participant's contributions, employer contributions, and an allocation of Plan earnings, net of administrative expenses. The Plan's earnings and administrative expenses were allocated according to the participant's relative account balance or specific participant transactions, as defined in the plan document. The benefit to which a participant was entitled was the benefit that can be provided from the participant's vested account balance.

Vesting: Participants were immediately vested in all Plan contributions and the investment income on those contributions.

Plan Loans: Participants could borrow from their fund accounts a minimum of \$1,000, up to a maximum equal to the lesser of \$50,000 or 50% of their account balance. Loans were available to participants through Mutual of America Life Insurance Company (MOA), subject to certain limitations. Plan loans were issued directly from funds owned by MOA and loan proceeds were not removed from a participant's account balance. However, a portion of a participant's MOA account balance was reserved, or held in collateral, to cover the outstanding loan amount for the period of time the loan was outstanding. For active loans, investments equal to 100% of the loan amount were reflected in the statements of net assets available for plan benefits and served as collateral for the loan. Investments underlying defaulted loan balances, if any, were reflected in the statements of net assets available for plan benefits until a distributable event occurred.

Note 1. Plan Description (Continued)

Plan Loans (Continued): Loan terms ranged from 1 to 5 years; however, terms could have exceeded 5 years for the purchase of a primary residence. The loans bore interest at prime plus one percent, which was commensurate with local prevailing rates as determined by the Plan administrator. Principal and interest payments were made ratably by participants directly to Mutual of America Life Insurance Company. If payments were not received within 30 days after each due date, loans were considered to be in default and were reported as a deemed distribution from the participant's account. The 30-day grace period could have been extended for up to a calendar quarter following the quarter in which payment was due in specific causes which were generally beyond the participant's control.

At December 31, 2023 and 2022, participants had outstanding loan balances of \$38,470 and \$54,457 due to Mutual of America Life Insurance Company (MOA). These amounts were reported within participant accounts and were held in reserve in the interest accumulation account of MOA on the Statements of Net Assets Available for Plan Benefits.

Payment of Benefits: Upon termination of service, death, disability or retirement, a participant was eligible to receive a distribution of their vested account balance. A participant or beneficiary could have elected to receive distribution of their account in a lump sum or partial payments. In-service distributions were available to participants after reaching the age of 59-1/2. Participant account balances of less than \$1,000 were involuntarily paid out in the form of a lump sum distribution upon termination. In addition, the Plan provided for hardship withdrawals if certain criteria were met.

Administrative Expenses: The Plan's administrative expenses were substantially paid by the Plan Sponsor, except for transaction fees which were charged directly to the account of the participant receiving the benefit.

Note 2. Summary of Significant Accounting Policies

Accounting Method: The accompanying 2024 financial statements were prepared on the liquidation basis of accounting. The 2023 and 2022 financial statements have been prepared on the accrual basis of accounting.

Use of Estimates: The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of net assets available for benefits and changes therein. Actual results could differ from those estimates.

Investment Valuation and Income Recognition: The Plan's investments were reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements.

Investment Valuation and Income Recognition (Continued): Purchases and sales of securities were recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends were recorded on the ex-dividend date. Net appreciation or depreciation in the fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Payment of Benefits: Benefits were recorded when paid.

Subsequent Events: In preparing these financial statements, the Plan Sponsor evaluated events and transactions for potential recognition or disclosure through October 21, 2024, the date the financial statements were available to be issued.

Note 3. Information Certified by the Custodian

Certain information related to investments disclosed in the accompanying financial statements and ERISA required supplemental schedule, including investments held at February 29, 2024, December 31, 2023 and 2022, Net appreciation in fair value of investments and interest income for the period of January 1, 2024 through February 29, 2024 and the year ended December 31, 2023, was obtained by management and agreed to information certified as complete and accurate by Mutual of America Life Insurance Company, Custodian of the Plan.

Note 4. Investments and Fair Value Measurements

The Plan measures on a recurring basis its investments at fair value in accordance with Financial Accounting Standards Board (FASB) codification *Fair Value Measurement*, which provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The three levels of the fair value hierarchy were as follows:

- Level 1 Inputs to the valuation methodology were unadjusted quoted prices for identical assets in active markets that were accessible to the Plan. These generally provide the most reliable evidence and were used to measure fair value whenever available.

- Level 2 Inputs to the valuation methodology include significant inputs, other than Level 1 inputs, that were observable either directly or indirectly for substantially the full term of the asset through corroboration with observable market data. Level 2 inputs include quoted prices for similar assets in active markets, quoted market prices in markets that were not active for identical or similar assets, and other observable inputs.

Note 4. Investments and Fair Value Measurements (Continued)

Level 3 Inputs to the valuation methodology were unobservable and significant to the fair value measurement.

The asset's fair value measurement level within the fair value hierarchy was based on the lowest level of any input that was significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs. The inputs or methodology used for valuing investments were not an indication of the risk associated with investing in those securities. The following is a description of valuation methodologies used for assets at fair value. There have been no changes in the methodologies used at December 31, 2023 and 2022.

Pooled separate accounts: Units of participation in pooled separate accounts were reported at the accumulated value of units held by the Plan at year-end as reported to the Plan by Mutual of America Life Insurance Company (MOA). The accumulated unit value was determined daily by MOA and was based on the net asset value of the underlying mutual fund and the contract's separate account charges. Although the fair values of the underlying fund shares were derived based on observable market data, the accumulated unit value was not a publicly quoted price in an active market but was computed in accordance with investment company measurement principles.

The preceding methods may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods were appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine fair value of certain investments or financial instruments could result in a different fair value measurement at the reporting date.

Note 5. Related Party and Party-in-Interest Transactions

Certain Plan investments consisted of units of pooled separate accounts and funds in an interest accumulation account within an insurance company general account managed by Mutual of America Life Insurance Company, the Custodian of the plan, and therefore, these transactions qualified as party-in-interest transactions. Fees incurred by the plan for the investment management services were included in net appreciation (depreciation) in fair value of the investment, as they were paid through revenue sharing, rather than a direct payment.

The Custodian issued loans to participants which were secured by participants' account balances and were contractual agreements between the Custodian and the plan participants (see 'Plan Loans' in Note 1). These transactions qualify as party-in-interest transactions.

Note 6. Tax Status

The Plan was designed to qualify under Section 403(b) of the Internal Revenue Code (IRC). Plan management believes the plan was designed and operating in accordance with the applicable requirements of the IRC. The Plan was considered qualified and the related group annuity contract was tax exempt. Therefore, no provision for income taxes has been included in the Plan's financial statements.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan Administrator has analyzed the tax positions taken by the Plan, and has concluded that as of February 29, 2024, December 31, 2023 and 2022, there were no uncertain positions taken or expected to be taken that would require recognition or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there were currently no audits for any tax periods in progress.

Note 7. Risks and Uncertainties

The Plan invested in various investment securities. Investment securities were exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities could occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the Statements of Net Assets Available for Plan Benefits.
