INDEPENDENT AUDITOR'S REPORT

To the Administrative Committee of

Opinion

We have audited the financial statements of UPS Crewmembers Benefit Package for Retired Employees (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA) which comprise the statement of net assets available for benefits (modified cash basis) as of December 31, 2023, and the related statement of changes in net assets available for benefits (modified cash basis) for the year then ended, and the related notes to the financial statements (modified cash basis) (the "financial statements").

NOTES TO FINANCIAL STATEMENTS (MODIFIED CASH BASIS)

AS OF DECEMBER 31, 2023 AND 2022, AND FOR THE YEAR ENDED DECEMBER 31, 2023

1. DESCRIPTION OF THE PLAN

General — The United Parcel Service Health and Welfare Plan Trust for Collectively Bargained Employees (“VEBA” or “Master Trust”) was established on December 30, 1992 and has been amended periodically. The VEBA is the funding vehicle for the UPS National LTD Plan, the UPS Health and Welfare Plan, the UPS Health Care Package, the UPS Health and Welfare Package, the UPS Health and Welfare Package for Retired Employees, the UPS Crewmembers Benefit Package, the UPS Crewmembers Benefit Package for Retired Employees (the “Plan”), the UPS Health and Welfare Package Select, the UPS National Health Plan for Part Time Employees, the UPS Health and Welfare Package Select—Hawaii and the UPS Health Program Plan (collectively, the “Plans”).

The following description of the Plan is provided for general information purposes only. Participants should refer to the plan document for a more complete description of the Plan’s provisions. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

The Plan’s Administrative Committee controls and manages the operation and administration of the Plan. Plan assets are held in the Master Trust for which the Bank of New York Mellon (“Mellon Trust”) serves as the trustee (“Trustee”).

Contributions — The VEBA receives and invests contributions from both United Parcel Service, Inc. (the “Plan Sponsor,” “employer” or “UPS”) and participants of the Plan. In addition to deductibles and copayments, participants contribute specified amounts based on applicable premiums for their respective benefit elections. The amount to be contributed by participants is determined annually based on several factors.

The majority of employer contributions to the Master Trust are allocated to each plan based upon the level of service provider payments (benefit payments, premiums (if any) plus administrative expenses, net of employee contributions) made on behalf of the applicable plan as compared to total service provider payments of the VEBA, net of employee contributions.

The Plan Sponsor makes contributions to the Plan as needed to fund claims in excess of participants’ contributions. Any deficiency of the Plan’s net assets over benefit obligations is expected to be funded by the Plan Sponsor on a pay-as-you-go basis.

Benefits — The Plan provides health and welfare benefits (including health, dental, and vision) to certain groups of retired collective bargaining unit employees of UPS and their dependents. Participants should refer to the summary plan description for a more complete description of the Plan’s benefits.

Health Reimbursement Arrangement — The Plan has a health reimbursement arrangement (HRA) that is funded solely through employer contributions. The HRA allows eligible participants to be reimbursed tax free for qualified medical expenses subject to a specified ceiling. The employer is not permitted to refund any part of the balance to the participant; the account cannot be used for anything other than reimbursements for qualified medical expenses; and remaining amounts are not portable once the participant leaves the Plan.

Termination — Although it has not expressed any intention to do so, UPS has the right under the Plan, subject to collective bargaining agreements, to modify the benefits provided to active employees, discontinue its contributions at any time, and terminate the Plan subject to the provisions set forth in ERISA. In the event the Plan terminates, UPS will contribute the necessary amounts to fund all applicable expenses incurred prior to the date of the termination.

2. SUMMARY OF ACCOUNTING POLICIES

Basis of Accounting — The Plan prepares its financial statements on the modified cash basis of accounting, which is a comprehensive basis of accounting other than accounting principles generally accepted in the United States of America (GAAP). Contributions are generally recorded when received and expenses are generally recorded when paid. Benefit obligations are not recorded in the statements of net assets available for benefits, however they are disclosed on an accrual basis in Note 5.

Use of Estimates — The preparation of financial statements in conformity with the modified cash basis of accounting requires Plan management to make estimates and assumptions that affect the reported amounts of assets, liabilities, disclosure of benefit obligations and changes therein, claims payable, claims incurred but not reported, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition — The Plan's and Master Trust's investments are stated at fair value. Fair value of a financial instrument is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date.

Purchases and sales of securities are recorded on a trade-date basis. Interest income and dividends are recorded when received. Investment Income allocated from the Master Trust includes the Plan's proportionate share in the Master Trust's gains and losses in investments bought and sold as well as held at year-end.

Claims Incurred but Not Reported — As reported in Note 5, the Plan's liability for participant health claims incurred but unreported at year-end is estimated using actuarial methods that use historical trend information developed through studies of medical claim lag patterns incurred in the prior years.

Claims Paid — Claims are recorded as paid when paid by the claims administrator.

Postretirement Benefit Obligation — The postretirement benefit obligation disclosed in Note 5 represents the actuarial present value of those estimated future benefits that are attributed by the terms of the Plan to an employee's service rendered to the date of the financial statements and reduced by the actuarial present value of contributions expected to be received in the future from current retired participants. Postretirement benefits include future benefits expected to be paid to or for (1) currently retired employees and their beneficiaries and dependents and (2) active employees and their beneficiaries and dependents after retirement from service with the Plan Sponsor. Prior to an active employee's full eligibility date, the postretirement benefit obligation is the portion of the expected postretirement benefit obligation that is attached to that employee's service rendered to the valuation date. The postretirement benefit obligation represents the amount that is to be funded by contributions from the Plan Sponsor and from existing Plan assets.

The actuarial present value of the expected postretirement benefit obligation is determined by an actuary and is the amount that results from applying actuarial assumptions to the historical claims cost data to estimate future annual incurred claims costs per participant and to adjust such estimates for

the time value of money (through discounts for interest) and the probability of payment (by means of decrements, such as those for death, disability, withdrawal, or retirement) between the valuation date and the expected date of payment and to reflect those costs expected to be borne by Medicare, retired participants, and other providers.

On December 8, 2003, the Medicare Prescription Drug, Improvement, and Modernization Act of 2003 (the "Act") was signed into law. The Act introduced a prescription drug benefit under Medicare ("Medicare Part D"), as well as a federal subsidy to sponsors of retiree health care benefit plans that provide a benefit that is at least actuarially equivalent to Medicare Part D. The Plan and its actuarial advisers determined that benefits provided to certain participants are expected to be at least actuarially equivalent to Medicare Part D and, accordingly, the Plan Sponsor expects to be entitled to a federal subsidy under the Act. The Plan's postretirement benefit obligation as of December 31, 2023 and 2022, and the changes in the postretirement benefit obligation for the year ended December 31, 2023, do not reflect any amount associated with the Medicare Part D subsidy because the Plan is not directly entitled to the subsidy.

For the December 31, 2023 valuation, the annual rate of increase in health care costs was assumed to be 7.25% in 2024 and grading down by 0.25% in years 2025 through 2035 and remaining at 4.5% thereafter.

For the December 31, 2022 valuation, a 7.50% annual rate of increase in the per capita cost of covered health care benefits was assumed; the rate was assumed to decrease gradually to 4.5% for 2035 and to remain at that level thereafter.

The health care cost-trend assumption has a significant effect on the amounts reported. If the assumed rates for 2023 and 2022 increased by one percentage point for each future year, the obligation as of December 31, 2023 and 2022, would increase by approximately \$120,000 and \$115,000, respectively.

The foregoing assumptions are based on the presumption that the Plan will continue. If the Plan were to terminate, different actuarial assumptions and other factors might be applicable in determining the actuarial present value of the postretirement benefit obligation.

Administrative Expenses — Administrative expenses of the Plan are paid by the Plan, as provided in the Plan document.

Refunds — Refunds due from the Plan’s pharmacy benefits manager are recorded upon the receipt of cash as a credit to claims disbursements to providers. Pharmacy rebates totaling \$651,827 have been netted with claims disbursements to providers in the accompanying statement of changes in net assets available for benefits for the year ended December 31, 2023.

Risks and Uncertainties — The Plan (through the Master Trust) utilizes money market fund investment securities. Investment securities, in general, are exposed to various risks, such as interest rate risk, credit risk, and overall market volatility. Market risks include global events, such as a pandemic or international conflict, which could impact the value of investment securities. Due to the level of risk associated with investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the amounts reported in the financial statements.

The actuarial present value of postretirement benefit obligations is reported based on certain assumptions pertaining to interest rates, inflation rates, and employee demographics, all of which are subject to change. Due to uncertainties inherent in the estimations and assumptions process, it is at least reasonably possible that changes in these estimates and assumptions in the near term would be material to the financial statements.

Subsequent Events — Management has evaluated subsequent events for the Plan through October 15, 2024, the date the financial statements were available to be issued. There are no subsequent events that require adjustment to or disclosure in the financial statements.

3. MASTER TRUST

The Master Trust investments are stated at fair value as determined and reported by the Trustee in accordance with the Master Trust Agreement established by the Company. The value of the assets held by the Master Trust is determined based on the fair value of the underlying assets. Use of the Master Trust permits commingling of the Plan’s assets with the assets of the other Plans in the Master Trust.

The Plan’s interest in the Master Trust represents 4.36% and 2.66% of the Master Trust’s net assets at December 31, 2023 and 2022, respectively.

The value of the Plan’s interest in the Master Trust is based on the beginning of year value of the Plan’s interest in the trust plus actual participant contributions, allocated employer contributions, allocated investment income, less actual claims netted against refunds, less premiums paid and administrative expenses, as applicable.

The investment income of the Master Trust, excluding earnings related to restricted assets, during 2023 is \$159,649, which consisted of interest income.

Investment income is allocated annually from the Master Trust to each plan based upon the investment income for the year compared to each plan’s relative expenses.

The assets of the UPS National LTD Plan, while residing within the Master Trust, are held in a separate account and are not permitted to be commingled with other plans within the Master Trust. The Plan Sponsor maintains supporting records for purposes of allocating assets, liabilities, income, and expenses based upon the relative benefit reimbursements of each plan.

Financial Accounting Standards Board Accounting Standards Codification (ASC) 820, *Fair Value Measurements and Disclosures*, establishes a single authoritative definition of fair value, sets a framework for measuring fair value, and requires additional disclosures about fair value measurements. In accordance with ASC 820, the Plan classifies its investments into Level 1, which refers to securities valued using quoted prices from active markets for identical assets; Level 2, which refers to securities not traded on an active market, but for which observable market inputs are readily available; and Level 3, which refers to securities valued based on significant unobservable inputs. Assets and liabilities are classified in their entirety based on the lowest level of input that is significant to the fair value measurement.

As of December 31, 2023 and 2022, the fair value of the Master Trust investment in the money market mutual fund is determined by obtaining quoted prices on nationally recognized securities exchanges (Level 1 inputs within the fair value hierarchy).

4. FEDERAL INCOME TAX STATUS

The Master Trust established under the Plan to hold the Plan's assets is intended to qualify as a VEBA trust under Section 501(c)(9) of the Internal Revenue Code (IRC), and accordingly, the Master Trust's net investment income is exempt from income taxes. The Master Trust has obtained an exemption letter dated May 26, 1993, from the Internal Revenue Service, and the Plan Sponsor believes the Master Trust, as amended, continues to qualify and to operate in accordance with the applicable provisions of the IRC. Therefore, no provision for income taxes has been included in the Plan's financial statements.

GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the applicable authorities. The plan administrator has analyzed the tax positions taken by the Plan and concluded that as of December 31, 2023 and 2022 there are no uncertain tax positions expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements.

The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan Sponsor believes the Plan is no longer subject to income tax examinations for years prior to 2020.

The Plan Sponsor provides certain accounting and other exempt administrative services for the Master Trust but receives no reimbursement from the Master Trust or Plan for these services. These transactions are exempt party-in-interest transactions under ERISA.



