Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Zapproved LLC 401(k) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of January 4, 2024 and December 31, 2023 and the related statements of changes in net assets available for benefits for the period from January 1, 2024 through January 4, 2024 and the year ended December 31, 2023, and the related notes to the financial statements.

NOTES TO FINANCIAL STATEMENTS
JANUARY 4, 2024 AND DECEMBER 31, 2023**

1. Description of Plan

The following description of the Zapproved LLC 401(k) Plan (the “Plan”) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan’s provisions.

a. General

The Plan is a defined contribution savings and profit sharing plan established January 1, 2015 by Zapproved LLC (the “Company”) under the provisions of Section 401(a) of the Internal Revenue Code (“IRC”), which includes a qualified cash or deferred arrangement as described in Section 401(k) of the IRC, for the benefit of eligible employees of the Company. The Plan is administered by the Company. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”), as amended.

b. Plan Termination Effective January 4, 2024

The Exterro, Inc. 401(k) Plan (“Exterro Plan”) was amended effective January 4, 2024, to merge the Plan into the Exterro Plan. As a result, the Plan was terminated effective January 4, 2024.

c. Eligibility

Employees are eligible to participate in the Plan except non-resident aliens, leased employees, union employees, interns, residents of Puerto Rico and temporary employees with less than 1,000 hours of scheduled service. Employees must be 18 years of age to participate in the Plan and enter the Plan on the first day of the month after meeting the age requirement. There are no service requirements to participate in the Plan.

d. Participant Contributions

Unless an eligible employee affirmatively elects otherwise, the employee is automatically enrolled in the Plan at a deferral rate of 5%. Employee deferrals for each active participant having automatic enrollment contributions made on their behalf shall be increased annually by 1%, never to exceed 10% unless the participant elects a different percentage. Participants that make their contribution election may defer up to 100% of their eligible compensation, limited by requirements of the IRC. Upon reaching the age of 50, eligible employees may make additional catch-up contributions as allowed by the IRC. Participants may also roll over amounts representing distributions from other qualified defined benefit or defined contribution plans into the Plan.

e. Employer Contributions

The Company makes safe harbor matching employer contributions equal to 100% of the employee’s elective deferral up to the first 3% plus 50% of the next 2% deferred. The Company may also make additional discretionary employer contributions to the Plan, subject to the limits of the IRC. No additional discretionary contributions were made during 2024 and 2023.

f. Participant Accounts

Individual accounts are maintained for each of the Plan's participants to reflect the participant's contributions, the Company's contributions, and an allocation of the Plan's earnings and expenses. Participants can direct their account into a variety of investments offered by Voya Retirement Insurance and Annuity Company ("Voya"). The benefit to which a participant is currently entitled is the benefit that can be provided from the participant's vested account.

g. Vesting

Participants are fully vested at all times in the portion of their accounts attributable to their own elected deferrals, rollover contributions, safe harbor matching contributions and earnings thereon. Participants vest in the portion of their accounts attributable to discretionary employer contributions and earnings thereon at a rate of 25% for each year of service. A participant is fully vested after four years of credited service or in the event a participant becomes disabled or dies.

h. Payment of Benefits

Upon reaching retirement age, termination of service or death, a participant or beneficiary may be paid a lump-sum amount equal to the participant's vested account balance. Account balances less than \$5,000 are distributed in a single lump-sum cash payment to the participant or beneficiary.

i. Hardship Withdrawals

Upon certain conditions, participants, while still employed by the Company, are permitted to withdraw, in a single sum, a portion of their vested account as a result of an immediate and heavy financial need. These conditions include unreimbursed medical expenses, the purchase of the participant's principal residence, the payment of post-secondary education tuition, the payment of burial or funeral costs of immediate family members, the payment of natural disaster clean-up on the participant's principal residence or to prevent eviction or foreclosure from the participant's principal residence.

j. Notes Receivable from Participants

Participants may borrow the lesser of \$50,000 or 50% of their vested account balance, subject to a \$1,000 minimum and certain other restrictions. Loans are secured by the vested account balance of the participant. Loans are repayable through payroll deductions over periods ranging up to five years, unless the loan is used to acquire a principal residence, in which case the loan term may be for a period of fifteen years. The interest rate on participant loans is set at the time the loan is made and is set consistent with similar type loans.

k. Forfeitures

The forfeited accounts of non-vested terminated participants may be used to pay administrative expenses of the Plan or to reduce future Company contributions. For the period from January 1, 2024 through January 4, 2024 and the year ended December 31, 2023, forfeitures utilized to reduce employer matching contributions were approximately \$0 and \$800, respectively. Forfeitures of \$0 and \$200 were available to reduce future Company contributions or to pay administrative expenses at January 4, 2024 and December 31, 2023, respectively.

2. Summary of Significant Accounting Policies

a. Basis of Accounting

The accompanying financial statements have been prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America ("GAAP").

b. Use of Estimates

The preparation of the financial statements in conformity with GAAP requires management of the Plan to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

c. Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for a discussion of fair value measurements.

Net appreciation (depreciation) in fair value of investments consists of the net change in unrealized gains or losses during the year and the realized gain or loss on investments sold during the year. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis and dividends are recorded on the ex-dividend date.

d. Notes Receivable from Participants

Notes receivable from participants are recorded at their unpaid principal balance plus any accrued but unpaid interest. Delinquent notes receivable from participants may be treated as a distribution based on the terms of the Plan document.

e. Payment of Benefits

Benefits are recorded when paid.

f. Expenses

Administrative costs, including custodial, recordkeeping, legal and accounting fees, are paid by the Company. Direct expenses totaling \$0 and \$9,700 were paid by the Plan during 2024 and 2023, respectively, representing transactional fees incurred and allocated to specific participants. Certain expenses are included in the transaction prices of investments bought and sold and cannot be separately quantified.

3. Investments

Plan investment assets are held by Voya. Participants can direct their accounts among various pooled separate accounts and an insurance contract.

The Plan's investment options include the Voya Fixed Account (the "Fixed Account"). The Fixed Account is a group annuity contract and is an obligation of Voya's general account. The Fixed Account is fully benefit-responsive and, accordingly, is carried at contract value.

The interest rate for new contributions is declared prior to the beginning of each year and is applicable to all contributions received in that year and is guaranteed at a rate of no less than 1%. Each calendar year, a one-year minimum guaranteed interest rate is set and will apply to all amounts held in the Fixed Account during the calendar year. Earnings from the Fixed Account are included in interest income on the accompanying statements of changes in net assets available for benefits. The Plan's failure to qualify under Section 401(a) of the IRC or the failure of the trust to be tax-exempt, premature termination of the contract, Plan termination or merger, or liquidation of the Company could result in the investment not transacting at contract value.

4. Fair Value Measurements

FASB Accounting Standards Codification ("ASC") 820 establishes a framework for fair value measurement, which provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under ASC 820 are described below:

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 – Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for investment assets measured at fair value. There have been no changes in the methodologies used at December 31, 2023.

Pooled separate accounts: valued at the NAV of the units held, based on the values provided to Voya. The unit prices are based on the quoted market prices of the underlying investments.

5. Risks and Uncertainties

The Plan assets are invested in a variety of investments. Investment securities, in general, are exposed to various risks, such as interest rate, credit, foreign currency and overall market volatility risks. Due to the level of risk associated with certain investment securities, it is reasonable possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the amounts reported in the statements of net assets available for benefits, and therefore participant account balances.

6. Information Certified by the Custodian

The Plan administrator has elected the method of annual reporting compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. The following information included in the financial statements and supplemental schedule was provided and certified by the custodian, Voya, as of January 4, 2024 and December 31, 2023 and for the period from January 1, 2024 through January 4, 2024 and the year ended December 31, 2023.

- Investments, at fair value
- Investment, at contract value
- Investment income (loss)
- Interest on notes receivable from participants

7. Party-in-interest Transactions

Certain Plan investment funds are managed by Voya Retirement Insurance and Annuity Company, the custodian as defined by the Plan and, therefore, these investments and investment transactions qualify as party-in-interest transactions. Certain investment fees are paid by the custodian and are reflected in the investment income or loss for the year. The Plan also issues loans to participants that are secured by the vested balance in the participants' accounts. As such, these transactions qualify as party-in-interest transactions, which are exempt from the prohibited transactions rules.

Additionally, the Plan sponsor, Zapproved LLC, is a party-in-interest to the Plan. The transactions between the Plan and the Plan sponsor included funding of contributions to the Plan and payment of certain administrative expenses of the Plan, which are exempt transactions.

8. Tax Status

Effective January 1, 2022, the Plan was restated utilizing the Angell Pension Group Inc. (“Angell Pension”) Non-Standardized Pre-Approved Profit Sharing Plan Document with CODA. Angell Pension received an opinion letter from the Internal Revenue Service (“IRS”) on June 30, 2020 in which the IRS stated that the Plan, as then designed, was in compliance with the applicable requirements of the IRC. The Plan has been amended since receiving the opinion letter. However, management of the Plan believes the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC. Management believes that the Plan is designed and continues to be operated in compliance with the requirements of the IRC and therefore was tax-exempt through the January 4, 2024 termination date.

Assuming it meets certain initial and ongoing requirements, the Plan is generally exempt from federal and state income taxes. However, GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan administrator has analyzed the tax positions taken by the Plan and has concluded that as of January 4, 2024 and December 31, 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements.

The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

9. Subsequent Events

The Plan has evaluated subsequent events with respect to the Plan through November 4, 2024, the date the financial statements were available for issuance.
