I am the former Plan Trustee and President of Envirocon Termite & Pest, Inc. The company was sold in 2022 and the plan referenced above was terminated during 2022. It has come to my attention that the final Form 5500 was never filed due to miscommunication between the 3rd-Party Plan Administrator, ADP, and myself, the Plan Trustee. Specifically, communications related to filing the final 5500 were sent to the old Envirocon e-mail addresses, which were discontinued upon the sale of the company in 2022. Thus, we never received notification of the need to initiate the filing process and assumed the final filing had been completed by the 3<sup>rd</sup>-party administrator.

We are requesting a waiver of any fees and penalties due to the above miscommunication so we can initiate the final Form 5500 filing process with the 3<sup>rd</sup>-party administrator.
