A. Description of plan:

The following description of the Champion Industries, Inc. (“Company”) 401(k) Plan (“Plan”) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

1. Contributions:

Each participant may elect to defer up to 15% of their compensation, subject to maximum annual deferrals, in accordance with the provisions of the Plan. The employer contributes an amount equal to 100% of the employee elective deferrals up to 2% of the employee’s compensation.

On February 1, 2010, the Plan was amended as such: the employer may make discretionary matching contributions in an amount equal to 100% of the employee elective deferrals up to 2% of the employee’s compensation.

2. Vesting:

Participants of the Plan become 100% vested in their elective deferrals, qualified non-elective deferrals, rollover contributions, transfer contributions, plus or minus any earnings or losses. A participant is 100% vested in employer contributions after five years of credited service as defined by the Plan.

3. Payment of benefits:

Payment of benefits to a participant whose service is terminated shall be deferred to what would have been the participant’s normal retirement date or may be paid at an earlier date in accordance with the Plan. Benefit payments may be in the form of lump-sum payments or annuities as elected by the participant in accordance with Plan provisions. However, non-vested benefits will be forfeited and distributed, on a pro-rata basis, to the other participants.

B. Summary of significant accounting policies:

1. Basis of accounting:

The financial statements of the Plan are prepared on the accrual basis of accounting.

Investment contracts held by a defined contribution plan are required to be reported at fair value. However, contract value is the relevant measurement attribute for that portion of net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants would receive if they were to initiate permitted transactions under the terms of the Plan.

B. Summary of significant accounting policies (Continued):

2. Investment valuation and income recognition:

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note D for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

3. Operating expenses:

All expenses of maintaining the Plan are paid by the Company. Investment related expenses are included in net appreciation in fair value of investments.

4. Use of estimates:

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America ("GAAP") requires the Plan administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosures of contingent assets and liabilities. Accordingly, actual results may differ from those estimates.

5. Payment of benefits:

Benefits are recorded when paid.

D. Fair value measurements:

The Plan's investments are reported at fair value in the accompanying Statements of Net Assets Available for Benefits. The methods used to measure fair value may produce an amount that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to measure the fair value of certain financial instruments could result in a different fair value at the reporting date.

The fair value measurement accounting literature establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority, Level 2 inputs consist of observable inputs other than quoted prices for identical assets, and Level 3 inputs are unobservable and have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. Level 3 inputs are used only when Level 1 or Level 2 inputs are not available.

*Level 1 Fair Value Measurements*

The fair value of mutual funds is based on quoted net asset values of the shares held by the Plan at year-end.

*Level 2 Fair Value Measurements*

No Level 2 inputs were held by the Plan as of December 31, 2023 and 2022.

*Level 3 Fair Value Measurements*

No Level 3 inputs were held by the Plan as of December 31, 2023 and 2022.

E. Fully benefit-responsive investment contracts:

The Plan has entered into benefit-responsive guaranteed investment contracts with Principal. Principal maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The guaranteed investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan.

Because the guaranteed investment contracts are fully benefit-responsive, contract value is the relevant measurement attribute for that portion of the net assets available for benefits attributable to the guaranteed investment contracts. The guaranteed investment contracts are presented on the face of the Statements of Net Assets Available for Benefits at contract value. Contract value, as reported to the Plan by Principal, represents contributions made under the contracts, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

There are no reserves against contract value for credit risk of the contract issuer or otherwise. The contract value of the investment contracts at December 31, 2023 and 2022 was \$1,802,722 and \$1,811,851, respectively. The crediting interest rate is based on a formula agreed upon with the issuer. Such interest rates are reviewed on a periodic basis for resetting.

Certain events limit the Plan's ability to transact at contract value with Principal. Such events include the following: (a) amendments to the Plan documents (including complete or partial plan termination or merger with another plan), (b) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (c) bankruptcy of the Plan sponsor or other Plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, or (d) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA. The Plan administrator does not believe that any events that would limit the Plan's ability to transact at contract value with plan participants are probable of occurring.

The guaranteed investment contracts do not permit the insurance company to terminate the agreement prior to the scheduled maturity date.

F. Plan termination:

Although it has not expressed any intent to do so, the Company has the right under the Plan to terminate the Plan in whole or in part at any time, subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their accounts.

G. Tax status:

The Internal Revenue Service (IRS) has ruled that the Plan qualifies under section 401(a) of the Internal Revenue Code (IRC) and is, therefore, not subject to tax under the present income tax laws. The Plan is required to operate in conformity with the IRC to maintain its qualification and the Company is not aware of any course of action or series of events that have occurred that might adversely affect the Plan's qualified status.

Accounting principles generally accepted in the United States of America require the Plan administrator to evaluate tax positions taken by the Plan and recognize a tax liability for any uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan administrator has concluded that as of December 31, 2023, there are no uncertain tax positions taken or expected to be taken that would require recognition of a liability or disclosure in the financial statements. The Plan administrator believes the Plan is no longer subject to income tax examinations for years prior to 2020.

H. Risks and uncertainties:

The Plan provides for participant directed investment options in any combination of investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the Statements of Net Assets Available for Benefits.

I. Party-in-interest and related party transactions:

The Company provides for certain professional services, including legal, accounting, and auditing services, on behalf of the Plan at no cost to the Plan.

Certain Plan investments are managed by Principal. Principal is the trustee as defined by the Plan and, therefore, these transactions qualify as party-in-interest transactions. Fees paid by the Plan amounted to \$1,117 for the year ended December 31, 2023.

All of these party-in-interest transactions are exempt from the prohibited transaction rules of ERISA.

J. Subsequent events:

The Plan has evaluated subsequent events through October 31, 2024, which is the date the financial statements were available to be issued.
