Please find enclosed the IRS Form 5500 for the plan noted above in connection with the plan year ended January 31, 2024. Please consider the following explanation as to the reason that this form is being submitted past the normal due date of August 31, 2024.

This plan was effective February, 12 2008. All prior IRS submissions, including prior Form 5500s, have been filed in a timely manner. Due to our firm being acquired, our recordkeeper's Compliance department was notified that we were merging into a new Plan; however, they were unaware that the merger had concluded, necessitating the filing of a final Form 5500. Due to this unintentional administrative oversight, IRS Form 5558 (Application for Extension of Time to File) was not submitted prior to August 31, 2024, for the 2024 submission.

We are aware of the mandatory due dates for the 5500 series submissions. Procedures are in place to prevent a recurrence of this event. I would, therefore, request that you waive the penalty for late filing in this instance.
