### Report on the Audit of the Financial Statements

#### **Scope and Nature of the ERISA Section 103(a)(3)(C) Audit**

We have performed audits of the accompanying financial statements of Meggitt-USA, Inc. 401(k) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of January 1, 2024, December 31, 2023 and December 31, 2022, and the related statements of changes in net assets available for benefits for the period and years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Meggitt-USA, Inc. 401(k) Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. #### **Opinion**

- the information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

***Basis for Opinion***

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the *Auditors' Responsibilities for the Audit of the Financial Statements* section of our report. We are required to be independent of Meggitt-USA, Inc. 401(k) Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audits. ***Responsibilities of Management for the Financial Statements***

**NOTE 1 DESCRIPTION OF PLAN**

The following description of Meggitt-USA, Inc. 401(k) Plan (the Plan) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

**General**

The Plan is a defined contribution plan originally effective July 1, 1988. The Plan has been amended throughout the years to comply with tax legislation and most recently amended effective December 15, 2021. The Plan excludes leased employees and nonresident aliens. The Plan is subject to the Employee Retirement Income Security Act of 1974 (ERISA). Employees of Meggitt-USA, Inc. (the Plan Sponsor) and the following companies (collectively, the Company) participate in the Plan:

Effective September 13, 2022, Parker-Hannifin Corporation completed the acquisition of Meggitt PLC, the parent company of the Plan Sponsor. As permitted by the Plan document, the Board of Directors of Meggitt-USA, Inc. 401(k) made the decision to merge the Meggitt-USA, Inc. 401(k) Plan into the Parker Retirement Savings Plan effective January 1, 2024. Effective at the end of day on December 31, 2023, the Plan was closed and frozen and the accounts of all plan participants were 100% vested and nonforfeitable. Transfers Payable as of January 1, 2024, totaled \$802,371,323 and was transferred on January 8, 2024.

**Eligibility**

Employees of the Company are eligible to participate in the deferral component of the Plan on their first day of employment. To be eligible to receive the Company's safe-harbor basic contribution or Company match, a participant must render one hour of service during the Plan year. Participants are eligible for the discretionary supplemental contribution if they meet the eligibility requirements above and are employed on the last day of the Plan year. In connection with the merger of the Plan into the Parker Retirement Savings Plan, participation in the Plan was frozen effective December 31, 2023.

**Contributions**

The Plan includes a salary deferral arrangement allowed under Section 401(k) of the Internal Revenue Code (IRC). Eligible participants are permitted to elect to have up to 60% of their eligible compensation contributed as pre-tax 401(k) contributions or an after-tax Roth contribution to the Plan, as defined in the Plan, or a statutory maximum as determined by the IRC. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. The Plan includes an auto-enrollment provision whereby all newly eligible participants are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their deferral rate set at 6% of eligible compensation, and their contributions invested in the designated default fund until changed by the participant. The Plan has an optional automatic increase feature where participants' deferral percentage will increase by 1% until the chosen max is reached.

The Company makes matching contributions up to 50% of each participant's contributions, not to exceed 3% of the participant's eligible compensation each pay period. In addition, the Company makes an annual safe-harbor contribution equal to 3% of the participant's eligible compensation. The participant does not have to make contributions to the Plan to receive the safe-harbor contribution. The Company may also make an annual discretionary supplemental contribution equal to 2% of the participant's eligible compensation. The employee does not have to contribute to the Plan to receive this contribution. The Plan has a true up matching contribution that participants receive the maximum annual matching contributions available under the Plan, even if their contribution rate fluctuates throughout the year as long as employee's deferral percentage averages 6% for the full year.

Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover). Participants direct the investment of contributions into various investment options offered by the Plan. Contributions are subject to certain Internal Revenue Service (IRS) limitations.

**Participant Accounts**

Each participant's account is credited with the participant's contributions, the Company's matching contribution, the Company's safe-harbor basic contributions, an allocation of the Company's supplemental contributions, and an allocation of Plan earnings or losses. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings or account balances, or participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided by the participant's vested account.

**Notes Receivable from Participants**

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. A loan shall be evidenced by a written promissory note bearing the prime rate of interest as published in *The Wall Street Journal* plus 1%; provided; however, that at no time shall a loan be made to any individual if the rate of interest would exceed the maximum rate allowable under applicable law. The maturity dates for loans taken for the purchase of a principal residence shall not exceed 15 years, while the maturity date for all other loans shall not exceed five years. The notes are secured by the balance in the participant's account and bear interest at a rate commensurate with local prevailing rates as determined quarterly by the Plan administrator. Principal and interest is paid ratably through payroll deductions or paid online through the trustee's website. Loan initiation fees of \$50 per loan are paid from participant's accounts.

**Vesting**

Participants are immediately vested in their contributions, Company matching and safe-harbor contributions, plus actual earnings thereon. Vesting in the supplemental contribution portion of their accounts, plus actual earnings thereon, is based on years of credited service. A participant is vested 20% each year until after five years of credited service which at that time becomes fully vested subject to Plan rules. Notwithstanding the above, a participant is fully vested upon reaching normal retirement age, death, or permanent disability. In connection with the merger of the Plan into the Parker Retirement Savings Plan, participants became 100% vested in all Company contributions effective December 31, 2023.

**Benefit Payments**

Upon termination of service due to death, disability, or retirement, a participant may elect to receive the value of the vested interest in his or her account in the form of a lump sum distribution or installments. The Plan allows for in-service distributions if a participant reaches age 59½ and hardship distributions subject to Plan provisions. If a participant terminates employment and the participant's account balance does not exceed \$1,000, the Plan administrator will authorize the benefit payment without the participant's consent. If the balance of the terminated participant's account is between \$1,000 and \$5,000, the Plan Sponsor may authorize that the benefit payment be rolled into an individual retirement account in the participant's name.

**Forfeited Accounts**

Forfeited nonvested accounts may first be used to reduce Company contributions and then are used to reduce administrative expenses. Forfeited nonvested accounts as of January 1, 2024, December 31, 2023 and December 31, 2022 totaled \$743,870, \$743,870 and \$601,177, respectively. There were no forfeitures used to pay administrative expenses for one-day period ended January 1, 2024 and years ended December 31, 2023 and December 31, 2022. There were \$0, \$309,320 and \$149,479 of forfeitures used to reduce Company contributions for one-day period ended January 1, 2024 and years ended December 31, 2023 and December 31, 2022, respectively.

**NOTE 2 SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

**Basis of Accounting**

The financial statements of the Plan are prepared on the accrual basis of accounting.

**Use of Estimates**

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP) requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

**Investment Valuation and Income Recognition**

The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

**Notes Receivable from Participants**

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of one-day period ended January 1, 2024, and years ended December 31, 2023 or December 31, 2022. Delinquent notes receivable are recorded as distributions on the basis of the terms of the Plan document.

**Benefit Payments**

Benefits are recorded when paid.

**Administrative Expenses**

Administrative fees and redemption fees are paid from the Plan. The Company pays most other administrative expenses of the Plan. The Plan receives revenue-sharing amounts from T. Rowe Price Trust Company (T. Rowe Price) each year, which are held in an administrative budget account used to pay certain administrative expenses. The amount remaining, if any, after administrative expenses, is allocated to participants' accounts on a prorata basis.

**Subsequent Events**

The Plan has evaluated subsequent events through October 17, 2024, the date the financial statements were available to be issued.

**NOTE 3 CERTIFICATION OF INVESTMENT INFORMATION**

T. Rowe Price, the trustee of the Plan, has supplied the Plan administrator with a certification as to the completeness and accuracy of all investment information and notes receivable from participants reflected on the accompanying statements of net assets available for benefits as of January 1, 2024, December 31, 2023 and December 31, 2022, the statements of changes in net assets available for benefits for the period and years then ended, and the supplemental schedule of assets (held at end of year) as of December 31, 2023.

**NOTE 4 FAIR VALUE OF INVESTMENTS**

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy are described as follows:

*Level 1* – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

*Level 2* – Inputs other than quoted prices included within Level 1 that are observable for the asset or liability, either directly or indirectly, such as:

- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

*Level 3* – Inputs to the valuation methodology are unobservable and significant to the fair market value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the valuation methodologies used for one-day period ended January 1, 2024, and years ended December 31, 2023 and 2022.

*Mutual Funds* – Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

*Common/Collective Trust Funds* – Valued at the NAV of units of the common/collective trusts. NAV is a readily determinable fair value and is the basis for current transactions. Participant transactions (purchases and sales) may occur daily. If the Plan initiates a full redemption of the collective trust, the issuer reserves the right to temporarily delay withdrawal from the trust in order to ensure that securities liquidations will be carried out in an orderly business manner.

**NOTE 5 PLAN TERMINATION**

The Company has the right under the Plan to discontinue contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, the participants would become 100% vested in their Company contributions. As discussed in Note 1, effective on January 1, 2024 the Plan merged with the Parker Retirement Savings Plan and participants became 100% vested in all Company contributions.

**NOTE 6 PLAN TAX STATUS**

The Plan is placing reliance on a determination letter received from the IRS indicating that the Plan is qualified under the IRC and is therefore not subject to tax under current income tax law. The Plan has been amended since receiving the determination letter. However, the Plan administrator believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified, and the related trust is tax-exempt.

U.S. GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**NOTE 7 PARTY-IN-INTEREST TRANSACTIONS**

Certain Plan investments are shares of mutual funds managed by T. Rowe Price. T. Rowe Price is the trustee as defined by the Plan and, therefore, the investment transactions qualify as party-in-interest transactions. Fees incurred by the Plan for the investment management services are included in net appreciation (depreciation) in fair value of the investment.

T. Rowe Price receives revenue from mutual fund service providers for services T. Rowe Price provides to the funds. This revenue is used to offset certain amounts owed to T. Rowe Price for its administrative services to the Plan, pursuant to the Plan's recordkeeping agreement. If the revenue received by T. Rowe Price from such mutual fund service providers exceeds the cost of operating the Plan, T. Rowe Price remits the excess to the Plan's trust on a quarterly basis. Such amounts are held in an administrative budget account and may be applied to pay Plan administrative expenses or allocated to the accounts of the participants. Revenue-sharing amounts remitted to the trust for one-day period ended January 1, 2024, and the years ended December 31, 2023 and 2022 were \$0, \$760,625, and \$877,209, respectively and are included in net appreciation (depreciation). Allocations to participant accounts totaled \$2,599,894 during the year ended December 31, 2023. There were no allocations made for the one-day period ended January 1, 2024 or the year ended December 31, 2022.
