Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed an audit of the financial statements of Creative Direct Response, Inc. 401(k) Retirement Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of January 13, 2022 and December 31, 2021, and the related statement of changes in net assets available for benefits from the period of January 1, 2022 through January 13, 2022, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audit of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audit need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained a certification from a qualified institution as of January 13, 2022 and December 31, 2021 and for the period from January 1, 2022 through January 13, 2022, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audit and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section –

- the amounts and disclosures in the financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- the information in the financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audit in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audit. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of these financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Note 1: DESCRIPTION OF THE PLAN

The following description of Creative Direct Response, Inc. 401(k) Retirement Plan (the Plan) provides only general information. Participants should refer to the Plan Document and *Summary Plan Description* for a more complete description of the Plan's provisions, which are available from the Plan Administrator.

General

The Plan is a defined contribution plan sponsored by Creative Direct Response, Inc. (the "Employer") for the benefit of its employees. Employees who have reached the age of 18 are eligible to participate in the Plan upon completion of three months of service. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA").

The Plan's service provider for record-keeping and trustee services is Principal Life Insurance Company.

On January 13, 2022, the Plan was terminated and all assets transferred to the Moore 401k Retirement Savings Plan.

Contributions

Prior to plan termination, participants may make elective deferral contributions to the Plan up to 100% of their annual compensation, excluding commission pay, up to IRS maximum limits. Participants who are projected to be age 50 or older by the end of the calendar year may also make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans ("rollover" contributions).

The Employer may make matching or discretionary contributions each plan year. However, the Employer made no such additional matching or discretionary contributions to the Plan for the period from January 1, 2022 through January 13, 2022.

Participant Accounts

Investment account options available include various funds. Each participant has the option of directing his contributions into any of the available fund options and may change the allocation daily. Each participant's account is credited with the participant's contribution, the Employer's contribution, Plan earnings, and is charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefits to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting and Forfeitures

Participants are immediately vested in their voluntary contributions plus earnings thereon. Employer discretionary contributions are subject to a six-year vesting schedule. Each participant, or his beneficiary in the event of death, obtains fully vested rights to his share of matching or discretionary Employer contributions upon completing six vesting years of service or upon his retirement, death, or disability. Participants not fully vested receive vested rights to their share of Employer contributions as follows:

When a participant withdraws from the Plan prior to becoming fully vested, the participant forfeits their right to Employer contributions in excess of vested amounts. Forfeitures reduce Employer contributions or can be used to pay Plan expenses as they arise and amounted to \$3,875 for the period from January 1, 2022 through January 13, 2022.

Payment of Benefits

Upon termination of service, a participant may elect to receive a lump-sum amount equal to the value of his account, a rollover to an individual retirement account or other qualified plan, or a rollover to a new employer's plan.

A participant may also receive benefit payments upon reaching normal retirement age, as defined.

Note 2: SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES***Basis of Accounting***

The accompanying financial statements are prepared on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of net assets and changes in net assets and disclosure of contingent assets and liabilities at the date of the financial statements. Actual results could differ from those estimates.

Valuation of Investments and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Notes 4 and 5 for discussion of investment valuation.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net depreciation includes the Plan's gains and losses on investments bought and sold as well as held during the period.

Payment of Benefits

Benefit payments to participants are recorded when paid.

Administrative Expenses

Administrative expenses may be paid by the Employer or the Plan, at the Employer's discretion.

Note 3: INFORMATION CERTIFIED BY THE PLAN'S TRUSTEE

The Plan Administrator has elected the method of annual reporting compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Principal Life Insurance Company, as of January 13, 2022 and December 31, 2021, and for the period from January 1, 2022 through January 13, 2022, has certified that the following data included in the accompanying financial statements and supplemental schedule is complete and accurate:

- Investments as shown on the statements of net assets available for benefits as of January 13, 2022 and December 31, 2021;
- Net investment activity as shown in the statement of changes in net assets available for benefits for the period from January 1, 2022 through January 13, 2022;
- Investment information included in the footnotes and supplemental schedule as of January 13, 2022 and December 31, 2021, and for the period from January 1, 2022 through January 13, 2022.

The Plan's independent auditors did not perform auditing procedures with respect to this information, except for comparing such information to the related information included in the financial statements.

Note 4: FAIR VALUE MEASUREMENTS

The Plan did not hold any investments as of January 13, 2022.

Note 4: FAIR VALUE MEASUREMENTS - CONTINUED

When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. Level 3 inputs were only used when Level 1 or Level 2 inputs were not available.

Level 1 Fair Value Measurements

Fair values are based on quoted market prices in active markets for identical issues that the plan has the ability to access at the measurement date. The Plan's Level 1 investments include mutual funds and fixed income funds.

Level 2 Fair Value Measurements

Fair values are based on inputs other than quoted market prices included within Level 1 that are observable for valuing the asset, either directly or indirectly. Observable inputs include quoted prices for similar assets in active or non-active markets. Level 2 inputs may also include insignificant adjustments to market observable inputs. The Plan's Level 2 investments include pooled separate accounts, which are valued based on the fair value of the underlying assets comprising the accounts.

Level 3 Fair Value Measurements

Fair values are based on unobservable inputs used for valuing the asset. Unobservable inputs are those that reflect the Plan's own assumptions about assumptions that market participants would use in pricing the asset, based on the best information available in the circumstances

The Plan holds no Level 3 investments.

Note 5: INVESTMENTS MEASURED USING THE NET ASSET VALUE PER SHARE PRACTICAL EXPEDIENT

Investments held by the Plan include common / collective trusts. There have been no changes in the methodologies used to value common / collective trusts at January 13, 2022.

Common / collective trusts are stated at fair value as determined by the issuer of the common / collective trusts based on the fair market value of the underlying investments, which is valued at net asset value (NAV) as a practical expedient to estimate fair value. This practical expedient would not be used if it is determined to be probable that the fund will sell the investments for an amount different from the reported NAV. Participant transactions (purchases and sales) may occur daily.

The Plan did not hold any investments as of January 13, 2022.

Note 6: PLAN TAX STATUS

The Plan operates under a non-standardized adoption agreement in connection with a prototype 401(k) profit-sharing plan and trust sponsored by Principal Life Insurance Company. This prototype plan document has been filed with the appropriate agency and has obtained an opinion letter from the Internal Revenue Service stating that the prototype constitutes a qualified plan under Section 401 of the Internal Revenue Code (IRC) as of the date of the letter.

Although the Plan has been amended since receiving the opinion letter on the prototype plan document, the Plan administrator believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believe that the Plan is qualified and the related trust is tax-exempt. The Plan files income tax returns in the U.S. Federal jurisdiction. The statute of limitations for Federal tax returns is three years; therefore, all tax returns filed over three years ago are no longer subject to examination.

Note 7: PARTY-IN-INTEREST TRANSACTIONS

Party-in-interest transactions include those with fiduciaries or employees of the Plan, any person who provides services to the Plan, an employer whose employees are covered by the Plan, an employee organization whose members are covered by the Plan, a person who owns 50 percent or more of such an employer or employee association, or relatives of such persons.

For the period from January 1, 2022 through January 13, 2022, the Plan paid \$999 in administrative expenses to Principal Life Insurance Company.

Fees paid by the Plan for investment management services are included in net depreciation in fair value of investments, as they are paid through revenue sharing rather than a direct payment.

Note 8: PLAN TERMINATION

As a result of an effort to consolidate all benefit offerings under the Plan's parent company, effective January 13, 2022 the Plan was terminated and all assets were transferred to the Moore 401(k) Retirement Savings Plan.

Note 9: SUBSEQUENT EVENTS

Subsequent events have been evaluated through the date of the independent auditor's report, which is the date the financial statements were available to be issued.
