Telex Metals, LLC was acquired by Kymera International on 12/30/2021. The 401K plan of Telex Metals was administered under EIN 80-0557490 with the plan name of "Telex Metals 401(k)", Plan number 001. The recordkeeper for this plan was ADP Retirement Services.

This plan was merged into the 401 (k) plan for Kymera International effective Friday 4/29/2022 under EIN 20-1161055 with the plan name of "Kymera International 401(k) plan", Plan number 001. The recordkeeper for this plan is Fidelity (FMR, LLC).

Through a misunderstanding, Telex notified ADP Retirement Services that there was no change in EIN number as part of the merger of the Telex plan into the Kymera plan.

Had ADP been notified that there was to be a change in EIN number, ADP would have prepared a final 5500 and sent reminders to Telex / Kymera to participate in the filing of that form. Absent that information, ADP did not prepare a 5500 at the time nor remind Telex/Kymera that such a filing was in fact needed.

Kymera International filed its appropriate 5500 filing for 2022 with the understanding that Telex Metals' requirements were met by this filing.

Upon learning in September, 2024 that the filing of a final 2022 5500 was necessary for Telex Metals, LLC, immediate action was taken to rectify the situation and work with the prior record keeper to submit the proper filing. With this submission, a final return with final balances of zero end of year assets, zero participants and marked final has been filed.

We request any penalties be waived.
