Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of Pete and Gerry's Organics, LLC 401(k) Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt that Pete and Gerry's Organics, LLC 401(k) Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments; administering the plan; and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditor's Responsibilities for the Audit of the Financial Statements

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with generally accepted auditing standards will always detect a material misstatement when it exists. Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

The supplemental schedule, Schedule H, Line 4i- Schedule of Assets (Held at Year End), as of December 31, 2023, is presented for purposes of additional analysis and is not a required part of the financial statements but is supplementary information required by the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audit of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with generally accepted auditing standards. For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including their form and content, is presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

Note 1 - Description of Plan:

The following description of the Pete and Gerry's Organics, LLC 401(k) Plan (the "Plan") provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

(a) General

The Plan is a defined contribution plan sponsored by Pete and Gerry's Organics, LLC and Rooster Cruiser, LLC (the "Company"). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA").

The Plan covers all full-time and part-time employees, except certain excluded employees such as union members, nonresident aliens, and residents of Puerto Rico.

Recent Legislation

On December 23, 2022, Congress passed the Consolidated Appropriations Act of 2023 which included SECURE Act 2.0. SECURE Act 2.0 contains over 90 new retirement provisions, with varying effective dates through 2027. Since SECURE Act 2.0 provisions include both required and optional elements, the plan administrator will determine the optional provisions to elect and amend the Plan document accordingly. Most of the significant provisions will become effective in 2024 and thereafter. Accordingly, there is no material impact to the Plan's 2023 financial statements.

(b) Eligibility Requirements

Participants are eligible to participate in the Plan after completing one month of service and attainment of age 18. Employees are eligible to receive a Company match and profit sharing contributions upon completing one month of service. The Plan entry date for the match and profit sharing contribution occurs immediately upon meeting eligibility requirements.

(c) Contributions

Participants may contribute up to 92% of their annual compensation, subject to Internal Revenue Code ("IRC") limitations. Participants may make pre-tax deferrals or post-tax Roth deferrals. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. The Plan is a safe harbor plan, and the Company matches 100% of the first 4% of employee deferrals. The Company made \$583,819 and \$516,512, respectively, of safe harbor matching contributions for the years ended December 31, 2023 and 2022. Additionally, the Company may elect to make a profit sharing contribution. Eligibility for the profit sharing match is the same as for safe harbor matching contributions except that if the participant is terminated at year end, they must have completed at least 501 hours of service during the plan year to be eligible for the Company profit sharing contribution. The Company elected not to make any profit sharing contributions during the years ended December 31, 2023 and 2022.

Note 1 - Description of Plan (continued):

(c) Contributions (continued)

Participants may also contribute funds from another qualified retirement plan ("rollover contributions"), subject to certain requirements. Prior to changing trustees, the Plan offered various mutual funds and a group annuity contract as investment options for participants before they changed trustees. Refer to Note 1 (i) for further discussion on the assets transferred which occurred on December 18, 2023.

The maximum allowable calendar-year pre-tax or post-tax voluntary contribution, as determined by the Internal Revenue Service, was \$22,500 and \$20,500 during the years ended December 31, 2023 and 2022, respectively in addition to a maximum allowable catch-up contribution of \$7,500 and \$6,500, respectively.

(d) Participant Accounts

Each participant's account is credited with the participant's contributions, the participant's allocation of the Company's contributions, and the participant's proportional allocation of the Plan's earnings, including realized and unrealized gains and losses, and expenses. Participants determine the percentage in which contributions are to be invested in each fund. Participants may change their investment options as set forth in the plan document. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested amount.

(e) Vesting

Participants are fully vested in that portion of their account which represents their contributions and the income earned thereon. Participants are also immediately 100% vested in the Company's safe harbor matching contributions and earnings thereon. Vesting in the Company's profit sharing contributions are based on years of continuous service. A participant is 100% vested after 6 years of credited service. Participant accounts also become fully vested upon death, disability, or attainment of normal retirement age.

(f) Notes Receivable from Participants

Participants may borrow from their accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. A participant may have only one loan outstanding at any time, unless one loan is a principal residence loan amortized for a period greater than five years. The loans are secured by the balance in the participant's account and bear interest at the prime rate in effect on the date the loan was made. Loans must be repaid over a period not to exceed five years unless the loan proceeds are used for the purchase of a primary residence, in which case a longer repayment period is allowed. Participant loans are valued at the unpaid principal balance plus any accrued but unpaid interest and categorized as notes receivable from participants on the statement of net assets available for benefits.

Note 1 - Description of Plan (continued):

(f) Notes Receivable from Participants (continued)

Delinquent participant loans are reclassified as distributions based upon the terms of the plan document. Interest rates on outstanding loans at December 31, 2023 and 2022 ranged from 4.25% to 9.50% and loans mature at various times with the oldest maturity date of May 2029. Principal and interest are paid ratably through regular payroll deductions.

(g) Payment of Benefits

In-service withdrawals may be made from a participant's employee contributions account based on financial hardship, or upon reaching age 59½. On termination of service due to retirement, disability, death or other separation from service, a participant, or his/her beneficiary, may elect to receive either a lump-sum amount equal to the value of that participant's vested interest in his or her account, or installment payments. Participants who terminate employment and have a vested account balance of less than \$5,000 will receive a lump sum distribution of 100% of their vested benefits. Participants who have a vested account balance in excess of \$5,000 may leave their funds invested in the Plan or may elect a lump sum distribution.

(h) Forfeited Accounts

When certain terminations of participation in the Plan occur, the non-vested portion of a participant's account represents a forfeiture, as defined by the Plan. If a forfeiting participant is re-employed and fulfills certain requirements, as set forth in the Plan, the participant's account will be restored. Remaining forfeitures may be used to reduce Company contributions to the Plan or may be used to offset plan expenses. In 2023 and 2022, \$6,239 and \$4,706, respectively, of forfeitures were used for plan expenses. Unallocated forfeitures at December 31, 2023 and 2022 were \$0 and \$6,166, respectively.

(i) Due From/To Brokers

Due from brokers and due to brokers may include cash or securities maintained with brokers for margin account balances, collateral held in conjunction with the Plan's investment portfolio, and the amounts due to/from brokers for the settlement of purchase and sale transactions. These balances are not considered cash and short-term investments of the Plan. Certain amounts due from brokers' unsettled securities transactions have been reported on a net-by-counterparty basis, where, in accordance with contractual rights and/or investment manager's opinion, there is a right of offset in the event of bankruptcy or default by the broker. On December 18, 2023, the Plan changed trustees from Charles Schwab to Nationwide. The plan transferred out all assets totaling \$10,894,405 and were placed into a holding account with Nationwide. The assets appreciated in value by \$18,305 as of December 31, 2023, and as such, the holding account will be reported as a money market fund on the statement of net assets available for benefits.

Note 2 - Summary of Significant Accounting Policies:

(a) Basis of Accounting

The accompanying financial statements have been prepared using the accrual method of accounting.

(b) Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect reported amounts of Plan assets and liabilities and disclosures in the financial statements. Actual results may differ from those estimates.

(c) Investment Valuation and Income Recognition

Prior to the blackout period commencing on December 18, 2023, investments in mutual funds were reported at fair value, except for the Standard Stable Asset Fund, which was reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants on the measurement date. See Note 5 for discussion of fair value measurements and Note 6 for discussion on contract value.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

(d) Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are charged directly to the borrowing participant's account and are included in administrative expenses when incurred. As of December 31, 2023 and 2022, no allowance for credit losses has been recorded. If a participant does not make loan repayments and the plan administrator considers the participant loan to be in default, the loan balance is reduced, and the delinquent participant note receivable is recorded as a benefit payment based on the terms of the Plan document.

(e) Payment of Benefits

Benefits payments to participants are recorded when paid.

(f) Concentration of Credit Risk

Financial instruments that potentially subject the Plan to concentrations of credit risk are part of the holdings in the Plan's investments. Management believes that the trustee maintains the Plan's investments with high credit quality institutions and attempts to limit the credit exposure to any particular investment.

Note 2 - Summary of Significant Accounting Policies (continued):

(g) Expenses

Certain participant transaction fees are paid by participants. Remaining expenses incurred in the administration of the Plan may be paid by the plan sponsor. Fees incurred by the Plan for investment management services are included in net appreciation (depreciation) of fair value of the investments, as they are paid through revenue sharing provisions, rather than direct payment.

(h) Subsequent events

The Plan has evaluated subsequent events through November 12, 2024, the date the financial statements were available to be issued.

Note 3 - Information Prepared and Certified by the Plan's Trustee (Unaudited):

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments and notes receivable from participants held at December 31, 2023 and 2022, and net appreciation (depreciation) in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the years ended December 31, 2023 and 2022, was obtained by management and agreed to or derived from information certified as complete and accurate by the Plan's trustee, Charles Schwab Bank.

Note 4 - Investments:

During 2023 and 2022, the Plan's investments (including gains and losses on investments bought and sold, as well as held during the year) appreciated (depreciated) in value by \$1,531,713 and (\$2,117,132), respectively.

Note 5 - Fair Value Measurements:

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Note 5 - Fair Value Measurements (continued):

Level 2 Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2023 and 2022.

Mutual Funds and Money Market Fund:	Valued at the daily closing price as reported by the fund. Mutual funds and the money market fund held by the Plan are open ended mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Note 6 – Investment Contract:

During the period January 1, 2022 through December 18, 2023, the Plan held a group annuity contract backed by a fixed pooled separate account issued by Standard Insurance Company ("the contract issuer"). This investment meets the fully benefit-responsive investment contract criteria and therefore is reported at contract value. Contract value is the relevant measurement for fully benefit-responsive investment contracts because this is the amount that would be received by participants if they were to initiate permitted transactions under the Plan. Contract value represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

With traditional investment contracts, the Plan owns only the contract itself. These contracts are designed to accrue interest based on crediting rates established by the contract issuers.

Note 6 – Investment Contract (continued):

The traditional investment contract held by the Plan is a guaranteed investment contract. The contract issuer is contractually obligated to repay the principal and interest at a specified interest rate that is guaranteed to the Plan. The crediting rate is based on a formula established by the contract issuer but may not be less than 1%. Such interest rates are reviewed on a quarterly basis for resetting. The contract cannot be terminated before the scheduled maturity date.

The Plan must provide 30 days' notice to the contract issuer to redeem its interest in the investment at contract value. Other plan level withdrawals may be subject to a market value adjustment.

The Plan's ability to receive amounts due in accordance with fully benefit-responsive investment contracts is dependent on the third-party issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

Certain events might limit the ability of the Plan to transact at contract value with the contract issuer. Such events include the following: (1) amendments to the plan documents (including complete or partial plan termination or merger with another plan), (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the plan sponsor or other plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, or (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under the Employee Retirement Income Security Act of 1974.

Effective December 2023, in conjunction with the change in trustee, the contract was terminated and the Plan no longer offers this group annuity contract as an investment option.

Note 7 - Related Party Transactions and Parties-In-Interest:

Certain Plan investments were shares of a common collective trust managed by Charles Schwab. Charles Schwab was also the record keeper of the Plan and therefore, these transactions qualified as party-in-interest transactions. The Plan participants paid administrative fees of \$157,160 and \$87,698, respectively to Charles Schwab during 2023 and 2022, respectively.

Note 8 - Plan Termination:

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100 percent vested in their accounts, and the net assets of the Plan must be allocated among the participants and beneficiaries of the Plan in the order provided for by ERISA.

Note 9 - Tax Status:

The Plan adopted the volume submitter document of Standard Retirement Services, Inc. effective March 1, 2015. The Plan obtained an advisory letter from the Internal Revenue Service ("IRS") on March 31, 2014 in which the IRS stated that the form of the volume submitter plan was in compliance with the applicable requirements of the IRC. The volume submitter plan has been amended since receiving this letter and the plan administrator believes that the Plan is designed and being operated in compliance with the applicable requirements of the IRC, and that the related trust is therefore tax-exempt.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more-likely-than-not would not be sustained upon examination by the applicable taxing authorities. The plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2023, there are no uncertain tax positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The plan administrator believes it is no longer subject to income tax examinations for years prior to 2020.

Note 10 – Risk and Uncertainties:

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.
