### **Report On The Financial Statements**

We were engaged to audit the accompanying financial statements of **WHELEN ENGINEERING COMPANY, INC. PROFIT SHARING PLAN**, which comprise the statement of net assets available for benefits as of March 31, 2021 and August 31, 2020, and the related statement of changes in net assets available for benefits for the short year ended March 31, 2021, and the related notes to the financial statements.

### **Management's Responsibility For The Financial Statements**

Management is responsible for the preparation and fair presentation of these financial statements in accordance with accounting principles generally accepted in the United States of America; this includes the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error.
