This letter is in regards to the **late filing of Form 5500-SF for calendar year 2022.**

The company information is as follows:

We ended our 401K plan in 2022 as there were only 2 employees, the Office Manager and myself. The office manager retired the end of March and that was the final incentive to end the program.

Funds were all finally distributed in July and the plan was finally terminated leaving \$ 0.00 in assets.

We had been using PayChex Retirement Services (PayChex) to manage the 401K from it's inception in 2002. Any 5500-SF forms were always filed by them. I had expected the same to happen with the partial 2022 year.

After getting a notice from the Internal Revenue Service (IRS) and contacting them, I discovered it was not filed for 2022. I feel the reason PayChex did not file it was we were not a paying client at year end. We stopped paying any management fees to PayChex when the plan was terminated in July.

In a communication I received from PayChex regarding the plan termination, one of the items listed stated "A form 5500 Annual Return/Report must be filed each plan year in which assets remain in the plan(excludes Simple IRAs".

There were no assets left. I felt this meant it did not need to be filed. The conversation I had with the IRS I mentioned above advised me a "Final" return DID need to be filed with the Department of Labor. This document is an attachment to that filing.

I respectfully request any assessed penalties be removed from this late filing.
