## Independent Auditor's Report

### **Scope and Nature of the ERISA Section 103(a)(3)(C) Audits**

We have performed audits of the financial statements of All American Windows and Doors 401(k) Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). ***Emphasis of Matter***

As explained in Note 7 to the financial statements, All American Windows and Doors - BTP, LLC, the Plan's sponsor, elected to transfer all plan assets to a pooled employer plan. Consequently, all assets were transferred out on January 18, 2024, effectively terminating the Plan. Our opinion has not been modified with respect to this matter.

***Responsibilities of Management for the Financial Statements***

Management is responsible for the preparation and fair presentation of the financial statements in accordance with GAAP and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Except as described in the *Scope and Nature of the ERISA Section 103(a)(3)(C) Audits* section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Accordingly, the objective of the ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with GAAP.

**Note 1 - Plan Description**

The following description of All American Windows and Doors 401(k) Plan (the "Plan") provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

**General**

The Plan is a defined contribution plan covering nonunion employees of All American Windows and Doors - BTP, LLC; Florida Aluminum Products - BTP, LLC; Universal Window Solutions, LLC; and WindowMan of South Florida - BTP, LLC (collectively, the "Company") who have completed the necessary hours of service and are age 21 or older. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). Effective January 18, 2024, assets in the Plan were transferred to a pooled employer plan. See Note 7 for further information.

**Contributions**

The Plan provides for employee salary deferral contributions up to a maximum of 100 percent of annual compensation subject to maximum tax-deferred limitations established by the Internal Revenue Code. Participants may also make contributions to the Plan in the form of a rollover of funds from another qualified plan. Employees are automatically enrolled in the Plan at a 5 percent deferral rate within 30 days of becoming eligible to participate in the Plan on a quarterly basis.

The Plan is operating pursuant to the safe harbor provisions of Internal Revenue Code Section 401(k)(12). The Company's safe harbor matching contributions are on an annual basis and will equal 100 percent of elective deferrals up to 3 percent of the participant's contribution and 50 percent of elective deferrals between 3 and 5 percent of eligible compensation. The Company has the right to designate all or a portion of the matching safe harbor contributions as qualified.

The Company may make annual discretionary contributions, as approved by the Company's board of directors. The Company elected not to make a discretionary contribution for the period ended January 18, 2024 and the year ended December 31, 2023.

**Participant Accounts**

Each participant's account is credited with the participant's contributions and allocations of the Company's contributions and plan earnings and charged with an allocation of administrative expenses. Allocations are based on participants' compensation or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. Participants may direct the investments of their account balances into various investment options offered by the Plan.

**Vesting**

Participants are immediately 100 percent vested in employee salary, rollover, and safe harbor matching contributions and any income or loss thereon. Vesting in the Company's discretionary contribution portion of their accounts, plus actual earnings thereon, is based on years of service.

### Note 1 - Plan Description (Continued)

#### ***Benefit Payments***

Distributions are payable upon retirement, death, disability, or termination of employment in the form of a lump-sum amount equal to the vested balance of a participant's account or in a partial lump sum upon termination of employment. Account balances of less than \$5,000 are paid in a single lump sum upon termination. Participants may request that all or a portion of their total employee contributions be distributed in the case of financial hardship, as defined in the plan document.

#### ***Forfeitures***

If a participant is not fully vested on his or her termination date, the nonvested amount of the account is forfeited. Forfeitures are used to reduce future company contributions or to pay administrative expenses of the Plan.

#### ***Party-in-interest Transactions***

Certain plan assets are in investment funds managed by Voya Retirement Insurance and Annuity Company or its affiliates. Voya Retirement Insurance and Annuity Company is the custodian of the Plan; therefore, these transactions qualify as party-in-interest transactions, as defined under ERISA guidelines.

#### ***Termination***

The Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions set forth in the plan agreement and ERISA.

### Note 2 - Summary of Significant Accounting Policies

#### ***Investment Valuation***

The Plan's investments are stated at fair value except as noted below. The fully benefit-responsive unallocated investment contract is valued at contract value. Contract value represents deposits made to the contract, plus earnings at guaranteed crediting rates, less withdrawals and fees.

The pooled separate accounts are valued at net asset value per share (NAV) (or its equivalent) of the funds, which is based on the fair value of the funds' underlying net assets. See Note 5 for additional information.

#### ***Benefit Payments***

Benefits are recorded when paid.

#### ***Administrative Expenses***

Various administrative costs are paid by the Company.

#### ***Use of Estimates***

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of additions and deductions during the reporting period. Actual results could differ from those estimates.

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the financial statements.

#### *Subsequent Events*

The financial statements and related disclosures include evaluation of events up through and including November 7, 2024, which is the date the financial statements were available to be issued.

### Note 3 - Certified Information

Voya Retirement Insurance and Annuity Company (the "Custodian") holds the Plan's investments and executes all investment transactions. The investment balances and related investment income and losses as of January 18, 2024 and December 31, 2023 and for the period ended January 18, 2024 and the year ended December 31, 2023 included in the accompanying financial statements are based solely on information certified by the Custodian.

### Note 4 - Tax Status

The Plan uses a preapproved plan. The preapproved plan has received a favorable opinion letter from the Internal Revenue Service (IRS) indicating that the Plan, as designed, is qualified for federal income tax-exempt status. The Plan has not individually sought its own determination letter.

### Note 5 - Fair Value Measurements

- (1) This class represents investments in actively managed pooled separate accounts that invest primarily in equity securities, which may include common stocks, options, and futures.
- (2) This class represents investments in actively managed pooled separate accounts that invest in a variety of fixed-income investments, which may include corporate bonds, both U.S. and non-U.S. municipal securities, interest rate swaps, options, and futures.
- (3) This class represents investments in actively managed pooled separate accounts with investments in both equity and debt securities. The investments may include common stock, corporate bonds, U.S. and non-U.S. municipal securities, interest rate swaps, options, and futures.

There were no unfunded commitments or redemption restrictions on the investments described above.

### Note 6 - Unallocated Investment Contract

The Plan has a benefit-responsive unallocated investment contract with Voya Retirement Insurance and Annuity Company (Voya). Voya maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan. There are no reserves against contract value for credit risk of the contract issuer or otherwise. The interest crediting rate is based on a formula agreed upon with the issuer but may not be less than 1.0 percent. Such interest rates are reviewed on a quarterly basis for resetting.

Certain events limit the ability of the Plan to transact at contract value with the insurance company and the financial institution issuer. Such events include the following: (i) amendments to the plan documents (including complete or partial plan termination or merger with another plan), (ii) changes to the Plan's prohibition on competing investment options, (iii) bankruptcy of the plan sponsor or other plan sponsor events (e.g., divestitures or spinoffs of a subsidiary) that cause a significant withdrawal from the Plan, or (iv) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA. The plan administrators do not believe that the occurrence of any such event, which would limit the Plan's ability to transact at contract value with participants, is probable. The unallocated investment contract allows for termination with the contract provider; the contract provider reserves the right to defer payment of the fixed account to the Plan for no longer than 12 months following termination date. There are no events that require the plan sponsor to settle an amount different than contract value paid either within 90 days or over time upon termination of the contract.

The unallocated investment contract is fully benefit responsive; therefore, contract value is the relevant measurement attribute for that portion of the net assets attributable to the unallocated investment contract. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investments at contract value. The benefit-responsive unallocated investment contract was liquidated at the Plan's transfer out date of January 18, 2024. See Note 7 for additional details.

### Note 7 - Plan Transfer Out

Effective January 18, 2024, the Plan's assets were transferred to a pooled employer plan at the direction of the plan sponsor. Accordingly, all assets, participants, and their related account balances were transferred to the pooled employer plan, effectively terminating the Plan.
