Opinion

NOTES TO FINANCIAL STATEMENTS

Note 1 - DESCRIPTION OF THE PLAN

The following description of the Atomica Corp 401(k) Savings Plan (the “Plan”) is provided for general information only. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan covering all employees of Atomica Corp., formerly Innovative Micro Technologies, Inc., (“the Employer”) except those that are: 1) covered by a collective bargaining agreement, 2) nonresident aliens not receiving any United States of America earned income, or 3) an owner-employee. Employees are eligible on the first day of employment. The plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Contributions

Participants may contribute 90% of their annual pretax wages up to the amount as defined in the Plan, subject to the annual limitation imposed by the Internal Revenue Service. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified plans.

The Company makes a matching contribution of \$1 for every dollar contributed by employees to the plan up to the first 3% of eligible compensation, followed by \$0.50 for every dollar contributed by employees to the plan for the next 2% of eligible compensation. The Company may make discretionary contributions to the Plan. The Company made no discretionary contributions for the year ended December 31, 2022.

Investments

Investments are held in participant-directed investment funds. The participants select the percentage of contributions to be allocated to each investment option. Participants’ contributions are withheld from their paychecks and remitted to the trustees. The participants’ accounts are credited with the actual earnings on the underlying investments and are charged for Plan withdrawals by the trustees. Earnings on investments include interest income, realized and unrealized gains and losses, and dividends from pooled separate accounts. The pooled separate accounts as reported by the trustees are included in the statements of net assets available for benefits at December 31, 2022 and 2021, at fair value.

NOTES TO FINANCIAL STATEMENTS

Note 1 - DESCRIPTION OF THE PLAN (continued)

Participant Accounts

Each participant's account is credited with the participant's contribution and distributions and an allocation of the Employers' contributions and Plan earnings. Allocations are based on participant earnings or account balances, as defined. Additionally, participants may change their investment elections on a daily basis in accordance with the trust agreement. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are immediately vested in their contributions and earnings. They are also immediately vested in all Company matching and discretionary contributions and earnings.

Payment of Benefits

Benefits are recorded when paid. On termination of service, a participant may elect to receive either a lump-sum amount equal to the value of the participant's vested account, or annual installments over a time period designated by the participant.

Forfeited Accounts

Forfeited accounts will be used to reduce future employer contributions. For the year ended December 31, 2022, forfeitures were \$10,332. At December 31, 2022 and 2021, forfeited account balances totaled \$72,251 and \$63,816, respectively.

Death Benefits and Disability

Upon the death or disability of a participant before retirement or termination of employment, the current balance of the participant's individual account becomes fully vested and will be paid to his designated beneficiary, as chosen by the beneficiary.

Notes Receivable From Participants

Participants in the Plan may borrow up to 50% of their vested account balance with a minimum of \$1,000 and a maximum of \$50,000. Loan transactions are treated as transfers between the investment fund and the loan fund. Monthly repayments are deducted from the participant's wages. Loan terms range from one to five years, or greater than five years for the purchase of a primary residence. The loans are secured by the balance in the participant's account and bear a fixed interest rate ranging from 4.25% to 7.25%, which are commensurate with local prevailing rates as determined by the plan administrator. Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent participant loans are reclassified as distributions based upon the terms of the plan document.

Note 2 - SUMMARY OF ACCOUNTING POLICIES

Basis of Accounting

The financial statements of the Plan have been prepared on the accrual basis of accounting.

Estimates

The preparation of financial statements requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

Investment Valuation and Income Recognition

The Plan's investments are reported at fair value, except for the fully benefit-responsive investment contract (stable value fund), which is reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's management determines the Plan's valuation policies utilizing information provided by the investment advisors, custodians, and insurance company.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Subsequent Events

The Plan's Trustees have evaluated subsequent events through May 5, 2024, the date which the financial statements were available to be issued.

Note 3 - INFORMATION CERTIFIED BY THE PLAN'S TRUSTEE

The plan administrator has elected the method of annual reporting compliance permitted by 29 CFR 2520.103-8 of the Department of Labor Rules and Regulations for Reporting and Disclosure under ERISA. Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and supplemental schedule, including investments (\$15,396,840 and \$19,613,543) and notes receivable from participants (\$116,816 and \$143,618) held at December 31, 2022 and 2021 respectively, and net depreciation in fair value of investments (\$4,193,209), interest income from notes receivable from participants (\$5,894), and dividend income (\$478,476) for the year ended December 31, 2022, was obtained or derived from information supplied to the plan administrator and certified as complete and accurate by Great-West Life & Annuity Insurance Company.

Note 4 - PLAN EXPENSES

Accounting and administrative expenses incurred in the administration of the plan are paid by the Company and are not allocated to individual participant accounts.

Note 5 - RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

The Plan investments in funds which invest in securities of foreign countries, which involve special risks and considerations not typically associated with investing in U.S. companies. These risks include devaluation of currencies, less reliable information about issuers, different securities transaction clearance and settlement practices, and possible adverse political and economic developments. Moreover, securities of many foreign companies and their markets may be less liquid and their prices more volatile than those securities of comparable U.S. companies.

Note 6 - PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue their contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

Note 7 - TAX STATUS

The Internal Revenue Service has determined and informed the trustee by a letter dated May 18, 2011, that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the determination letter, the Plan administrator and the Plan's tax counsel believe that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC. Therefore, they believe that the Plan was qualified and the related trust was tax-exempt as of the financial statement date. As a result, the Plan has not provided for Federal or applicable state income taxes.

The Plan evaluates uncertain tax positions, whereby the effect of the uncertainty would be recorded if the outcome was considered probable and reasonably estimable. As of December 31, 2022, the Plan had no uncertain tax positions requiring accrual.

The Plan files tax returns in the U.S. federal jurisdiction. The Plan is no longer subject to U.S. federal tax examinations by tax authorities for years before 2019.

Note 8 - PARTY-IN-INTEREST TRANSACTIONS

Great-West Life & Annuity Insurance Company is a party-in-interest with respect to the Plan. The records of the Plan indicate no party-in-interest transactions which are prohibited by ERISA Section 406 and for which no statutory or administrative exemption exists.

Note 9 - STABLE VALUE FUND INVESTMENT CONTRACT

The Plan entered into a traditional fully benefit-responsive guaranteed investment contract with Great-West Life & Annuity Insurance Company totaling \$2,643,983 for 2022 and \$1,573,861 for 2021. Great-West Life & Annuity Insurance Company maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The guaranteed investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan. The issuer resets the crediting interest rate annually. The minimum guaranteed interest rate varies for each contract year and may be modified by the custodian prior to the renewal date of the contract upon occurrence of specific events as provided in the contract. The crediting interest rate is based upon many factors, including estimated future earnings rate (the rate at which investments mature) and future cash flows.

The contract meets the fully benefit-responsive investment contract criteria and is therefore reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value, as reported by Great-West Life & Annuity Insurance Company, represents contributions made under the contract, plus earnings, less participant withdrawals, and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

The Plan's ability to receive amounts due is dependent on the issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments

Note 10 - FAIR VALUE MEASUREMENTS

Financial Accounting Standards Board (FASB) *Accounting Standards Codification* (ASC) 820, *Fair Value Measurement and Disclosures*, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes inputs to the valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2022 and 2021.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.
