### **Independent Auditor's Report**

#### ***Scope and Nature of the ERISA Section 103(a)(3)(C) Audit for the 2023 and 2024 Financial Statements***

We have performed audits of the financial statements of the Philadelphia Tramrail Enterprises, Inc. Employees Profit Sharing and 401(k) Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C). The financial statements comprise the statements of net assets available for benefits as of January 31, 2024 and December 31, 2023, and the related statements of changes in net assets available for benefits for the periods then ended, and the related notes to the financial statements.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with GAAP.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

### Plan Description

The Philadelphia Tramrail Enterprises, Inc. Employees Profit Sharing and 401(k) Plan (the Plan) is a defined contribution plan covering all full-time employees of Philadelphia Tramrail Enterprises, Inc., PTR Baler & Compactor Co., and Tramrail Baler & Compactor Service Co., (collectively, the Company). The Plan was amended October 11, 2022, however the administration of the Plan and participant benefits remained materially consistent.

The following description of the Plan is provided for general information purposes only. Participants should refer to the Plan agreement for a complete description of the Plan's provisions.

#### General

The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). Employees, who are a minimum of 21 years old, are eligible once they have completed one month of service. The Plan provides that all eligible employees are automatically enrolled at an initial deferral rate of 5%, which increases 1% annually up to 10%, unless they specifically opt-out. Contributions are invested in a designated balanced fund until changed by the participant.

During 2024, management of Komar Industries LLC, a controlling party of the Company, approved the merger of this Plan into the Khor Buyer 401(k) Profit Sharing Plan & Trust (the Khor Plan). Effective January 1, 2024, the Plan was frozen to new participation and all future contributions. The Plan's assets were transferred out of the Plan on January 31, 2024 and into the Khor Plan at Mid Atlantic Trust Company. As part of this merger, each participant's and beneficiary's account balance under the Khor Plan shall be at least equal to the balance he or she had under this Plan immediately prior to the January 31, 2024 merger.

#### Contributions

Each year, participants may contribute up to 100% of pretax annual compensation, or make Roth contributions, as defined in the Plan agreement. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollovers). Participants direct the investment of their contributions into various investment options offered by the Plan. As of both December 31, 2023 and 2022, the Plan offered 30 mutual funds, one interest bearing money market fund, and one common collective trust as investment options for participants.

The Plan provides that the Company may made discretionary matching contributions, as approved by the Plan Committee. For the year ended December 31, 2023, the Plan Committee declared a matching contribution of 40% of participant's salary deferral contributions, up to 5% of a participant's salary deferral contributions. The Company is required to make a safe harbor contribution of 3% of compensation for eligible participants. For the year ended December 31, 2023, the safe harbor contribution was approximately \$452,000. Additionally, profit sharing amounts may be contributed at the discretion of the Plan Committee. There were no profit sharing contributions during 2023.

Contributions are subject to certain limitations.

#### Participant Accounts

Each participant's account is credited with the participant's contribution and allocations of (a) the Company's contributions and (b) plan earnings, and (c) charged with an allocation of administrative expenses. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined in the Plan agreement. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

#### Vesting

Participants are vested immediately in their contributions, the Company's safe harbor contributions, plus actual earnings thereon. Vesting in the employer matching contribution portion of their accounts is based on years of continuous service, based on the following schedule:

#### Notes Receivable from Participants

Participants may borrow from their fund accounts up to a maximum equal to the lesser of \$50,000 or 50% of their account balance. Loan terms range from one to five years, or over a reasonable period of time for the purchase of participant's primary residence, as established by the Plan Administrator. The loans are secured by the balance in the participant's account and bear interest at a rate commensurate with local prevailing rates as determined by the plan administrator. Principal and interest is paid ratably through payroll deductions.

#### Payment of Benefits

Upon termination of service due to death, disability, retirement or other reasons, benefit payments will be paid in the form of a lump sum. Participant contributions may be withdrawn from the Plan prior to termination of the participant's employment with the Company if the participant has either attained age 59 ½ or is able to demonstrate financial hardship, as defined in the plan agreement. If the value of the vested portion of the participant's account is not more than \$5,000, the participant's benefit will be distributed in a single lump sum payment.

### Forfeited Accounts

At December 31, 2023 and 2022, forfeited non-vested accounts totaled \$132,486 and \$69,951, respectively. Amounts forfeited by participants who terminate service prior to becoming fully vested are used to pay administrative expenses or reduce Company contributions. For the periods ended January 31, 2024 and December 31, 2023, no forfeitures were used to pay administrative expenses or to reduce employer contributions.

### SECURE Act 2.0

On December 23, 2022, Congress passed the Consolidated Appropriations Act of 2023 which included SECURE Act 2.0. SECURE Act 2.0 contains over 90 new retirement provisions, with varying effective dates through 2027. Since SECURE Act 2.0 provisions include both required and optional elements, the plan administrator will determine the optional provisions to elect and amend the Plan document accordingly. Most of the significant provisions will become effective in 2024 and thereafter. Accordingly, there is no material impact to the Plan's 2022, 2023 or 2024 financial statements.

## Summary of Significant Accounting Policies

### Basis of Accounting

The accompanying financial statements of the Plan are prepared on the accrual basis of accounting.

### Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America (GAAP) requires the plan administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

### Contributions

Participant contributions are recognized when due through salary withholding. Employer matching and safe harbor contributions are recognized each payroll period.

### Investment Valuation and Income Recognition

The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. For additional disclosure regarding fair value of investments, see the *Fair Value Measurements* footnote herein.

#### Investment Valuation and Income Recognition (continued)

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

#### Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. No allowance for credit losses has been recorded as of December 31, 2023 or 2022. If a participant ceases to make loan repayments and the plan administrator deems the participant loan to be in default, the participant loan balance is reduced and a benefit payment is recorded.

#### Payment of Benefits

Benefits are recorded when paid.

#### Administrative Fees

The Plan's administrative expenses are paid by either the Plan or the Company, as provided by the plan document.

### Fair Value Measurements

GAAP established a fair value hierarchy that prioritizes the inputs to measure the fair value of the assets or liabilities being measured. Fair value is defined as the exchange value that would be received on the measurement date to sell an asset or to value the amount paid to transfer a liability in the principal or most advantageous market available to the entity in an orderly transaction between market participants. The three levels of the fair value hierarchy are as follows:

- Level 1 Inputs are unadjusted quoted market prices in active markets for identical assets or liabilities that the entity has the ability to access at the measurement date. Level 1 inputs provide the most reliable measure of fair value as of the measurement date.
- Level 2 Inputs are based on significant observable inputs, including unadjusted quoted market prices for similar assets and liabilities in active markets, unadjusted quoted prices for identical or similar assets or liabilities in markets that are not active, or inputs other than quoted prices that are observable for the asset or liability.
- Level 3 Inputs to the valuation methodology are unobservable inputs for the asset or liability.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at January 31, 2024, December 31, 2023 or 2022.

*Mutual Funds:* Valued at the net asset value (NAV) of shares held by the Plan at year-end.

*Interest Bearing Cash:* Valued at the net asset value (NAV) of shares held by the Plan at year-end.

*Common Collective Trusts:* Valued at the NAV provided by the administrator of the fund. Issues and redemptions of units are recorded upon receipt of unit holder's instructions based on the determined NAV per unit, which is determined daily. The NAV is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV. For this fund, there are no unfunded commitments, redemption restrictions, and participants can transact daily.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

### **Tax Status**

The Company has adopted a prototype non-standardized profit sharing plan which received a favorable opinion letter dated June 30, 2020, from the Internal Revenue Service (IRS). The opinion letter stated that the Plan is designed in accordance with applicable sections of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the determination letter, the plan administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC. Therefore, no provision for income taxes has been included in the Plan's financial statements.

GAAP requires plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of January 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

### **Transactions with Parties-in-Interest**

Certain Plan investments are shares of mutual funds and a money market fund managed by Fidelity. Fidelity is the trustee of the Plan and, therefore, these transactions qualify as party-in-interest. Fees paid by the Plan for these services amounted to \$24,006 and \$6,716 in 2024 and 2023, respectively.

### **Nonexempt Transactions**

During the year ended December 31, 2022, the Company inadvertently failed to deposit \$479,589 of participant deferrals within the required timeframe as stated by the DOL regulations. The Company intends to reimburse the Plan for lost interest, however lost interest reimbursement has not been completed during the period ended January 31, 2024 or the year ended December 31, 2023. The excise tax payments will be made from the Company's assets and not from assets of the Plan.
