Opinion

Notes to Financial Statements

NOTE 1 – DESCRIPTION OF PLAN

The following description of R.S. Hughes Company, Inc. Employee Stock Ownership Plan (the Plan), provides only general information. Participants should refer to the plan document, most recently amended and restated effective as of January 1, 2023, for a more complete description of the Plan's provisions.

The Plan is an employee stock ownership plan (ESOP) that was established in 1976 by R.S. Hughes Company, Inc. (the Company), to provide benefits to eligible employees, as defined in the plan document. The Plan is currently designed to be qualified under the applicable requirements of the Internal Revenue Code (the Code) and the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). Under the terms of the Plan, a designated officer of the Company acts as the Trustee. The Company has appointed an ESOP Committee (the Committee) to manage the operation and administration of the Plan.

Eligibility – An employee may become eligible to participate in the plan on the first June 30th or December 31st coinciding with or immediately preceding meeting eligibility requirements, which is completion of twelve consecutive months of service (in which they are credited with at least 1,000 hours of service).

Employer contributions – The Company may elect to make discretionary contributions to the Plan in such amounts as determined by the Company's Board of Directors. There were no discretionary contributions made from January 1, 2024 to January 31, 2024.

Voting rights – Other than mentioned below, all shares of the Company's stock held in the Trust shall be voted by the Trustee in accordance with the directions of the Committee. Whenever a vote concerns a corporate matter involving a corporate merger or consolidation, recapitalization, reclassification, liquidation, dissolution, sale of substantially all assets of a trade or business, or such other similar transaction, the Trustee shall vote in accordance with instructions received from participants who have stock allocated to their account.

Participant accounts – Each participant's share of plan assets is recorded in two accounts: the Company Stock Account, which generally represents the participant's allocable portion of the Company's shares included in plan assets, and the Other Investment Account, which generally represents the participant's share of Company contributions and forfeitures in other than Company common stock.

Each participant's account is credited (or debited) with an allocation of: a) the Company's contribution, b) forfeitures of terminated participants' nonvested accounts, c) net income (or loss) of the Trust, and d) unrealized appreciation (depreciation) in the value of the Plan's investment in Company stock. Employer contributions and forfeitures are allocated to all participants in equal amounts without regard to compensation; however, no allocation is made to any participant whose annual compensation is \$345,000 or higher.

Dividend income on unallocated shares and forfeitures are contributed to the Plan and are held by the Trust. Cash dividends on allocated shares are paid by the Company directly to the participants and are recorded in the Plan's financial statements as dividends and distributions. There were no dividends paid for the period of January 1, 2024 to January 31, 2024.

Vesting – Each individual who is a participant on December 31, 2022 will continue to have a 100% vested and nonforfeitable interest in their accounts. Employees hired on or after January 1, 2023 will become vested in their accounts 100% upon reaching retirement age or upon completion of three years of eligible service.

Payment of benefits – On termination of service due to any reason, distributions commence in the plan year following the event. The amount to be distributed is based upon the immediately preceding valuation date.

Distributions will be made in cash, shares of Company stock, or a combination of both, as determined by the Company and the participants' rights under the Plan. Under the provisions of the Plan, the Company is obligated to repurchase participant shares, which have been distributed under the terms of the Plan.

Administrative expenses – The Company pays for plan administrative expenses, which consist primarily of third-party administrator, audit, and independent appraisal fees.

Put option – Under federal income tax regulations, the employer stock that is held by the Plan and its participants and is not readily tradable on an established market, or is subject to trading limitations, includes a put option. The put option is a right to demand that the Company buy any shares of its stock distributed to participants for which there is no market. The put price is representative of the current appraised value of stock. The put option, as defined in the plan document, gives the participant a right to have the Company repurchase their shares within 60 days after the shares are distributed. If not exercised at that time, a second 60 day put option will begin as soon as the following year's stock valuation is completed.

Diversification – Participants who are age 55 or over and have completed ten years of participation under the Plan may diversify a portion of the shares in Company common stock into investments that are more diversified.

Forfeitures – Plan forfeitures are allocated to each participant's account based upon the relation of the participant's eligible compensation to total eligible compensation for the plan year. Forfeited nonvested accounts to be allocated to participant accounts in future years as of January 31, 2024 and December 31, 2023, were \$0. During the period ended January 31, 2024, forfeitures of shares and cash amounting to approximately 0 and \$0, respectively, were allocated to participants.

NOTE 2 – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of accounting – Financial statements of the Plan are prepared on the accrual method of accounting in accordance with accounting principles generally accepted in the United States of America.

Use of estimates – The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities, and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates. The Plan relies significantly on the use of estimates in determining the valuation of the Company's common stock, which is the primary plan investment.

Investments – The Plan assets, which consist principally of Company common stock, are nonparticipant-directed and are maintained by the Trustee under the R.S. Hughes Company, Inc. Employee Stock Ownership Trust (the Trust).

The Plan's investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade date basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought or sold as well as held during the year.

Risks and uncertainties – The value of the Company's common stock is directly related to the annual operating results and financial position of the Company. It is at least reasonably possible that changes in the value of the Company's common stock in the near term would materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits and the statement of changes in net assets available for benefits.

NOTE 3 – FAIR VALUE MEASUREMENTS

The fair value measurements standard establishes a framework for measuring fair value. That framework provides a hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements).

The three levels of the fair value hierarchy under the standard are described below:

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 – Inputs to the valuation methodology include:

- Quoted market prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability; and
- Inputs that are derived principally from, or corroborated by, observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation technique used for common stock measured at fair value. There have been no changes in the technique used at January 31, 2024 and December 31, 2023.

The fair value of common stock of the Company is determined periodically or annually by an independent appraiser. The methodology used by the independent appraiser is a combination of an income approach (discounted cash flow method) and a market approach (guideline company method).

The method described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair value. Furthermore, while the Plan believes its valuation method is appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value could result in a different fair value measurement at the reporting date.

NOTE 5 – TAX STATUS

The Internal Revenue Service has determined and informed the Company by a letter dated October 18, 2017, that the Plan is designed in accordance with applicable sections of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the determination letter, the plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC.

In accordance with guidance on accounting for uncertainty in income taxes, the plan administrator has evaluated the Plan's tax positions and does not believe the Plan has any uncertain tax positions that require disclosure or adjustment to the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE 6 – RECONCILIATION TO FORM 5500

The Form 5500 has certain items that differ from amounts shown on the accompanying financial statements. These differences relate to classification only and have no effect upon net assets available for benefits for either period.

NOTE 7 – PLAN TERMINATION OR MODIFICATION

The Company intends to continue the Plan indefinitely for the benefit of its participants; however, it reserves the right to terminate or modify the Plan at any time by resolution of its Board of Directors and subject to the provisions of ERISA.

NOTE 8 – SUBSEQUENT EVENTS

Subsequent events are events or transactions that occur after the statements of net assets available for benefits date, but before the financial statements are available to be issued. The Plan recognizes in the financial statements the effects of all subsequent events that provide additional evidence about conditions that existed at the date of the statements of net assets available for benefits, including the estimates inherent in the process of preparing the financial statements. The Plan's financial statements do not recognize subsequent events that provide evidence about conditions that did not exist at the date of the statements of net assets available for benefits but arose after the statements of net assets available for benefits date and before the financial statements are available to be issued.

Subsequent to January 31, 2024, the Plan was amended and restated effective February 1, 2024. A summary of the relevant provisions is as follows:

- The Company was a C Corporation for income tax purposes for all tax periods through January 31, 2024. The Company elected to become an S Corporation effective as of February 1, 2024.
- Employees hired on or after February 1, 2024 will become participants as of the first January 31st or July 31st coinciding with or immediately preceding meeting eligibility requirements, which is completion of twelve consecutive months of service (in which they are credited with at least 1,000 hours of service).
- The right of first refusal and put options were removed effective February 1, 2024.

The Plan has evaluated subsequent events through November 14, 2024, which is the date the financial statements were available to be issued.
