Re: Waiver of Penalty for Late Filing of Form 5500

Please be informed that the office above had no supporting staff for approximately one year as revenue was much less than the overhead expenses for the office. This led to a void in the supporting staff for the dentist/owner, who was not aware of this requirement. Although the ADP has been charging a monthly fee, there were no salaries being paid to the persons who are owners of the 401K accounts. I attempted to discontinue ADP services a year ago, but was unsuccessful, as the penalty of \$1500 could not be found.

As the administrator for the 401K plan, I had to leave the operations at Apollo Dental Centers to get gainful employment in order to pay my living expenses. I was not able to return to the office to complete application forms until last week, since my new work location is in the North of Georgia, while the dental office is in the South of Atlanta, Georgia. Unfortunately, the due date for filing the 5500-form passed.

The office continues to operate in deficit with the dentist not yet able to obtain a salary. In view of this dire situation, I am asking for a waiver of the penalty for not filing the 5500 form on time. Please note that the office is in an underserved community and is subject to poor or no payment for services rendered.
