(1) Description of Plan

The following description of the St. Elizabeth Medical Center 401(k) Plan (Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

(a) General

The Plan is a defined contribution 401(k) profit sharing plan covering eligible employees of St. Elizabeth Medical Center (SEMC) who have three months of service and are age 21 or older. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Mohawk Valley Health System (MVHS), a not-for-profit corporation is the sole member of SEMC and MVHS, Inc. (formerly Faxton-St. Luke's Healthcare). Effective October 29, 2023, all SEMC employees became employees of MVHS, Inc., and were immediately eligible to participate in the MVHS, Inc. 401(k) Plan as a result of MVHS finalizing the construction of its new hospital campus in downtown Utica and consolidating operations and services from SEMC and MVHS, Inc. Contributions into the Plan ceased after the aforementioned effective date of employees transferring to MVHS, Inc.

Effective January 19, 2024, the Plan merged with and into the MVHS, Inc. 401(k) Plan. Each participant in the Plan will receive a benefit under the MVHS, Inc. 401(k) Plan immediately after the merger which is equal to the benefit the participant would have been entitled to receive immediately prior to the merger, if the Plan had then terminated.

(b) Contributions

SEMC offers the Plan to substantially all of its non-union employees and New York State Nurses Association (NYSNA) registered nurses. Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan offered various mutual funds, a self-directed brokerage account, and a stable value fund as investment options for participants. Each year participants may contribute up to 75% of eligible pre-tax compensation, as defined in the Plan, subject to maximum annual additions allowed by law. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Non-union employees and NYSNA registered nurses are eligible to receive a safe harbor contribution equal to 3% of eligible compensation. In addition, non-union employees and NYSNA registered nurses age 21 or older who have completed at least one year of service (at least 1,000 hours) are eligible for a discretionary match on their contributions based on years of service as detailed below:

(b) Contributions, Continued

The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their deferral rate set at 3% of eligible compensation for the first two years of participation, which increases annually after year two by 1% to a maximum of 6%, with their contributions invested in a Life Targeted Fund approximating year of retirement unless changed by the participant. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollovers).

(c) Participant Accounts

Each participant's account is credited with the participant's contributions and related employer contributions, as well as allocations of Plan earnings (losses). Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings (losses), account balances or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

(d) Vesting

Participants were vested immediately in their contributions plus actual earnings thereon. Vesting in the employer's safe harbor contribution was 100% vested after two years of credited service. Vesting in the employer's discretionary match contribution was 100% vested after three years of credited service.

(e) Notes Receivable from Participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The loans are secured by the balance in the participant's account and bear interest at rates ranging from 3.25% to 8.50%, which are commensurate with the U.S. prime rate of interest at the time the loan is originated plus 1.00%. Principal and interest is paid ratably through payroll deductions or directly by the Plan participant.

(f) Payment of Benefits

On termination of service due to death, disability, retirement or other reasons, a participant may elect to receive either a lump sum amount equal to the value of the participant's vested interest in his or her account or may elect to roll these funds into another qualified retirement account.

(g) Forfeited Accounts

At December 31, 2023, forfeited nonvested accounts totalled \$6,400. During 2023, Employer contributions were reduced by \$38,662, from forfeited nonvested accounts. At January 19, 2024, there were no forfeited nonvested accounts.

(2) Summary of Significant Accounting Policies

(a) Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

(b) Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires the Plan administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

(c) Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Pension Committee determines the Plan's valuation policies utilizing information provided by the investment advisors and trustee. See note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the period.

(d) Notes Receivable from Participants

Notes receivables from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred.

(e) Payment of Benefits

Benefits are recorded when paid.

(f) Expenses

Certain expenses of maintaining the Plan are paid directly by the employer and are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Certain investment related expenses are included in administrative expenses.

(g) Subsequent Events

The Plan has evaluated subsequent events through November 15, 2024, the date the financial statements were available to be issued.

(3) Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2023.

Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Self-directed brokerage account: A separate account valued by each account's investment holding by Schwab Personal Choice Retirement Account. The funds held by the account are open-end mutual funds, exchange traded funds and common stocks that are registered with the U.S. Securities and Exchange Commission. The mutual funds, exchange traded funds and common stocks in the account are deemed to be actively traded.

Collective trust fund: Valued at the NAV of units of the collective trust fund. The NAV, as provided by the trustee, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV.

(4) Certified Investment Information

Certain information disclosed in the accompanying financial statements and ERISA-required supplementary schedule, including all investments and notes receivable from participants held at January 19, 2024 and December 31, 2023, and net appreciation (depreciation) in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the period from January 1, 2024 to January 19, 2024 and for the year ended December 31, 2023, was obtained by management and agreed to or derived from information certified as complete and accurate by Hand Benefits & Trust Company.

(5) Party-in-Interest Transactions

Hand Benefits & Trust Company is the Plan trustee as defined by the Plan and, therefore, these transactions qualify as party-in-interest transactions. Fees paid for providing the services for 2024 and 2023 were \$458 and \$214,254, respectively. In addition, the Plan issues notes receivable to participants, which are secured by the balances in the participants’ accounts. These transactions qualify as exempt party-in-interest transactions.

(6) Tax Status

The IRS has determined and informed the prototype sponsor by a letter dated June 30, 2020, that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the determination letter, the Plan administrator believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and therefore believes that the Plan is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan administrator believes it is no longer subject to income tax examinations for years prior to 2020.

(7) Risks and Uncertainties

The Plan invested in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it was at least reasonably possible that changes in the values of investment securities would occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.
