To Whom It May Concern,

I would like to request to waive fee for Form 5500 filing for 2022. My company is jointly owned by my wife and I and we are the only 2 employees.

While I have filed form 5500 in the past I thought I had sone so in error and that these compliance rules didn't apply to us.

We've only had a 401K plan for 3 years and we are on a learning curve.

My understanding is that Form 5500 is an annual report containing information about retirement plans, as well as health and welfare plans, provided by employers.

It has come to my knowledge that there is in fact a difference and that we should use Form 5500-EZ when the only plan participants are the business owner, partners in the business and the owners' spouses. In this case we are all 3 things.

In addition, we are in the process of changing our 401K to a Simple IRA plan and I mistakenly thought that this would change requirements.

It is a challenge to run a small business when the burden of all paperwork, billing and taxes is on the same people doing all of the day to day operations. In addition 2022 was a tough year for our business and Form 5500 got lost in the shuffle.

It is my hope that Compliance is the goal and now that I understand the rules I look forward to fulfilling our filing obligations. It would be received in gratitude if you were to waive the \$750 penalty.
