## INDEPENDENT AUDITOR'S REPORT

To the Administrator of

### Opinion

We have audited the financial statements of the Winston & Strawn LLP Retirement Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), which comprise the statements of net assets available for benefits as of January 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended January 31, 2024, and the related notes to the financial statements.

In our opinion, the accompanying financial statements present fairly, in all material respects, the net assets available for benefits of the Plan as of January 31, 2024 and 2023, and the changes in its net assets available for benefits for the year ended January 31, 2024, in accordance with accounting principles generally accepted in the United States of America.

### Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our audit opinion.

### Emphasis of matter

As discussed in Note 1 to the financial statements, the Plan merged into the Employee Savings Plan of Winston & Strawn LLP ("Savings Plan") effective January 31, 2024. The Plan's net assets were transferred to the Savings Plan as a result of the merger. Our opinion is not modified with respect to this matter.

### Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for one year after the date that the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the Plan, and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

### **Auditor's Responsibilities for the Audit of the Financial Statements**

Our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. ## NOTES TO FINANCIAL STATEMENTS

### AS OF JANUARY 31, 2024 AND 2023, AND FOR THE YEAR ENDED JANUARY 31, 2024

---

#### 1. DESCRIPTION OF THE PLANS

The Winston & Strawn LLP Retirement Plan (the “Plan”) was established effective February 1, 1968, and is a defined contribution plan subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (“ERISA”). The following description of the Plan provides only general information. Participants should refer to the Plan document for more specific information. Effective January 31, 2024, the Plan was merged into the Employee Savings Plan of Winston & Strawn LLP (the “Savings Plan”). The Plan’s net assets available for benefits totaling \$494,455,820 were transferred to the Savings Plan. The transferred net assets include partnership contributions receivable owed to the Plan, on behalf of the Plan’s participants as of January 31, 2024 totaling \$25,889,410.

**General**—The Plan sponsor is Winston & Strawn LLP, a Delaware limited liability partnership (the “Partnership”). The Winston & Strawn LLP Retirement Plans Committee is the Plan administrator and consists of partners of the Partnership who are appointed by the Executive Committee of the Partnership. Fidelity Management Trust Company (“Fidelity” or “Trustee”) is the custodian and trustee of the Plan’s assets and is the recordkeeper. A “Plan Year” covers the 12-month period commencing on February 1 and ending on the following January 31.

**Eligibility and Vesting**—Partners and administrative staff members of the Partnership who were U.S. citizens and certain partners in the Paris office are eligible to participate in the Plan upon his or her date of hire. Other partners outside the U.S. offices who are not U.S. citizens are not eligible to participate in the Plan.

Participants are 100% vested immediately upon entry into the Plan.

**Contributions**—Contributions are made solely by the Partnership. The Partnership makes a contribution each Plan Year, out of its net income, on behalf of each participant who is employed on January 31 of that year. Contributions are recorded when earned. For Plan Year 2024, the contribution made on behalf of each eligible participant was 9.8% of compensation up to \$75,000, plus 13.980392% of any compensation in excess of \$75,000. The maximum Partnership contribution per participant was \$43,000. For purposes of calculating each participant’s contribution, compensation for Plan Year 2024 was limited to \$330,000.

**Rollover Contributions**—As of October 1, 2013, rollover contributions are not permitted in the Plan.

**Participant Accounts**—An individual account is maintained for each participant of the Plan. Participants direct the investment of Partnership’s contributions into various options offered by the Plan and in the self-directed brokerage account option. Participants may transact on a daily basis within an option.

Participant accounts are credited with the contributions, transfers, and withdrawals made and reflect allocations of investment gains or losses and expenses through changes in the value of the investments in their account. Dividends and capital gain distributions earned on investments are automatically reinvested.

The benefit to which each participant is entitled is the value of the benefit that can be provided from that participant's account.

**Notes Receivable from Participants**—A participant may apply for a loan for any purpose other than the purchase of publicly traded securities. Loan terms range from one to five years. As of January 31, 2023, participant loans had maturities through 2028 at interest rates ranging from 4.25% to 8.5%. The loans are secured by the balances in the participants' accounts. Other details of the Plan's loan provision include the following:

- a. There is a limit of one new loan each Plan Year.
- b. The minimum amount of a loan is \$1,000.
- c. The amount of the loan at origination date, when added to the participant's then-outstanding loan balance(s) under the Plan, may not exceed 50% of the value of the participant's Plan account balance.
- d. The amount of the loan at origination date, when added to the participant's then-outstanding loan balance(s) under the Plan and the Savings Plan, if applicable, may not exceed \$50,000, reduced by the highest outstanding balance of the participant's combined loans from the Plan and the Savings Plan during the one-year period ending on the day before which such loan is to be made.
- e. For each loan, a participant's account is charged a loan origination fee of \$35, plus a quarterly maintenance fee of \$3.75.
- f. The interest rate charged for a loan that originated within the Plan is equal to the current prime rate, plus one percentage point, as determined at the time the loan is made. Principal and interest are paid ratably through payroll deductions.

**Payment of Benefits**—Under the terms of the Plan, a participant may withdraw all or a portion of his or her account balance upon retirement or other separation from service. A participant may also elect to receive a portion of his or her account balance in connection with an in-service withdrawal if the participant has reached age 59 1/2 or is younger than 59 1/2, but has completed at least five years of participation in the Plan. A participant may elect to receive any withdrawal in partial payments, as a lump-sum payment, or as a direct transfer to an eligible retirement plan or IRA.

## 2. SUMMARY OF ACCOUNTING POLICIES

**Basis of Accounting**—The accompanying financial statements have been prepared in accordance with accounting principles generally accepted in the United States of America ("GAAP").

**Use of Estimates**—The preparation of financial statements in conformity with GAAP requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities, and changes therein and the disclosures of contingent assets and liabilities. Actual results could differ from those estimates.

**Risks and Uncertainties**—The Plan utilizes various investment instruments through the Winston & Strawn LLP Retirement Plans Master Trust (the "Master Trust"). Investment securities, in general, are exposed to various risks, such as interest rate, credit, and overall market volatility. Market risks include global events which could impact the value of investment securities, such as a pandemic or international conflict. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term and

that such changes could materially affect the participant account balances and the amounts reported in the financial statements.

**Investment Valuation and Income Recognition**—The Plan’s interest in the Master Trust is stated at fair value. Fair value of the underlying financial instruments is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on an accrual basis. Dividends are recorded on the ex-dividend date. Net investment income from interest in the Master Trust includes the Master Trust’s gains and losses on investments bought and sold, as well as held during the year.

Management fees and operating expenses charged to the Master Trust for investments are deducted from income earned on a daily basis and are not separately reflected. Consequently, management fees and operating expenses are reflected as a reduction in investment return for such investments.

**Notes Receivable from Participants**—Notes receivable from participants are measured at their unpaid principal balance, plus any accrued but unpaid interest. Delinquent participant loans are recorded as distributions based on the terms of the Plan document.

**Administrative Revenue (Expenses)**—The Partnership pays all administrative expenses related to the Plan. Transaction fees charged by Fidelity for benefit distributions and loans are deducted from participants’ accounts. Transaction fees related to assets held in the self-directed brokerage or participant accounts are reflected as a reduction of return of those assets. The Plan has a revenue-sharing agreement whereby certain investment managers return a portion of the investment fees to the recordkeeper to offset the Plan’s administrative expenses. Future Plan expenses can be paid from any excess remaining revenue sharing amounts.

**Payment of Benefits**—Benefit payments to participants are recorded upon distribution. There are no amounts allocated to accounts of persons who had elected to withdraw from the Plan, but had not yet been paid as of January 31, 2024 and 2023.

### **3. INTEREST IN MASTER TRUST**

The Plan’s investment assets are held in the Master Trust that was established for the investment assets of the Plan and the Savings Plan. Prior to January 31, 2024, each participating plan had a divided interest in the Master Trust based upon the underlying participant account balances in each plan. As a result of the merger, effective January 31, 2024, the Savings Plan held a 100% interest in the assets of the Master Trust. The investment income for the year ended January 31, 2024 was allocated based on Plan’s interest in the Master trust during the year.

#### 4. FAIR VALUE MEASUREMENTS

FASB Accounting Standards Codification (“ASC”) 820, *Fair Value Measurements and Disclosures*, establishes a single authoritative definition of fair value, sets a framework for measuring fair value, and requires disclosures about fair value measurements. In accordance with ASC 820, the Plan classifies its investments into a fair value hierarchy that prioritizes inputs to valuation techniques used to measure fair value, as follows: Level 1 refers to securities valued using unadjusted quoted prices from active markets for identical assets; Level 2 refers to securities not traded on an active market, but for which observable market inputs are readily available; and Level 3 refers to securities valued based on significant unobservable inputs. Assets and liabilities are classified in their entirety based on the lowest level of input that is significant to the fair value measurement. The Master trust had no Level 3 investments as of January 31, 2024 and 2023.

**Mutual Funds**—Shares of mutual funds are valued at quoted market prices that represent the net asset value (“NAV”) of shares held at plan year-end. The mutual funds held by the Plan are deemed to be actively traded.

**Self-Directed Brokerage Account**—Investments entered into through Fidelity BrokerageLink (self-directed brokerage account) are primarily stated at quoted market prices reported in the active market in which the individual security is traded or valued using pricing models maximizing the use of observable inputs for similar securities. Participants have the option to invest in a variety of individual common and preferred stocks, mutual funds, U.S. government securities, corporate debt, and interest-bearing cash.

#### **Common Collective Trust Funds (“CCT Funds”):**

**Collective Trust Fund**—The collective trust fund is valued at the net asset value of units of a bank collective trust. The net asset value as provided by the trustee is used as a practical expedient to estimate fair value. The net asset value is based on the fair value of the underlying investments held by

the fund less its liabilities. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported net asset value. Participant transactions (purchases and sales) may occur daily. Were the Plan to initiate a full redemption of the collective trust, the investment advisor reserves the right to temporarily delay withdrawal from the trust in order to confirm that securities liquidations will be carried out in an orderly business manner.

**Stable Value Fund**—The stable value fund (“SV Fund”) is composed primarily of fully benefit-responsive investment contracts that are valued at the net asset value of units of the bank collective trust. The net asset value is used as a practical expedient to estimate fair value. This practical expedient would not be used if it is determined to be probable that the fund will sell the investment for an amount different from the reported net asset value. Participant transactions (purchases and sales) may occur daily. If the Plan initiates a full redemption of the collective trust, the issuer reserves the right to require 12 months’ notification in order to confirm that securities liquidations will be carried out in an orderly business manner.

**Transfer Between Levels**—The availability of observable market data is monitored to assess the appropriate classification of financial instruments within the fair value hierarchy. Changes in economic conditions or model-based valuation techniques may require the transfer of financial instruments from one fair value level to another. In such instances, transfers are reported at the beginning of the reporting period.

The significance of transfers between levels is evaluated based upon the nature of the financial instrument and size of the transfer relative to total net assets available for benefits. For the years ended January 31, 2024 and 2023, there were no transfers between levels.

**5. SV FUND**

The SV Fund is a collective trust fund sponsored by Fidelity. The beneficial interest of each participant is represented by units. Units are issued and redeemed daily at the SV Fund’s constant NAV of \$1 per unit. Distribution to the SV Fund’s unitholders is declared daily from the net investment income and automatically reinvested in the SV Fund on a monthly basis, when paid. It is the policy of the SV Fund to use its best efforts to maintain a stable NAV of \$1 per unit, although there is no guarantee that the SV Fund will be able to maintain this value.

**6. RELATED PARTY TRANSACTIONS AND EXEMPT PARTY-IN-INTEREST TRANSACTIONS**

As Fidelity is a service provider of the Plan, transactions in the investments managed by Fidelity affiliates qualify as exempt party-in-interest transactions. In addition, the Plan document provides for secured participant loans, which also qualify as party-in-interest transactions. Fees paid by the Plan for the investment management services are included as a reduction of the return on each investment. Administrative revenues arise when investment managers return a portion of the investment fees to the trustee to offset the administrative expenses. Any excess resulting from this revenue sharing remains in an unallocated account from which future Plan expenses can be paid.

**7. PLAN TERMINATION**

Although it has not expressed any intent to do so, the Partnership has the right, as stated in the Plan document, to terminate the Plan at any time, subject to the provisions of ERISA.

**8. FEDERAL INCOME TAX STATUS**

The Plan obtained its latest determination letter dated August 17, 2017, in which the Internal Revenue Service (“IRS”) stated that the Plan and related trust, as then designed, were in compliance with the applicable requirements of the Internal Revenue Code (“IRC”). In December 2016, the IRS began publishing a Required Amendments List for individually designed plans which specifies changes in qualification requirements. The list is published annually and requires plans to be amended for each item on the list, as applicable, to retain its tax-exempt status. The Plan administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC, and the Plan and related trust continue to be tax exempt. Therefore, no provision for income taxes has been included in these financial statements.

**9. SUBSEQUENT EVENTS**

Management has evaluated subsequent events through November 15, 2024, the date the financial statements were available to be issued, and concluded that no subsequent events have occurred that would require recognition or additional disclosure.
