## **Notes to Financial Statements**

### **Note 1 – Description of Plan**

The following description of the Tasks Unlimited Health & Welfare Benefit Plan (the Plan) provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

#### **General**

The Plan provides fully insured health and other benefits to substantially all full-time active employees of several employers that participate in the Plan (the Sponsors).

#### **Benefits**

The Plan provides health benefits (medical, prescription drugs, dental, and vision), disability benefits, and life insurance coverage to full-time employees of the Sponsors and to their beneficiaries and covered dependents.

Staff Benefits Management and Administrators (SBMA) provides medical and prescription drug benefits under a self-insured group insurance contract. MetLife provides dental benefits under a group insurance contract. Short-term disability, long-term disability, life, and other related benefits are administered by Basic Life and AD&D.

#### **Contributions**

Sponsors contribute specific amounts, determined by them based on a prevailing wage fringe amount ranging from \$0.056 to \$6.84 per hour worked up to a max of 40 hours per week, and the employees contribute the balance of insurance premiums and other expenses as needed. If a deficit should occur each employee would be responsible for their respective portion of the obligation.

#### **Eligibility and Vesting**

Participants are eligible for benefits based on each Sponsor's requirements. Eligibility is based on participants working an average of 30 hours a week to receive medical coverage and participants working an average of 20 hours a week for all other coverage except medical. As such there is no vesting period. Exempt employees include union employees and those covered by other plans.

#### **Administrative Expenses**

A portion of the administrative expenses of the Plan are paid by the Sponsors.

### **Note 2 – Summary of Significant Accounting Policies**

#### **Basis of Accounting**

The Plan's financial statements are presented on the accrual basis of accounting.

#### **Cash**

Cash equivalents are generally comprised of certain highly liquid investments with maturities of three months or less at the date of purchase.

#### **Use of Estimates**

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Actual results could differ from those estimates.

### **Notes to Financial Statements**

#### **Concentrations of Credit Risk**

The Plan's financial instruments that may be exposed to concentrations of credit risk consist primarily of temporary cash investments.

The Plan maintains its cash balances at a financial institution. At times such investments may exceed federally insured limits. The Plan has not experienced any losses in such accounts. The Plan believes it is not exposed to any significant credit risk on cash.

#### **Subsequent Events**

The plan administrator has evaluated subsequent events through November 15, 2024, which is also the date the financial statements were available to be issued. No subsequent events were noted during this evaluation that require recognition or disclosure in these financial statements.

#### **Note 3 – Plan Termination**

Although it has not expressed any intent to do so, the plan administrator may terminate the Plan by sending written notice to the Trustees. Once the Plan has determined to terminate, the insurance contracts would be terminated and benefits would stop in accordance with the written notice. All additional payments or assets submitted by Sponsors would be returned to each sponsor in the amount of excess contributions or assets left over by the Plan at the termination date.

#### **Note 4 – Income Tax Status**

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the plan has taken an uncertain position that more likely than not would not be sustained upon examinations by the IRS. The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of January 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.
