We offer the following as reasonable cause to abate any and all penalties plus interest on the above-mentioned Form 5500-SF (2023) for late filing:

Dr. Garfinkel required emergency surgery to repair the of right side pf the carotid artery. He was diagnosed as 90% occluded on October 7.

He was told to minimize any and all stress until a surgeon was located. A surgeon was located to do the procedure, but his first available appointment was October 23, 2024, at which time emergency surgery was performed and has only recently returned to work on a full-time basis.

We believe the above qualifies as "reasonable cause".
