NOTES TO FINANCIAL STATEMENTS

(1) Description of plan

The following description of Aspekt Solutions 401(k) and Profit Sharing Plan (the "Plan") provides only general information. Participants should refer to the Basic Plan Document and Adoption Agreement or Summary Plan Description for a more complete description of the Plan's provisions, which are available from the plan administrator.

General - The Plan is a defined contribution plan sponsored by Medical Physics Holdings LLC and Associates in Medical Physics LLC (collectively, the "Company" or "plan sponsor") for the benefit of its full-time nonunion employees who are age 21 or older and have completed three months of service, as defined. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA").

Plan transfer - During the year ended December 31, 2023, the Company was acquired by a third party. Effective December 31, 2023, the Plan was amended to freeze the Plan, and no further contributions were made to the Plan during the period from January 1, 2024 through April 22, 2024, other than with respect to the repayment of any participant loans outstanding. On April 22, 2024, participant accounts totaling \$22,402,111 were transferred from the Plan to another plan, which is included in Plan Transfer on the statements of changes in net assets available for benefits.

Contributions - Employees who are eligible to participate in the Plan may elect to defer, through payroll deductions, up to 90% of their eligible compensation, limited to the maximum dollar amount allowable by law through both pre-tax or post-tax (Roth) contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans (rollover). Additionally, participants aged 50 or older who are making contributions to the Plan are allowed to make catch-up contributions as defined in the Plan.

The Company may make safe harbor contributions. For the year ended December 31, 2023, the Company contributed 3% of eligible compensation to each eligible participant as a safe harbor contribution.

Contributions are subject to certain Internal Revenue Code ("IRC") limitations.

Participant investment account options - Participants direct the investment of all contributions into various investment options offered by the Plan. The Plan currently offers mutual funds and a common/collective trust fund as investment options for participants.

Participant accounts - Each participant's account is credited with the participant's contribution and allocations of the Company's contributions and Plan earnings and is charged with an allocation of administrative expenses. Allocations are based on participants' compensation, participant contributions, or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting - Participant and Company safe harbor contributions, and actual earnings thereon, are fully vested immediately. The Company's discretionary nonelective contributions, if any, are subject to a 2-year cliff vesting period.

Notes receivable from participants - Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balances. The loans are secured by the balance in the participant's account and bear interest at rates that are commensurate with local prevailing rates as determined by the plan administrator. Principal and interest are paid ratably through payroll deductions.

(1) Description of plan (continued)

Payment of benefits - On termination of service due to death, disability, or retirement, a participant or their beneficiary(ies) may elect to receive a lump sum amount or regular installment payments equal to the value of the participant's vested interest in their account. For termination of service due to other reasons, a participant may receive the value of the vested interest in their account as a lump sum distribution.

Forfeited accounts - As of April 22, 2024, December 31, 2023, and December 31, 2022, forfeited nonvested accounts totaled \$0, \$12,455, and \$12,261, respectively. These accounts may be used to pay administrative expenses or reduce future Company contributions. There were no usages of forfeited nonvested accounts during the period from January 1, 2024 through April 22, 2024 and for the year ended December 31, 2023. On April 22, 2024, forfeited nonvested accounts totaling \$12,532 were transferred from the Plan to another plan, which is included in Plan Transfer on the statements of changes in net assets available for benefits.

(2) Summary of significant accounting policies

Basis of accounting - The financial statements of the Plan are prepared on the accrual method of accounting.

Use of estimates - The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America ("U.S. GAAP") requires management to make estimates and assumptions that affect reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Accordingly, actual results may differ from those estimates.

Investment valuation and income recognition - Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The plan administrator determines the Plan's valuation policies utilizing information provided by the investment trustee. See Note 4 for discussion of fair value measurements.

Purchases and sales of investments are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation in fair value of investments includes the Plan's gains and losses on investments bought and sold, as well as held during the year.

Contributions - Contributions from Plan participants and the safe harbor contributions from the Company are recorded in the year in which the employee contributions are withheld from compensation.

Notes receivable from participants - Notes receivable from participants are measured at their unpaid principal balance plus accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of April 22, 2024, December 31, 2023, and December 31, 2022. If a participant ceases to make loan repayments and the plan administrator deems the loan to be in default, the participant's loan balance is reduced, and a benefit payment is recorded.

Payment of benefits - Benefits are recorded when paid.

Administrative expenses - Certain expenses of the Plan are paid by the Company and are not included in the statements of changes in net assets available for benefits. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment-related expenses are included in net appreciation in fair value of investments.

(3) Information prepared and certified by the trustee

Certain information related to investments and notes receivable disclosed in the accompanying financial statements and ERISA-required supplemental schedules, including investments at fair value and notes receivable from participants as of April 22, 2024, December 31, 2023, and December 31, 2022, and net appreciation in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the period from January 1, 2024 through April 22, 2024 and for the year ended December 31, 2023, was obtained by management and agreed to or derived from information certified as complete and accurate by Fidelity Management Trust Company (the trustee of the Plan).

(4) Fair value measurements

The Financial Accounting Standards Board (“FASB”) Accounting Standards Codification (“ASC”) Topic 820, “*Fair Value Measurements and Disclosures*,” provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under FASB ASC Topic 820 are described below:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 Inputs to the valuation methodology include: quoted prices for similar assets and liabilities in active markets; quoted prices for identical or similar assets and liabilities in inactive markets; inputs other than quoted market prices that are observable for the asset or liability; and inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset’s or liability’s fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following are descriptions of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used as of April 22, 2024, December 31, 2023, and December 31, 2022:

Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-ended mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily Net Asset Value (“NAV”) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Common/collective trust fund: Valued at the NAV of units of a bank collective trust. The NAV, as provided by the investment’s trustee, is used as a practical expedient to estimate fair value. Participant transactions (purchases and sales) may occur daily. Were the Plan to initiate a full redemption of the common/collective trust fund, the investment advisor reserves the right to temporarily delay withdrawal from the trust in order to ensure that securities’ liquidations will be carried out in an orderly business manner.

(5) Related-party transactions and party-in-interest transactions

Certain Plan investments are shares of mutual funds and common/collective trust funds managed by Fidelity Investments. Fidelity Investments is an affiliate of the trustee as defined by the Plan; therefore, these transactions in these investments qualify as party-in-interest transactions, which are exempt from the prohibited transaction rules of ERISA. The Plan paid certain expenses related to the Plan's operations and investment activity to various service providers. These transactions are also party-in-interest transactions. Fees incurred by the Plan for investment management services are included in net appreciation in fair value of investments. The Plan made direct payments to the trustee and various service providers of \$8,748 and \$22,649 during the period from January 1, 2024 through April 22, 2024 and for the year ended December 31, 2023, respectively.

(6) **Tax status**

The IRS has determined that the Basic Plan Document adopted by the Plan is designed in accordance with applicable sections of the IRC and informed the trustee of such in a letter dated June 30, 2020. The plan administrator believes that the Plan and related trust are currently designed and being operated in compliance with the applicable requirements of the IRC.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that “more likely than not” would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

(7) **Subsequent events**

The Plan has evaluated subsequent events through October 31, 2024, which is the date the financial statements were available to be issued.
