As a result, Stinnett & Associates 401(k) Profit Sharing Plan changed its basis of accounting from the going-concern basis of accounting used in presenting the 2021 financial statements to the liquidation basis of accounting used in presenting the 2022 financial statements. Our opinion is not modified with respect to this matter.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the plan, and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

NOTES TO FINANCIAL STATEMENTS DECEMBER 20, 2022

1. DESCRIPTION OF THE PLAN

The following description of the Plan provides only general information. Participants should refer to the *Summary Plan Description* for a more complete description of the Plan's provisions, which is available from the Plan administrator.

Plan Termination – The Board of Directors of Stinnett & Associates, the Plan Sponsor, voted in June 2022, to terminate the Plan effective July 1, 2022. Final distributions were based on all participants being 100% vested and were completed December 20, 2022. In accordance with generally accepted accounting principles, the Plan changed its basis of accounting used to value plan assets from the ongoing plan basis to the liquidation basis for the period January 1, 2022 to December 20, 2022.

CBIZ, Inc. acquired Stinnett & Associates effective July 1, 2022. Participants were given the option to transfer their balances to CBIZ, Inc. Retirement Savings Plan in 2022.

General – The Plan is a defined contribution plan in which eligible employees of Stinnett & Associates (the “Company”) may participate. To participate, employees are enrolled on their first day of employment and to remain in the plan in subsequent years are required to earn at least 1,000 hours of service during the plan year. There are no age requirements to participate. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Contributions – The Company will match, on a discretionary basis, 50% of the salary deferrals up to 7% of compensation. Additional amounts may be contributed at the discretion of the Board of Directors. Participants are required to be employed on the last day of the plan year in order to receive the Company match. Participants can elect to contribute up to 100% of their compensation or \$20,500 for 2022. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions currently at \$6,500 for the 2022 Plan year. Participants direct the investment of their contributions as well as the Company's contributions in various investment options offered by the Plan.

Participant Accounts – Each participant's account is credited with the participant's contribution, the Company's contribution and plan earnings. The benefits to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting – Effective with the Plan's termination on December 20, 2022, participants became fully vested in their accounts.

Participant Loans – Participant loans were not allowed under the terms of the Plan.

Investment Options – Upon enrollment in the Plan, a participant may direct participant deferrals and employer contributions in any of the funds offered by the Plan. Participants may change their investment options daily.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Payment of Benefits – Upon termination of service, a participant with an account valued at less than \$5,000 shall receive a lump sum distribution. For accounts exceeding \$5,000 the participant may elect to receive the distribution. In addition, if the value of the participant's vested balance does not exceed \$1,000 the distribution will automatically be rolled over to an IRA, if no election is made. Benefit payments to participants are recorded upon distribution.

Basis of Accounting – For the period of January 1, 2022 to December 20, 2022, the financial statements were prepared using the liquidation basis of accounting in accordance with accounting principles generally accepted in the United States of America (“U.S. GAAP”). For the year ended December 31, 2021, the Plan used the accrual basis of accounting in accordance with U.S. GAAP.

Investment Valuation and Income Recognition – Investments are stated at fair value. Securities traded on a national securities exchange are valued at the last reported sales price on the last business day of the Plan year. For securities for which no sale was reported on that day, the administrative committee has established a fair value based upon current trading information.

Purchases and sales of securities are recorded on a trade-date basis. Interest is recorded on the accrual basis. Dividends are recorded on the ex-dividend date.

Use of Estimates – The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities, and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Plan Tax Status – On January 1, 2019, the Plan adopted a prototype plan document which obtained its latest determination letter on June 30, 2020, in which the Internal Revenue Service stated the Plan, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code (IRC). The Plan has been amended since receiving the determination letter. However, the Plan administrator and the Plan’s tax counsel believe that the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code.

The Plan files information returns in the United States.

Risks and Uncertainties – Investment securities are exposed to various risks, such as interest rate, market and credit risk. Due to the risks associated with certain investment securities, it is at least reasonably possible that changes in the value of investment securities will occur in the near term and that such change could materially affect participants’ account balances and amounts reported in the statement of net assets available for Plan benefits.

Expenses – Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Investment related expenses are included in net appreciation (depreciation) of fair value of investments.

3. INFORMATION CERTIFIED BY FIDELITY MANAGEMENT TRUST COMPANY

The Company has elected the method of compliance as permitted by 29 CFR 2520.103-8 of the Department of Labor’s Ruled and Regulations for Reporting and Disclosure under ERISA. Accordingly, as permitted under such election, the Plan Administrator instructed the Plan’s independent auditors not to perform any auditing procedures with respect to the following information certified as complete and accurate by Fidelity Management Trust Company, the trustee and a party-in-interest as defined by ERISA, as of and for the years ending December 20, 2022 and December 31, 2021 and for the year ended December 20, 2022, except for comparing such information certified by the trustee to information included in the Plan’s financial statements and supplemental schedule. This information consists of the following:

- Investments as shown in the accompanying statements of net assets available for benefits as of December 20, 2022 and December 31, 2021.

- Net appreciation in fair value of investments and interest and dividend income as shown in the accompanying statements of changes in net assets available for benefits for the year ended December 20, 2022.

The Plan's independent auditors did not perform auditing procedures with respect to this information except for comparing such information to the related information included in the accompanying financial statements and supplemental schedule.

4. RELATED PARTY TRANSACTIONS

Fidelity Management Trust Company is the trustee for the Plan and Fidelity Investments Institutional is the recordkeeper for the Plan and, therefore, these transactions qualify as party in interest transactions.

Certain administrative fees relating to the maintenance of employee eligibility records are paid by the Company.

5. FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2021 and 2020.

Registered investment companies: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-ended mutual funds that are registered with the SEC. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

The preceding methods may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The Plan's investments are reported at fair value in the accompanying statement of net assets available for benefit. The following table sets forth by level, within the fair value hierarchy, the Plan's assets at fair value as of December 20, 2022 and December 31, 2021.
