Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

Opinion

Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for one year after the date that the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments; administering the plan; and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

NOTE 1 – DESCRIPTION OF PLAN

The following description of the Avionos, LLC 401(k) Plan provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General

The Plan was formed October 1, 2019 and was most recently restated on August 4, 2021. The Plan was a qualified defined contribution plan covering all full-time employees of Avionos, LLC ("the Company"), who had reached 21 years of age. The Plan auto-enrolled employees with pretax deferrals of 3% on the first day of the next month following their date of hire. The Plan excluded non-resident aliens, and part-time or seasonal employees from participating. The Plan was subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA").

Contributions

Participants could contribute up to the maximum dollar amount allowable as established by the Internal Revenue Service ("IRS"), as defined in the Plan. Participants who had attained age 50 before the end of the plan year were eligible to make catch-up contributions. Participants could also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans. Participants directed the investment of their contributions into various investment options offered by the Plan. The Plan offered investment options through Empower Annuity Insurance Company of America and Empower Trust Company, LLC, the custodians of the Plan's investments, that included a group annuity contract and mutual funds through various registered investment companies.

The Plan allowed for discretionary employer matching contributions. The Company did not make matching contributions to the Plan for the period from January 1, 2024 to February 2, 2024. The Company made matching contributions of \$321,862 to the Plan for the year ended December 31, 2023.

Participant Accounts

Each participant's account was credited with the participant's contributions; qualified rollover contributions; allocations of the Company's contributions, if any; Plan earnings or losses; and charged with an allocation of administrative expenses. Allocations were based upon participant earnings or account balances, as defined by the Plan. That benefit to which a participant was entitled was the benefit that could be provided from the participant's vested account.

Vesting

Participants were immediately 100% vested in their deferral contributions plus actual earnings or losses thereon. Vesting in the employer's discretionary matching contributions, plus actual earnings or losses thereon, was based upon years of continuous service as defined in the Plan document. A participant became 50% vested after two years of service and 100% vested after three years of service. A participant would also immediately become fully vested in the event of death or normal retirement at age 65.

Notes Receivable from Participants

Participants could borrow from their fund accounts a minimum of \$1,000 up to a maximum that was equal to the lesser of \$50,000, or 50% of their vested account balances. Principal and interest were paid ratably through regular payroll deductions. Loan terms ranged from 1 to 5 years for general purpose loans, or up to 15 years for a principal residence loan. The loans were secured by the participant's vested account balance and bore interest at the prime rate plus 1% on the date of issuance. There were no outstanding loans at February 2, 2024. Interest rates for outstanding loans at December 31, 2023 ranged from 4.25% to 7.25%.

Payment of Benefits

On termination of service due to death, disability, retirement, or any other reason, participants could elect to receive a lump-sum amount equal to the value of their vested account balance. In addition, hardship withdrawals of elective deferrals and in-service distributions from all contribution types were permitted once participants reached age 59 ½. The Plan document also required post-severance mandatory force-out distributions for account balances under \$5,000.

Forfeited Accounts

The Plan maintained a non-vested forfeiture account. Forfeited balances of terminated participant's non-vested accounts could be used by the Company to pay Plan expenses or used to reduce discretionary employer matching contributions. There were no forfeited non-vested accounts at February 2, 2024 and December 31, 2023. No forfeitures were used for the period from January 1, 2024 to February 2, 2024 and \$157,976 in forfeitures were used to reduce the discretionary employer matching contributions for the year ended December 31, 2023.

NOTE 2 – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The financial statements of the Plan are prepared under the accrual method of accounting.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States requires the plan administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results may differ from those estimates.

Investment Valuation and Income Recognition

The Plan's investments were reported at fair value with the exception of the fully benefit-responsive investment contract which was reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The plan administrator determined the Plan's valuation policies utilizing information provided by the custodians. See Note 4 for discussion of fair value measurements.

Investment Valuation and Income Recognition (continued)

Purchases and sales of securities were recorded on a trade-date basis. Interest income was recorded on the accrual basis. Dividends were recorded on the ex-dividend date. Net appreciation (depreciation) included the Plan's gains and losses on investments bought and sold as well as held during the year.

Management fees and operating expenses charged to the Plan for investments in mutual funds and the group annuity contract were deducted from income earned on a daily basis and not separately reflected. Consequently, management fees and operating expenses were reflected as a reduction of investment return for such investments.

Notes Receivable from Participants

Notes receivable from participants were measured at their unpaid balance plus any accrued but unpaid interest. Interest income was recorded on the accrual basis. Related fees were recorded as administrative expenses and were expensed when they were incurred. No allowance for loan losses has been recorded as of February 2, 2024 and December 31, 2023. If a participant ceased to make loan repayments and the plan administrator deemed the note receivable to be in default, the participant loan balance was reduced; and a benefit payment was recorded.

Payment of Benefits

Benefits were recorded when paid.

Administrative Expenses

Certain expenses of maintaining the Plan were paid directly by the Plan, unless otherwise paid by the Company. Expenses that were paid by the Company were excluded from these financial statements. Fees related to the administration and processing of benefit payments were charged directly to the participant's account and were included in administrative expenses. Fees related to management of investments were included as a reduction in net appreciation or an addition to net depreciation in the fair value of investments and were not reported separately. The Plan made direct payments for administrative expenses totaling \$16,050 and \$43,348 for the period from January 1, 2024 to February 2, 2024 and the year ended December 31, 2023, respectively.

Subsequent Events

Management has evaluated subsequent events through October 24, 2024, the date the financial statements were available to be issued. There were no subsequent events requiring recognition or disclosure in these financial statements.

The custodians also certified the completeness and accuracy of \$64,031 of net appreciation in fair value of investments, \$393 of interest and dividend income from mutual funds and the group annuity contract, and \$167 of interest income on notes receivable from participants, related to the aforementioned assets for the period from January 1, 2024 to February 2, 2024.

The custodians also certified the completeness and accuracy of \$879,969 of net appreciation in fair value of investments, \$143,896 of interest and dividend income from mutual funds and the group annuity contract, and \$3,152 of interest income on notes receivable from participants, related to the aforementioned assets for the year ended December 31, 2023.

NOTE 4 – FAIR VALUE MEASUREMENTS

Financial Accounting Standards Board Accounting Standards Codification 820, *Fair Value Measurements and Disclosures* (“FASB ASC 820”), provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 – Inputs to the valuation methodology include the following:

- quoted prices for similar assets or liabilities in active markets
- quoted prices for identical or similar assets or liabilities in inactive markets
- inputs other than quoted prices that are observable for the asset or liability
- inputs that are derived principally from, or corroborated by, observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the valuation methodologies used at February 2, 2024 and December 31, 2023.

Mutual Funds (Level 1): Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan were open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan were deemed to be actively traded.

The preceding method described could produce a fair value calculation that could not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believed its valuation method was appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

NOTE 5 – GROUP ANNUITY CONTRACT WITH INSURANCE COMPANY

The Plan's investments included a traditional fully benefit-responsive guaranteed investment contract with Empower Annuity Insurance Company of America ("Empower") totaling \$0 and \$10,340 at February 2, 2024 and December 31, 2023, respectively. Empower maintained the contributions in a general account. The account was credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The guaranteed investment contract issuer was contractually obligated to repay the principal and a specified interest rate that was guaranteed to the Plan. The crediting rate was based on a formula established by the contract issuer but could not be less than 1.00%. The crediting rate was reviewed on a quarterly basis for resetting. The guaranteed investment contract did not permit the insurance company to terminate the agreement prior to the scheduled maturity date.

This contract met the fully benefit-responsive investment contract criteria and therefore was reported at contract value. Contract value was the relevant measure for fully benefit-responsive investment contracts because this was the amount received by participants if they were to initiate permitted transactions under the terms of the Plan.

Contract value, as reported to the Plan by Empower, represented contributions made under the contract, plus earnings, less participant withdrawals, and administrative expenses. Participants could ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

The Plan's ability to receive amounts due was dependent on the issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations could be affected by future economic and regulatory developments.

Certain events could limit the ability of the Plan to transact at contract value with the issuer. Such events included: (1) amendments to the plan documents (including complete or partial plan termination or merger with another plan), (2) changes to the Plan’s prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the plan sponsor or other plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, or (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA, or (5) premature termination of the contract.

In addition, certain events allowed the issuer to terminate the contract with the Plan and settle at an amount different from contract value. Such events included (1) an uncured violation of the Plan’s investment guidelines, (2) a breach of material obligation under the contract, (3) a material misrepresentation, or (4) a material amendment to the agreement without the consent of the issuer.

NOTE 6 – TAX STATUS

On November 14, 2022, the IRS stated that the non-standardized pre-approved plan document adopted by the Plan, as then designed, qualified under Section 401(a) of the Internal Revenue Code (“IRC”). Although, the Plan did not receive a determination letter specific to the Plan itself, and the Plan was amended since the pre-approved plan was adopted, the plan administrator believed that the Plan was designed and was being operated in compliance with the applicable requirements of the IRC. Therefore, the plan administrator believed that the Plan was qualified and the related trust was tax-exempt.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. No assets or liabilities relative to uncertain tax positions were recorded as of February 2, 2024 and December 31, 2023. The Plan was subject to routine audits by taxing jurisdictions; however, as of February 2, 2024 and December 31, 2023, there were no audits in progress for any tax periods.

NOTE 7 – RELATED-PARTY AND PARTY-IN-INTEREST TRANSACTIONS

Certain plan investments were managed by Empower Annuity Insurance Company of America and Empower Trust Company, LLC, the custodians of the Plan; and, therefore, these transactions qualified as party-in-interest transactions under ERISA. Fees paid by the Plan for investment services were included as a reduction of the return earned on each investment.

As described in Note 2, the Company could pay certain administrative expenses relating to Plan operations. Fees paid during the year for administrative and investment services rendered by parties in interest were based on customary and reasonable rates for such services. In addition, employees of the Company provided administrative services to the Plan for which no fees were charged.

Notes receivable from participants also qualified as party-in-interest transactions under ERISA.

NOTE 8 – PLAN MERGER

On February 2, 2024, the Plan was merged into the Hero Digital, LLC 401(k) Plan and all plan assets were transferred into the Hero Digital, LLC 401(k) Plan.

NOTE 9 – RISKS AND UNCERTAINTIES

The Plan invested in various investment securities. Investment securities were exposed to a range of risks such as interest rate risk, market, and credit risks. Due to the level of risk associated with certain investment securities, it was at least reasonably possible that changes in the values of investment securities would occur in the near term and that such changes would materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

NOTE 10 – PLAN AMENDMENT

Effective May 1, 2023, the Plan was amended to credit related employer service with Integrous Marketing as service for the Plan.
