## Independent Auditors' Report

### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed an audit of the accompanying financial statements of Dental Health Associates 401(k) Profit Sharing Plan and Trust, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the Statement of Net Assets Available for Benefits - Modified Cash Basis as of October 31, 2022 and December 31, 2021, and the related Statement of Changes in Net Assets Available for Benefits - Modified Cash Basis for the period then ended October 31, 2022, and the related Notes to the Financial Statements.

Management, having determined it is permissible in the circumstances, has elected to have the audit of Dental Health Associates 401(k) Profit Sharing Plan and Trust financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audit need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained a certification from a qualified institution as of October 31, 2022 and December 31, 2021 and for the period ended October 31, 2022, stating that the certified investment information, as described in Note 4 to the financial statements, is complete and accurate.

### Opinion

In our opinion, based on our audit and on the procedures performed as described in the Auditors' Responsibilities for the Audit of the Financial Statements section, -

- the amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with the modified cash basis of accounting.

- the information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

### Basis for Opinion

We conducted our audit in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditors' Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of Dental Health Associates 401(k) Profit Sharing Plan and Trust and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audit. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

### Basis of Accounting

We draw attention to Note 3 of the financial statements, which describes the basis of accounting. The financial statements and Supplementary Schedules are prepared on the modified cash basis of accounting, which is a basis of accounting other than accounting principles generally accepted in the United States of America. Our opinion is not modified with respect to this matter.

### Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of these financial statements in accordance with the modified cash basis of accounting, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Note 1 - Plan summary

Description of plan

The following description of the Dental Health Associates 401(k) Profit Sharing Plan and Trust (the Plan) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

General

The Plan, originally established August 1, 2000, and amended April 6, 2017 and January 1, 2019, was a defined contribution plan covering all employees of Dental Health Associates (the Company) who have obtained the age of eighteen and completed three consecutive months of employment. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). Effective January 1, 2022, the Plan's management changed Trustees and adopted the ADP Defined Contribution, Non-Standardized 401(k) Profit Sharing Plan.

Contributions

Participants were permitted to make pre-tax and/or Roth elective deferrals from their compensation, subject to maximum amounts allowed by the Internal Revenue Code. Participants who have attained age 50 before the end of the Plan year were eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollovers). Participants directed the investment of their contributions into various investment options offered by the Plan. The Plan included an auto-enrollment provision whereby all newly eligible employees were automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants had their deferral rate set at 1% of eligible compensation and their contributions were invested in a designated balance fund until changed by the participant. The Company could make discretionary matching contributions as well as discretionary profit-sharing contributions. The Company did not make a discretionary contribution for the period ended October 31, 2022.

In the event of termination for reasons other than death, disability or normal retirement, balances in participant accounts were payable in a lump-sum.

Participant accounts

Each participant's account is self-directed and credited with the participant's and Company's contributions and earnings on investments. Allocations were based on participant earnings as defined. The benefit to which a participant was entitled was the benefit that can be provided from the participant's vested account.

Participant loans

New loans were not permitted beginning January 1, 2022.

Vesting

Participants were immediately vested in their contributions plus actual earnings thereon. Vesting in the Company's contribution portion of their accounts plus actual earnings thereon is based on years of service.

A participant is vested as follows:

Less than 3 years	-

A participant is 100% vested upon attaining normal retirement age.

Investment options

Upon enrollment in the Plan, a participant may direct the investment of their contributions in a variety of investments. Participants may change their investments daily.

Forfeited accounts

Forfeited non-vested accounts will be applied to reduce employer contributions. As of October 31, 2022 and December 31, 2021, there was \$0 and \$1,462, respectively, in forfeited accounts and no forfeitures used during 2022 and 2021.

Note 2 - Concentration of credit risk

The Plan maintained its cash in bank deposit accounts which were in excess of the insurance limits provided by the Federal Deposit Insurance Corporation (FDIC). At October 31, 2022 and December 31, 2021, there was approximately \$0 and \$5,080,982 of uninsured cash, respectively.

Note 3 - Summary of significant accounting policies

Basis of accounting

The financial statements and supplemental schedules of the Plan are presented on the modified cash basis of accounting. Under this method, contributions, interest and dividend income are recorded as received. Benefits and expenses are recorded when paid. The Plan's investments are stated at fair value, determined by either quoted market prices or estimates provided by the Plan Trustee. Purchases and sales of securities are recorded on a trade-date basis.

Use of estimates

The preparation of financial statements in conformity with the modified cash basis of accounting requires the Plan Administrator to make estimates and assumptions that affect certain reported amounts of assets and liabilities and disclosures of contingent assets and liabilities at the date of the financial statements and the reported amounts of revenue and expenses during the reporting period. Accordingly, actual results may differ from those estimates.

Expenses

Certain expenses of maintaining the Plan were paid by the Sponsor and were therefore excluded from these financial statements. Fees for the administration and maintenance of a participant account balance was included in administrative expenses and charged directly to the participant's account.

Payment of benefits

Benefits were recorded when paid.

Note 4 - Information prepared and certified by the Trustee

The following information included in the accompanying financial statements and supplemental schedules were obtained from data that has been prepared and certified to as complete and accurate by the Trustee.

Note 5 - Cash in transit

The Plan's management has elected to change Trustees from Reliance Trust Company to ADP Retirement Services effective at the Plan's 2021 year end. In order to accommodate this transfer, the Reliance Trust Company's investments were liquidated into cash on December 30, 2021. ADP Retirement Services received the cash transfer on December 31, 2021. The cash in transit balance was \$5,080,982 and was valued at its par value. On January 3, 2022, ADP Retirement Services fully invested this cash balance in various investments selected by the participants.

Note 6 - Termination

On July 19, 2022, the Board of Directors of Allied Dental Practices of New Jersey, LLC permitted the plan merger of Dental Health Associates 401(k) Profit Sharing Plan and Trust into the Allied Dental Practices of New Jersey, LLC 401(k) Plan, effective as of October 1, 2022. All plan assets were merged with the Allied Dental Practices of New Jersey, LLC 401(k) Plan as of October 31, 2022. This is a reportable transaction because assets that merged with the Allied Dental Practices of New Jersey, LLC 401(k) Plan exceeded the 5% reporting rule. Accordingly, this report is the last and final report for the Plan.

Note 7 - Risks and uncertainties

The Plan provided for various investment options in registered investment companies. Investment securities were exposed to various risks, such as interest rate, market and credit.

Due to the level of risk associated with certain investment securities and the level of uncertainty related to changes in the value of investment securities, it was at least reasonably possible that changes in risks in the near-term would materially affect participants' account balances and the amounts reported in the Statements of Net Assets Available for Benefits - Modified Cash Basis and the Statement of Changes in Net Assets Available for Benefits - Modified Cash Basis.

Note 8 - Party-in-interest and related party transactions

Certain administrative functions were performed by officers or employees of the Sponsor. No such officer or employee receives compensation from the Plan. The Sponsor pays for the annual audit fee. Investment advisor fees were deducted from fund earnings prior to the allocation of investment returns. Administrative fees paid during the period ended October 31, 2022, were \$30,322.

These transactions are considered to be related party transactions exempt from the ERISA prohibited transactions.

Note 9 - Tax status

The Organization adopted a Non-Standardized Pre-Approved Profit Sharing/Money Purchase/CODA Plan sponsored by ADP, LLC. The Internal Revenue Service has determined and informed ADP, LLC by a favorable opinion letter dated October 6, 2020, that the Non-Standardized Pre-Approved Profit Sharing/Money Purchase/CODA Plan was designed in accordance with the applicable sections of the Internal Revenue Code. The Non-Standardized Pre-Approved Profit Sharing/Money Purchase/CODA Plan's opinion letter was being relied on by the Plan.

Accounting principles generally accepted in the United States of America require the Plan Administrator to evaluate tax positions taken by the Plan and recognize a tax liability for any uncertain tax positions that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by tax authorities; however, there are currently no audits for any tax periods in progress.

Note 10 - Reportable transaction

The Internal Revenue Service in conjunction with the Department of Labor, (DOL), requires the Plan to file a Form 5500 Annual Return/Report of Employee Benefit Plan by the last day of the seventh month following the end of the Plan year. The Plan filed an extension extending the original due date for the October 31, 2022, Plan year, to August 15, 2023. The filing requirement for this plan required the inclusion of an Independent Qualified Accountants' report or opinion, Financial Statements, Notes to the Financial Statements and Supplemental Schedules. The filing was after the passing of the extended due date.

On May 20, 2024, the Plan Administrator received a Notice of Intent to Assess a Penalty regarding Dental Health Associates 401(k) Profit Sharing Plan & Trust Annual Report from the DOL, for the year ending December 31, 2022. The reason for the rejection notice was the Plan failed to file the Plan's 2022 Form 5500 annual report filing. This audit report was not included with the Plan's original filing of the Form 5500 Annual Return/Report of Employee Benefit Plan. Failure to amend the original filing by inclusion of the Independent Qualified Accountants' report or opinion, Financial Statements, Notes to the Financial Statements and Supplemental Schedules within 45 days of the notice may cause the Plan Administrator to be assessed a civil penalty of up to \$2,670 per day from the date on which the annual report was due.

In May 2019 the Plan Sponsor Dental Health Associates was acquired by a venture capital group named Prosmile. Prosmile acquired other dental practices during the same period. One of its other acquisitions was a company named Allied Dental. Allied Dental had a 401(k) plan for its employees. In 2022 the Dental Health Associates 401(k) Profit Sharing Plan and Trust was merged into the Allied Dental Practices of New Jersey, LLC 401(k) Plan, (the Surviving Plan). The Surviving Plan was used to consolidate Prosmile's retirement benefits package.

As a result of COVID, the re-organizations, and personnel changes the Plan's conformity with ERISA regulations fell into state of non-compliance. Another matter of non-compliance was the Plan's failure of the ADP non discrimination testing. The regulations require corrective distributions from the plan be returned to highly compensated employees, within two and a half months after of the following year. Those distributions did not occur.

Under current regulations because of the passing of time the original excess distributions of the highly compensated totaling \$77,033 plus earnings of \$12,395 for a total correcting distribution of \$89,428 needs to be returned by the Plan to the highly compensated employees. Since the assets have been fully transferred to the Surviving Plan, the distribution will be made from the Surviving Plan.

Note 10 - Reportable transaction (continued)

As a penalty for not correcting the excess distributions on a timely basis, the Sponsoring Employer is required to contribute a Qualified Non-Elective Contribution, (QNEC) equal to the amount of correcting distribution, into the accounts of the non-highly compensated employees. That amount is \$89,428. Since the Plan has been dissolved the QNEC will be made to the Surviving Plan.

As a penalty for not correcting the excess distributions on a timely basis, the Sponsoring Employer is required to pay an excise tax equal to 10% of the excess distributions

Management has made the representation that the distributions, the QNEC, and the excise tax will be paid by the end of 2024.

Note 11 - Subsequent events

The Notice of Intent to Assess a Penalty dated May 20, 2024, was superseded by a Notice of Determination on Statement of Reasonable Cause dated September 23, 2024. The notice contained an updated assessed penalty for the failure to file the Plan's 2022 Form 5500 annual report filing. The Plan Administration must pay a \$195,000 penalty if the Plan Administration chooses not to contest the penalty determination.

The Plan's management has determined that no additional material events or transactions occurred subsequent to October 31, 2022 and through October 24, 2024, the date of the Plan's financial statement issuance, which require additional disclosure in the Plan's financial statements.
