**Note 1 - Plan Description**

The following description of Aviation Inflatables, LLC (the "Plan") provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

***General***

Effective January 1, 2024, Aviation Inflatables, LLC was merged into the TPC Qualified Plans LLC Retirement Savings Plan as sponsored by First Class Air Support, LLC. Effective January 1, 2024, assets and participant accounts totaling \$1,155,969 were transferred out Aviation Inflatables, LLC into the TPC Qualified Plans LLC Retirement Savings Plan as sponsored by First Class Air Support, LLC.

The Plan is a defined contribution plan covering substantially all employees of Aviation Inflatables, LLC and Survival Products, LLC (collectively, the "Company") who have completed three months of service. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

***Contributions***

The Plan provides for employee salary deferral contributions up to a maximum of 80 percent of annual compensation subject to maximum tax-deferred limitations established by the Internal Revenue Code. Participants may also make contributions to the Plan in the form of a rollover of funds from another qualified plan.

Certain participant contributions in 2023 were paid after the time frame required by the Department of Labor. The Company remitted a portion of these contributions during 2023 and expect to remit the remaining contributions and related lost earnings to the Plan in 2024.

The Plan provides for employer matching contributions of 100 percent of the participant's contribution, not to exceed 2 percent of the employee's deferred compensation.

***Participant Notes Receivable***

Participants may borrow from their accounts subject to certain maximum and minimum amounts prescribed in the Plan and in the Internal Revenue Code. Notes receivable bear interest at a market rate.

***Participant Accounts***

Each participant's account is credited with the participant's contributions and allocations of the Company's contributions and plan earnings and charged with an allocation of administrative expenses. Allocations are based on participants' compensation or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. Participants may direct the investments of their account balances into various investment options offered by the Plan.

***Vesting***

Participants' employee salary and rollover contributions, the employer match contributions, and the employer discretionary contributions and related earnings are fully vested at all times and are not subject to forfeiture for any reason.

***Benefit Payments***

Distributions are payable upon retirement, death, disability, termination of employment, or attainment of 59½ years of age in the form of a lump-sum amount equal to the vested balance of a participant's account.

***Forfeitures***

If a participant is not fully vested on his or her termination date, the nonvested amount of the account is forfeited. Forfeitures are used to reduce future company contributions or to pay administrative expenses of the Plan.

**Note 1 - Plan Description (Continued)**

***Party-in-interest Transactions***

The Plan provides for loans to participants, which are party-in-interest transactions that are exempt from the prohibited transaction rules.

***Termination***

The Company had the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions set forth in the plan agreement and ERISA. Effective January 1, 2024, Aviation Inflatables, LLC was merged into the TPC Qualified Plans LLC Retirement Savings Plan as sponsored by First Class Air Support, LLC.

**Note 2 - Summary of Significant Accounting Policies**

***Investment Valuation***

The Plan's investments are stated at fair value.

The common/collective trust fund is valued at net asset value per share (NAV) (or its equivalent) of the fund, which is based on the fair value of the fund's underlying net assets. There are no redemption restrictions or unfunded commitments on this investment. All other investments are valued based on quoted market prices reported in active markets. See Note 5 for additional information.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded as earned. Dividends are recorded on the ex-dividend date.

***Participant Notes Receivable***

Participant notes receivable are recorded at their unpaid principal balances plus any accrued interest. Participant notes receivable are written off when deemed uncollectible.

***Benefit Payments***

Benefits are recorded when paid.

***Administrative Expenses***

Various administrative costs are paid by the Company.

***Use of Estimates***

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of additions and deductions during the reporting period. Actual results could differ from those estimates.

***Risks and Uncertainties***

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the financial statements.

***Subsequent Events***

The financial statements and related disclosures include evaluation of events up through and including November 11, 2024, which is the date the financial statements were available to be issued.

### Note 3 - Certified Information

Reliance Trust Company (the "Trustee") held the Plan's investments and participant notes receivable and executed all related transactions. As of December 31, 2023 and 2022 and for the year ended December 31, 2023, the investment and participant notes receivable balances and related income and losses included in the accompanying financial statements and supplemental schedule of assets held at end of year are based solely on information certified by the Trustee.

### Note 4 - Tax Status

The Plan was a preapproved plan. The preapproved plan had received a favorable opinion letter from the Internal Revenue Service indicating that the Plan, as designed, was qualified for federal income tax-exempt status. The Plan had not individually sought its own determination letter.

### Note 5 - Fair Value Measurements

Accounting standards require certain assets and liabilities be reported at fair value in the financial statements and provide a framework for establishing that fair value. The framework for determining fair value is based on a hierarchy that prioritizes the valuation techniques and inputs used to measure fair value.

#### Level 1

Fair values determined by Level 1 inputs use quoted prices in active markets for identical assets that the Plan has the ability to access.

#### Level 2

Fair values determined by Level 2 inputs use other inputs that are observable, either directly or indirectly. These Level 2 inputs include quoted prices for similar assets in active markets, quoted prices for identical or similar assets in markets that are not active, and inputs other than quoted prices that are observable for the asset.

#### Level 3

Level 3 inputs are unobservable inputs, including inputs that are available in situations where there is little, if any, market activity for the related asset.

In instances where inputs used to measure fair value fall into different levels of the fair value hierarchy, fair value measurements in their entirety are categorized based on the lowest level input that is significant to the valuation. The Plan's assessment of the significance of particular inputs to these fair value measurements requires judgment and considers factors specific to each asset.
