Note 1. Description of the Plan

The following description of the Search Discovery Services LLC 401(k) Plan, (the Plan) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions, which is available from Plan management.

General

The Plan was a defined contribution plan covering all full-time employees of Search Discovery Services LLC, and its wholly owned subsidiaries (the Company) who had attained age twenty-one or older. The Plan was subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Board of Directors were responsible for oversight of the Plan. The Plan administrator determined the appropriateness of the Plan's investment offerings, monitored investment performance and reported to the Plan's Board of Directors.

Effective January 1, 2024, the Search Discovery Services LLC 401(k) Plan was merged into the Momentum 401(k) Plan. As a result of this merger, the participant accounts were transferred out of the Plan and into the Momentum 401(k) Plan by January 11, 2024.

Contributions

Each year, participants could contribute up to 100 percent of pretax annual compensation, as defined in the Plan. Participants who had attained age 50 before the end of the plan year were eligible to make catch-up contributions. Participants could also designate some of their contributions as after tax contributions to a Roth 401(k) option. Participants could also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover). Participants directed the investment of their contributions into various investment options offered by the Plan. The Plan included an auto-enrollment provision whereby all newly eligible employees were automatically enrolled in the Plan unless they affirmatively elected not to participate in the Plan. Automatically enrolled participants had their deferral rate set at 6 percent of eligible compensation, and their contributions invested in a designated balanced fund until changed by the participant. The Company contributed 100 percent of over the first one percent and 50 percent of elective deferral contributions which were over one percent but were not over six percent of eligible compensation that a participant contributed to the Plan. This contribution was intended to satisfy a safe harbor contribution formula permitted by Internal Revenue Service (IRS) regulations. By making the safe harbor matching contribution, the Plan would automatically satisfy the nondiscrimination requirements that otherwise would apply to 401(k) contributions made by the Plan. The matching Company contribution was invested as directed by the participant. The Company could also authorize additional discretionary employer contributions to the Plan for the related year. The Company did not make additional discretionary employer contributions for 2024 or 2023. Contributions were subject to certain Internal Revenue Service (IRS) limitations.

Participant Accounts

Each participant's account was credited with the participant's contribution and allocations of (a) the Company's contribution and (b) Plan earnings. Participant accounts were charged with an allocation of administrative expenses. Allocations were based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant was entitled was the benefit that could be provided from the participant's vested account.

Vesting

Participants were vested immediately in their contributions plus actual earnings thereon. Vesting in the Company's safe harbor matching contribution and discretionary employer contribution portion of their accounts was based on years of continuous service. A participant was 100 percent vested after two years and five years of credited service in the safe harbor matching contribution and discretionary employer contribution portion, respectively.

Notes Receivable from Participants

Participants could borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% percent of their vested account balance. The loans were secured by the balance in the participant's account bearing interest at rates commensurate with local prevailing rates as determined by Plan management. Principal and interest was paid ratably through payroll deductions.

Payment of Benefits

Upon separation of service due to death, disability, retirement or termination of employment, a participant could elect to receive either a lump sum amount equal to the value of the participant's vested interest in his or her account, or annual installments.

Forfeited Accounts

At January 11, 2024 and December 31, 2023, forfeited nonvested accounts totaled \$0 and \$1,662, respectively. These accounts would be used to reduce future Company contributions and to pay Plan expenses. During 2024 and 2023, Company contributions were reduced by \$0 and \$94,101, respectively, and administrative expenses of \$0 and \$28,084, respectively were paid from forfeited nonvested accounts.

Note 2. Summary of Significant Accounting Policies

Basis of Accounting

The financial statements of the Plan have been prepared using the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America (US GAAP) requires Plan management to make estimates and assumptions that affect the reported amounts of assets, liabilities and changes therein, and disclosure of contingent assets and liabilities at the date of the financial statements. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments were reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's administrator determined the Plan's valuation policies utilizing information provided by the investment advisers, custodians, and insurance company. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities were recorded on a trade-date basis. Interest income was recorded on the accrual basis. Dividends were recorded at the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Contributions

Contributions from Plan participants and the matching contributions from the Company were recorded in the year in which the employee contributions were withheld from compensation.

Notes Receivable from Participants

Notes receivable from participants were measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income was recorded on the accrual basis. Related fees were recorded as administrative expenses and were expensed when they were incurred. No allowance for credit losses has been recorded as of January 11, 2024 and December 31, 2023.

Payment of Benefits

Benefits were recorded when paid.

Expenses

Certain expenses of maintaining the Plan were paid by the Plan, unless otherwise paid by the Company. Expenses that were paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants were charged directly to the participant's account and were included in administrative expenses. Investment related expenses are included in net appreciation (depreciation) of fair value of investments.

Plan Management's Review of Subsequent Events

The Plan has evaluated subsequent events through November 15, 2024, the date the financial statements were available to be issued.

Note 3. Certified Investments

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements, including investments and notes receivable from participants held at January 11, 2024 and December 31, 2023, and net appreciation (depreciation) in fair value of investments, interest and dividends and interest income on notes receivable from participants for the period from January 1, 2024 through January 11, 2024 and year ended December 31, 2023, was obtained by management and agreed to or derived from information certified as complete and accurate by Delaware Charter Guarantee & Trust Company d/b/a Principal Trust Company (Principal), the trustee/custodian of the Plan.

Note 4. Fair Value Measurements

Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) 820, *Fair Value Measurement*, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability; and
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value.

Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Collective trust fund: Valued at the NAV of units of a bank collective trust. The NAV, as provided by the trustee, is used as a practical expedient to estimate fair value. Participant transactions (purchases and sales) may occur daily. Were the Plan to initiate a full redemption of the collective trust, the investment adviser reserves the right to temporarily delay withdrawal from the trust in order to ensure that securities liquidations will be carried out in an orderly business manner.

Note 5. Related Party Transactions and Party in Interest Transactions

Certain Plan investments were shares of mutual funds and collective trust funds provided through Principal. Principal was the record keeper and trustee for the Plan and, therefore, these transactions qualified as party in interest transactions. All investment fund earnings or losses posted to each Plan participant's account were net of investment management fees charged by each investment fund under the Plan.

Note 6. Plan Merger

Effective January 1, 2024, the Plan merged into the Momentum 401(k) Plan. Plan assets were transferred to the trustee of the Momentum 401(k) Plan by January 11, 2024.

Note 7. Tax Status

Effective January 1, 2023, the Plan adopted a nonstandardized prototype defined contribution profit sharing plan with Internal Revenue Code Section 401(k) Cash or Deferred Arrangement (CODA) which received a favorable opinion letter from the Internal Revenue Service (IRS) dated June 30, 2020. The Plan has been amended since the date of the last amendment covered by the above-mentioned determination letter. However, Plan management believes that the plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code.

US GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

To Whom It May Concern:

We are writing to provide a reasonable cause explanation for the late filing of our Form 5500 for the 2024 plan year. Our filing was delayed due to an error in classifying our plan size during the transition of plan assets..

Specifically, during the blackout period from January 1 to January 11, 2024, our plan assets were transferred to another plan. During this process, the plan was incorrectly marked as a small plan instead of a large plan. Once this error was discovered, we promptly contacted our plan administrator to rectify the classification. Additionally, we engaged with our auditor to obtain their opinion letter to ensure compliance and accuracy in our filings.

Despite our diligent efforts to correct the classification and secure the necessary documentation, these steps caused an unavoidable delay in completing and submitting the Form 5500. As soon as we resolved the issue, we promptly filed the form.

We deeply regret the late filing and have implemented measures to prevent a recurrence, including enhancing our internal review processes and communication with our plan administrator and auditor during future transitions.
