Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the plan, and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditors' Responsibilities for the Audit of the Financial Statements

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditors' report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

- Exercise professional judgment and maintain professional skepticism throughout the audit.



Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control related matters that we identified during the audits.

(1) Description of Plan

The following brief description of the TGM Associates L.P. 401(k) Plan (the Plan) is provided for general information purposes only. Participants should refer to the Plan agreement and related amendments for more complete information.

(a) General

The Plan was formed on January 1, 2000, with effective salary deferral provisions beginning on July 1, 2000, and restated effective June 27, 2023. The Plan is a defined contribution plan covering all eligible employees of TGM Associates L.P. (the Employer or Plan Sponsor). Employees are eligible to enter the Plan after they have completed two months of service and are age twenty-one or older. Temporary employees are not eligible to participate in the Plan. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (ERISA). The Plan was amended since its adoption to comply with various regulatory requirements.

Effective May 8, 2024, the Plan merged into the SuccessWise Pooled Employer Plan, and all participants of the the Plan were eligible to participate in the SuccessWise Pooled Employer Plan upon the merger date. Total assets of \$11,171,285 were merged into the SuccessWise Pooled Employer Plan on May 8, 2024.

(b) Contributions

The Plan allows eligible participants to make an elective contribution of up to 100% of their pre-tax compensation. Under the Internal Revenue Code (IRC), individual contributions for which taxes may be deferred were limited to \$23,000 and \$22,500 - in 2024 and 2023, respectively. Participants over age 50 are eligible to make pre-tax catch up contributions equal to \$7,500 in 2024 and 2023. The participants may change their percent contribution election at any time during the Plan Year. Participants may also contribute amounts representing distributions from other qualified plans. The Employer may make an annual discretionary matching contribution of \$0.50 on every \$1 contributed by the employee up to a maximum match of \$2,000 in 2024 and 2023. Such discretionary matching contributions were made by the Employer in 2024 and 2023. Under the provisions of Section 415 of the IRC, the sum of Employer contributions and employee contributions allocable to a participant is limited to the lesser of \$69,000 and \$66,000 in 2024 and 2023, respectively, or 100% of the participant's compensation.

Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover). Participants are permitted to elect to have contributions invested in any investment option offered by the Plan.

(c) Participant Accounts

Each participant's account is credited with the participant's contributions and allocations of the Employer's contributions, if any, and the investment net earnings or losses. Allocations are based on participant earnings account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

(d) Vesting

Participants are immediately vested in their voluntary contributions and earnings and losses thereon. Vesting in both the Employer’s discretionary matching contribution and the earnings and losses thereon is based on years of service of the participant. A year of service means a Plan year in which the participant completes at least 1,000 hours of service. Participants will become fully vested upon death, total and permanent disability and early retirement. The vested percentage of a participant’s account balance attributable to the Employer matching contribution and the earnings and losses thereon is determined as follows:

(e) Forfeitures

The portion of a participant’s account attributable to Employer contributions and the earnings and losses thereon, which is forfeited by the participant resulting from his or her termination of participation in the Plan, is used to offset contributions to the Plan by the Employer or to pay administrative expenses of the Plan. The amount of forfeitures available as of May 8, 2024 and December 31, 2023 was \$0 and \$7,809, respectively. The Employer used \$10,689 of forfeitures to reduce contributions to the Plan for the period January 1, 2024 through May 8, 2024.. Forfeitures totaling \$9,545 were included in the transfer to the SuccessWise Pooled Employer Plan plan on May 8, 2024.

(f) Plan Benefits and Distributions

Under the terms of the Plan, eligible participants (or their beneficiaries) are entitled to a single lump-sum benefit payment upon their (a) death (b) disability or (c) termination of service with the Employer, or they may choose to receive (1) nonperiodic installment payments, where the participant specifies the amount at each distribution date, not to exceed a ten-year period or (2) periodic installment payments payable quarterly, semi-annually or annually, not to extend beyond the participant’s life expectancy. Additionally, a participant may withdraw all or part of his/her account upon either (a) attainment of age 59-1/2 or (b) demonstration of serious financial hardship.

If a participant terminates service and the value of the Participant’s vested account balance is below a certain amount, the participant will receive a distribution of the value of the entire vested portion of such account balance and the nonvested portion will be treated as a forfeiture.

(g) Notes receivable from participants

A participant with a vested account balance in the Plan of more than \$2,000 may borrow up to 50% of his or her vested account balance, subject to a minimum amount of \$1,000 and a maximum of \$50,000. Each participant may only have one loan outstanding at any time. Loan transactions are treated as a transfer to (from) the investment fund from (to) participant loans. Generally, loans are repaid within 5 years. Loans used to acquire a principal residence may be repaid over a longer period of time. The loans are secured by the balance in the participant's account and bear interest at the prime rate of interest as published in the Wall Street Journal as of the date of the loan, plus 1%, unless otherwise determined by the trustee. Principal and interest are paid ratably through bi-weekly payroll deductions.

(h) Plan Expenses

The Plan pays certain administrative expenses relating to participant accounts. All other expenses are paid by the Employer.

(2) Summary of Significant Accounting Policies

(a) Basis of Presentation

The accompanying financial statements have been prepared under the accrual basis of accounting.

(b) Uses of Estimates

The preparation of the Plan's financial statements in conformity with U.S. generally accepted accounting principles (U.S. GAAP) requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities and changes therein, and disclosures of contingent assets and liabilities at the date of the financial statements. These estimates and assumptions are based on the Plan administrator's best estimate and judgment. The Plan administrator evaluates its estimates and assumptions on an ongoing basis using historical experience and other factors, including consideration of the current economic environment. The Plan administrator adjusts such estimates when facts and circumstances dictate. As future events and their effects cannot be determined with precision, actual results may differ from those estimates and assumptions.

(c) Investment Valuation and Income Recognition

The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See note 4, "Fair Value Measurements" for further detail on investment valuations.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date.

Investment income recorded by the Plan includes current earnings from investments, the net change in the unrealized appreciation or depreciation in investments, and any realized gains and losses on investments sold during the period.

Investment management fees, including brokerage fees and commissions on the purchase and sale of securities and other related portfolio management expenses, are paid from assets of and applied against the investment performance of the respective investments in the mutual funds.

(d) Payment of Benefits

Benefits are recorded when paid.

(e) Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of May 8, 2024, or December 31, 2023. Delinquent notes receivable are recorded as distributions on the basis of the terms of the Plan document.

(f) Risk and Uncertainties

The Plan offers a number of investment funds available for participants. The investment funds include various mutual funds and exchange traded funds. Investment securities, in general, are exposed to various risks, such as interest, credit, and overall market volatility risk. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the amounts reported in the Statements of Net Assets Available for Benefits and participant account balances.

(3) Certification of Investment Information (Unaudited)

The Plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, as permitted under such election, the investment values and notes receivable from participants and related activity as of May 1, 2024, and December 31, 2023, and for the period January 1, 2024 through May 1, 2024 were certified to as being complete and accurate by Ameritas Life Insurance Corp. (Ameritas) and not subjected to any auditing procedures performed by the independent auditors. Matrix Trust Company, custodian, has certified to the completeness and accuracy of certain investment values and related activity as of May 8, 2024, and December 31, 2023, and for the period January 1, 2024 through May 8, 2024. Notes receivable from participants as of May 8, 2024 that were transferred out were not certified.

(4) Fair Value Measurements

Fair value is defined as the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants, in the principal or most advantageous market considering the highest and best use of an asset or nonperformance risk related to a liability, at the measurement date. Fair value measurement establishes a fair value hierarchy that prioritizes observable and unobservable inputs used to measure fair value into three levels. Observable inputs are inputs that the market participants would use in pricing the asset or liability based on market data obtained from sources independent of the Plan. Unobservable inputs are inputs that reflect the Plan's assumptions about the assumptions market participants would use in pricing the asset or liability developed based on the best information available in the circumstances.

The hierarchy has three levels based on the nature of inputs:

Level 1 – quoted prices (unadjusted) in active markets that are accessible at the measurement date for assets or liabilities;

Level 2 – observable prices that are based on inputs not quoted in active markets, but corroborated by market data; and

Level 3 – unobservable inputs are used when little or no market data is available.

The fair value hierarchy gives the highest priority to Level 1 inputs and the lowest priority to Level 3 inputs. In instances where the determination of the fair value measurement is based on inputs from different levels of the fair value hierarchy, the level in the fair value hierarchy within which the entire fair value measurement falls is based on the lowest level input that is significant to the fair value measurement in its entirety.

Mutual Funds - Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-ended mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the plan are deemed to be actively traded.

Common Collective Trusts - Stated at NAV with a readily determinable fair value, based on the fair value of the funds' underlying net assets. NAV is a readily determinable fair value and is the basis for current transactions and participant transactions (purchases and sales) may occur daily.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

There were no investments at May 8, 2024, due to the transfer of assets to SuccessWise Pooled Employer Plan (see Note 1(i)).

(5) Related Party Transactions

Fees incurred by the Plan for the investment management and third party record keeping services are included in administrative expenses and net appreciation or depreciation fair value of the investment. These party-in-interest transactions are exempt from the prohibited transaction rules of ERISA.

(6) Excess Participant Contributions

The Plan failed to pass the Average Deferral Percentage (ADP) Test for the 2023 plan year. In order to remediate the failure to pass the ADP Test for 2023 Plan year, the accompanying Statements of Net Assets Available for Benefits include \$36,782 of "Excess participant contributions payable" as of December 31, 2023.

(7) Income Tax Status

The Internal Revenue Service has determined and informed the Plan Sponsor by a letter dated March 31, 2014 that the Plan is qualified and the trust established under the Plan is tax-exempt, under the appropriate sections of the IRC. The Plan has been amended since receiving the determination letter. However, the Plan administrator and the Plan's tax counsel believe that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC. Therefore, they believe that the Plan was qualified and the related trust was tax-exempt as of the financial statement date.

U.S. GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or derecognize asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of May 8, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or de-recognition of an asset) or disclosure in the financial statements.

The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. Plan management believes the Plan is no longer subject to tax examination for years prior to 2021.

(8) Subsequent Events

Management of the Plan has evaluated subsequent events through, November 15, 2024 and determined that there are no other items to disclose or record in these financial statements.
