1. DESCRIPTION OF THE PLAN

The following description of The Heathman Lodge 401(k) Plan ("Plan") provides only general information. Reference should be made to the Plan agreement for a more complete description of its provisions. The Plan is a multiple-employer plan sponsored by H Lodge, LLC with five participating employers (collectively referred to as the "Company").

GENERAL. The Plan is a defined contribution 401(k) plan covering employees of the Company and Company affiliates who have one year or more of service, have at least one thousand hours of service and who are at least twenty-one years of age. The Plan's trustee manages the operation and administration of the Plan. Fidelity Management Trust Company ("Fidelity") serves as custodian and trustee of the Plan. The Plan is subject to the Employee Retirement Income Security Act of 1974 (ERISA).

PLAN AMENDMENT. Effective June 8, 2022, the Plan was amended to spin off the employees of North Pacific Management, Inc. into the CoHo Services 401(k) Plan and to change the name of the Plan from North Pacific Management 401(k) Profit Sharing Plan to The Heathman Lodge 401(k) Plan. Prior to the spin off, the Plan sponsor was North Pacific Management, Inc.

CONTRIBUTIONS. Contributions to the Plan are in the form of salary reductions which participants have elected to defer in lieu of current compensation, and which the Company has then contributed to the Plan on behalf of participants. The Company may elect to match a discretionary percentage of employee contributions. The Company contributed 50% of the first 6% of eligible compensation that a participant contributes to the plan. The Plan has an automatic enrollment feature which automatically withholds 3% of eligible compensation from new participants and existing participants without a salary deferral arrangement in effect. Participants can elect not to defer if they choose. The Company may make additional contributions entirely at the discretion of its Board of Directors.

PARTICIPANT ACCOUNTS. Each participant's account is credited with an allocation of (a) employee elective deferrals, (b) the employer's discretionary matching contributions, as defined above, if any, (c) Plan earnings, and (d) administrative expenses paid by the plan. Item (a) is allocated based on participants' elective contributions. Items (b), (c), and (d) are allocated based on participants' elective deferrals or account balances, as defined and specified in the Plan agreement. The benefit to which a participant is entitled is based on the benefit that can be provided from the participant's vested account.

INVESTMENT OPTIONS. Upon enrollment, a participant may direct contributions to certain investment accounts offered by the Trustees. Participants may change their investment options daily.

VESTING. Participants are fully vested upon their entrance into the plan.

NOTES RECEIVABLE FROM PARTICIPANTS. Participants may borrow from their fund accounts a maximum amount equal to the lesser of \$50,000 or 50% of their vested account balance. Generally, note terms range from one to five years, are secured by the balance in the participant's account, and bear interest at a rate commensurate with the local lending market. Principal and interest are paid ratably through monthly payroll deductions.

PAYMENT OF BENEFITS. On termination of service, a participant may elect to receive a lump sum amount equal to the value of the participant's vested interest in their account, roll their account balance to another company's qualified plan or IRA, or defer distribution until a later date of their choosing (if the balance exceeds \$5,000). At December 31, 2023 and 2022, there were no amounts allocated to accounts of participants who had elected to withdraw from the Plan, but had not been paid.

1. DESCRIPTION OF THE PLAN - Continued

HARDSHIP WITHDRAWALS. Pre-retirement distributions of elective deferrals are available on a hardship basis. These distributions are limited to the specific financial need. They must be approved by the trustee and custodian on a nondiscriminatory basis.

PLAN TRUSTEE/RELATED PARTY. The trustee of the Plan is Fidelity Management Trust Company. The trustee is responsible for the custody of the Plan assets. A material portion of employee and Company contributions are invested in various money market and mutual funds maintained by an affiliate of the trustee; therefore, these transactions qualify as party-in-interest transactions. The trustee receives fees for services provided on behalf of the investment funds. Fund earnings are presented net of these fees. Plan assets invested in these funds totaled \$808,472 and \$647,797 at December 31, 2023 and 2022, respectively. A net gain of \$153,162 and a net loss of \$189,296 occurred in these funds for the years ended December 31, 2023 and 2022, respectively. The Plan utilizes the investment advisory services of Robert W. Baird & Co. Inc., and recordkeeper services of Fidelity Investments Institutional Operations Company, Inc. These fees qualify as party-in-interest transactions totaling \$14,605 and \$24,780 at December 31, 2023 and 2022, respectively.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

The Plan employs accounting policies generally accepted in the United States of America. The Financial Accounting Standards Board ("FASB") has issued guidance which establishes the FASB Accounting Standards Codification (the "Codification" or "FASB ASC") as the source of authoritative accounting principles recognized by the FASB to be applied by nongovernmental entities in the preparation of the financial statements in conformity with accounting principles generally accepted in the United States of America.

BASIS OF ACCOUNTING. The accompanying financial statements have been prepared on the accrual basis of accounting.

USE OF ESTIMATES. The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires Plan Administrators to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

VALUATION OF INVESTMENTS - MONEY MARKET FUNDS. Money market funds are valued at cost which approximates market.

VALUATION OF INVESTMENTS - MUTUAL FUNDS. Investments in mutual funds are carried at fair value, which is the net asset value per unit of each mutual fund multiplied by the number of units owned. The value of each unit is computed by the mutual fund company on the last business day of the plan year, based on quoted market prices of the underlying securities, bonds and other financial instruments owned by each fund.

INVESTMENT TRANSACTIONS. Purchases and sales of securities are recorded on the settlement date.

NOTES RECEIVABLE FROM PARTICIPANTS. Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred.

PAYMENT OF BENEFITS. Benefits are recorded when paid.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES - Continued

EXPENSES. Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation of fair value of investments.

RISKS AND UNCERTAINTIES. The Plan provides for investment options in mutual funds, which invest in portfolios of investment securities through Fidelity, the custodian of the Plan's assets. Investment securities are exposed to various risks such as interest rate, market and credit risk. Due to the level of risk associated with certain investment securities and the level of uncertainty related to changes in the value of investment securities, it is at least reasonably possible that changes in risks in the near term would materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits and the statements of changes in net assets available for benefits.

From time to time, investments may include securities with contractual cash flows, such as asset backed securities, collateralized mortgage obligations and commercial mortgage backed securities, including securities backed by subprime mortgage loans. The value, liquidity, and related income of these securities are sensitive to changes in economic conditions, including real estate value, delinquencies or defaults, or both, and may be adversely affected by shifts in the market's perception of the issuers and changes in interest rates.

The Plan has implemented the accounting guidance for uncertainty in income taxes using the provisions of FASB ASC 740, Income Taxes. Using that guidance, the Plan does not believe it has any uncertain tax positions that qualify for either recognition or disclosure in the financial statements as of December 31, 2023 and 2022. The Plan's tax filings are subject to audit by U.S. Federal taxing authorities and open audit years are 2020-2023.

SUBSEQUENT EVENTS. The Plan has evaluated subsequent events through October 8, 2024, the date that financial statements were available for issue.

3. FAIR VALUE MEASUREMENTS AND DISCLOSURES

FASB ASC 820 establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 for financial assets and financial liabilities are described below:

Level 1	Values are based on quoted prices in active markets for identical securities.
Level 2	Values are based on (a) quoted prices for similar assets or liabilities in active markets; (b) quoted prices for identical or similar assets in non-active markets; or (c) valuation models whose inputs are observable, directly or indirectly, for substantially the full term of the asset or liability.
Level 3	Values are based on prices or valuation techniques that require inputs that are both unobservable and significant to the overall fair value measurement. These inputs may reflect the Plan's estimates of the assumptions that market participants would use in valuing the financial asset or financial liability.

3. FAIR VALUE MEASUREMENTS AND DISCLOSURES

Pursuant to FASB ASC 820, fair value is a market-based measure, considered from the perspective of a market participant who owns an asset or owes a liability. Accordingly, when market observable data is not readily available, assumptions are set to reflect those that market participants would be presumed to use in pricing the asset or liability at the measurement date. Prices and inputs are used that are current as of the measurement date, including during periods of market disruption. In periods of market disruption, the ability to observe the prices and inputs may be reduced for many instruments. This condition could cause an instrument to be reclassified from Level 1 to Level 2 or from Level 2 to Level 3.

The following is a summary of the inputs used, as of December 31, 2023 and 2022, involving the Plan's financial assets carried at fair value. The inputs or methodologies used for valuing investments may not be an indication of the risk associated with investing in those securities. For more information on valuation inputs, and their aggregation into the levels used in the table below, please refer to Valuation of Investments section in Note 2.

4. INCOME TAX STATUS

The Plan obtained its latest determination letter on June 30, 2020, in which the Internal Revenue Service stated that the prototype plan, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code. Once qualified, the Plan is required to operate in conformity with the Internal Revenue Code to maintain its qualification. The Plan has been amended to meet the requirements of certain changes to the law, therefore, the plan administrator believes that the Plan is qualified, and the related trust is tax-exempt as of the financial statement date. Therefore, no provision for income taxes has been included in the Plan financial statements.

5. PLAN TERMINATION

Although it has not expressed any intention to do so, the employer Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA.
