## **Independent Auditors' Report**

Plan Administrator and Participants of  
EasTex Tower LLC 401(k) Profit Sharing Plan

### ***Scope and Nature of the ERISA Section 103(a)(3)(C) Audit***

We have performed an audit of the financial statements of EasTex Tower LLC 401(k) Profit Sharing Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). The financial statements comprise the statements of net assets available for benefits as of December 31, 2022 and 2021, and the related statement of changes in net assets available for benefits for the year ended December 31, 2022, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audit need not extend to any statements or information related to assets held for investment of the plan ("investment information") by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA ("qualified institution").

Management has obtained certifications from a qualified institution as of December 31, 2022 and 2021 and for the year ended December 31, 2022, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

### ***Opinion***

**NOTE 1 – DESCRIPTION OF PLAN**

The following description of the EasTex Tower LLC (“Company”) 401(k) Profit Sharing Plan (“Plan”) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan covering substantially all employees of the Company. The plan was established June 1, 2006 and is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

The Plan was most recently restated on August 1, 2021 and November 15, 2021 to incorporate various regulatory changes. There were no significant changes to Plan provisions.

Eligibility

All non-leased employees who are 18 years old and have worked three consecutive months of service are eligible to actively participate in the Plan.

Contributions

Each year participants may contribute a percentage of annual compensation, as defined by the Plan, as pre-tax or after tax (Roth) deferrals. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollovers).

The Company may make safe harbor matching contributions and discretionary profit-sharing contributions. For the year ended December 31, 2022, the Company made safe harbor matching contributions equal to 100% of the first 4% of eligible compensation that a participant contributes to the Plan. There were no discretionary profit-sharing contributions for the year ended December 31, 2022. Contributions are subject to certain limitations.

Participants can direct the investment of elective deferrals and Company contributions, if any, into any of the mutual funds offered by the Plan as investment options. Participants are permitted to change their investment elections daily.

Participant Accounts

Each participant's account is credited with the participant's contribution and the Company's safe harbor matching contributions, if any, and allocations of (a) the discretionary profit-sharing contribution, if any and, (b) Plan earnings (losses), and may be charged with an allocation of any administrative expenses paid by the Plan. Allocations are based on participant earnings, account balances, or specific transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account balance.

**NOTE 1 – DESCRIPTION OF PLAN (continued)**

Vesting

Participants are immediately vested in their elective contributions and safe harbor matching contributions plus actual earnings thereon. Vesting in the Company's discretionary profit sharing contribution plus earnings thereon is based on years of continuous service. A participant is vested 20% after the second year of service; 40% after the third year; 60% after the fourth year; 80% after the fifth year; and is 100% vested after six years. However, if an active participant dies or becomes disabled prior to completing six years of service or attaining the normal retirement age, the participant becomes 100% vested.

Forfeited Accounts

There were no forfeited non-vested accounts at December 31, 2022 and 2021. Forfeitures of matching contributions may be used to offset employer contributions or to pay Plan expenses. There were no forfeitures used to offset employer contributions or to pay Plan expenses during the year ended December 31, 2022. Forfeitures are applied based on when amounts are due.

Payments of Benefits

Distributions from the Plan are permitted upon termination of employment, retirement, disability, or death. Participants may elect a lump-sum distribution. For accounts \$1,000 or less, the vested account balance may be automatically paid out to the participant as a single sum, unless the participant elects otherwise. For accounts with balances between \$1,000 and \$5,000 where the participant is no longer an employee of the Company and has not elected to receive a distribution, the participant's vested balance can be rolled over into an IRA by the Plan Administrator. The Plan permits in-service distributions for participants who are age 59 ½ or older as well as in the case of certain financial hardship situations, subject to the provisions of the Plan document. Minimum required distributions for participants who have reached age 72 also apply per IRS regulations.

Administrative Expenses

The Plan's administrative expenses may be paid by the Plan, the Company, or with forfeitures, as provided in the Plan document. Transaction expenses, such as investment expenses and distribution administrative expenses are charged directly to the participant's account and are included in administrative expenses.

**NOTE 2 – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

Basis of Accounting

The financial statements of the Plan are prepared using the accrual basis of accounting, in accordance with generally accepted accounting principles in the United States of America ("GAAP").

Use of Estimates

The preparation of financial statements in accordance with GAAP requires the plan administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosures of contingent assets and liabilities. Accordingly, actual results may differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Plan Management determines the Plan's valuation policies utilizing information provided by the trustee. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net depreciation includes the plan's gains and losses on investments bought and sold, as well as held, during the year.

Contributions

Employee deferrals and employer safe harbor matching contributions, if any, are recognized on the pay date to which they relate. Employer discretionary profit-sharing contributions, if any, are recognized in the year designated by the Company.

Payment of Benefits

Benefits are recorded when paid.

**NOTE 3 – INFORMATION CERTIFIED BY THE PLAN TRUSTEE**

As noted in the independent auditors' report, the Plan administrator has elected the method of annual reporting compliance as permitted by 29 CFR 2520.103-8 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, certain information disclosed in the accompanying financial statements and supplemental schedule, was obtained or derived from information supplied to the Plan administrator and certified as complete and accurate by Ascensus Trust Company, the trustee of the Plan. This information includes:

- Investment values as of December 31, 2022 and 2021, as shown in the statements of net assets available for benefits and the fair value disclosures in Note 4.
- Notes receivable from participants, as shown in the statements of net assets available for benefits as of December 31, 2022 and 2021.
- Net investment income, as shown in the statement of changes in net assets available for benefits for the year ended December 31, 2022.
- Schedule H, Line 4i – schedule of assets (held at end of year) as of December 31, 2022.

The Plan's independent auditors did not perform auditing procedures with respect to information certified by the trustee.

**NOTE 4 – FAIR VALUE MEASUREMENTS**

GAAP establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are described as follows:

- Level 1    Unadjusted quoted prices for identical instruments in active markets.
- Level 2    Quoted prices for similar instruments in markets that are not active; and model-derived valuations in which all significant inputs are observable.
- Level 3    Valuations derived from valuation techniques in which significant inputs are unobservable.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodology used for assets measured at fair value. There have been no changes in the methodology used at December 31, 2022 and 2021.

*Mutual Funds:* Valued at the quoted net asset value ("NAV") of shares held by the Plan at year-end.

*Collective Trust Fund* Valued using the NAV of units as a practical expedient, which is determined by the insurance or trust company. The NAV is based on the value of the underlying assets owned by the account or fund. As of December 31, 2022, there were no unfunded commitments or redemption restrictions. The accounts and funds are direct filing entities and as such, investment strategy disclosures are not required.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

**NOTE 5 – RELATED PARTY AND PARTY-IN-INTEREST TRANSACTIONS**

Administrative expenses paid to the trustee qualify as party-in-interest transactions. These transactions qualify as party-in-interest transactions which are exempt from the prohibited transaction rules.

**NOTE 6 – PLAN TERMINATION**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their employer contributions.

**NOTE 7 – TAX STATUS**

The Plan has adopted the Ascensus LLC Non-Standardized Pre-Approved Profit Sharing Plan. On June 30, 2020, the IRS stated in an opinion letter that the prototype plan adopted by the Plan, as then designed, was in compliance with applicable requirements of the Internal Revenue Code (“IRC”) and therefore, the related trust is exempt from taxation.

U.S. GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination. Management evaluated the Plan’s tax positions and concluded that the Plan has maintained its tax-exempt status and has taken no uncertain tax positions that require recognition or disclosure in the financial statements. Therefore, no provision or liability for income taxes has been included in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax period in progress.

**NOTE 8 – RISKS AND UNCERTAINTIES**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the accompanying statement of net assets available for benefits.

**NOTE 9 – SUBSEQUENT EVENTS**

Plan management has evaluated subsequent events through November 21, 2024, the date the financial statements were available to be issued. The Plan was amended and restated effective January 1, 2023. The name of the Plan was changed to the Ontivity 401(k) Plan. Additionally, the name of the Plan Sponsor was changed to TAC Enertech Resources Holdings, LLC. The amendment removed the minimum age requirement of 18 years old for all deferral types and also added a condition to exclude leased employees and interns from participating. Participants can now enter the Plan as of the first day of the month. Additionally, the Plan allows matching contributions for pre-tax and Roth deferrals and removed the safe harbor contributions. Participants will be required to have 6 months of service to be eligible to receive profit sharing contributions. The Plan also amended the vesting conditions so that participants will be 25% vested after 1 year of service, 50% vested after 2 years of service, 75% vested after 3 years of service and fully vested after 4 years of service. Participants will receive credit for prior service with CIS; Legacy Telecommunications, LLC; Enertech Resources, LLC; EasTex Tower, LLC; Mountain Wireless Construction, LLC; CMS Wireless, LLC.. Lastly, the Plan removed the condition that participants would qualify as reaching the normal retirement age on the 5<sup>th</sup> anniversary of their participation.

In January 2023, the Plan Sponsor approved the merger of several affiliated plans:

- On January 6, 2023 assets of approximately \$3 million from the Mountain Wireless Construction LLC, 401(k) Plan were merged into the Plan.
- On January 6, 2023 assets of approximately \$3.8 million from the Enertech Resources, LLC 401(k) Plan were merged into the Plan.
