THE TAXPAYER REQUESTS RELIEF FROM LATE FILING OF FORM 5500-SF. THERE WAS MISCOMMUNICATION BETWEEN THE PLAN ADMINISTRATOR AND THE TAXPAYER WHICH ULTIMATELY AND INADVERTENTLY RESULTED IN THE LATE FILING OF THE FORM.
