1. Description of Plan

The following description of the Wawona Packing Company Retirement Savings Plan (the “Plan”) provides only general information. Participants should refer to the Plan Agreement, as amended, for a more complete description of Plan provisions.

General – The Plan was a 401(k) salary deferral and profit sharing plan covering substantially all employees of Wawona Packing Company, LLC (the Company), and was subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Company was the Plan’s sponsor and appointed an Administrative Committee to serve as plan administrator. The trustee was responsible for oversight of the Plan assets. The Administrative Committee determined the appropriateness of the Plan’s investment offerings, monitored investment performance, and reported to the Plan sponsor.

Effective September 13, 2019, the Company merged with Gerawan Farms (GF) and all GF employees became employees of the Company effective January 1, 2020. Effective March 1, 2020, all GF employees were credited with prior service. All GF employees who participated in the GF Plan were allowed immediate special entry into the Plan, and other GF employees became eligible as further described in the Plan.

Plan Termination and Liquidation – In connection with the Company’s October 2023 bankruptcy filing, on April 3, 2024, the members of the Company passed a resolution to terminate the Plan and an amendment was adopted to terminate and liquidate the Plan. Effective April 15, 2024, an amendment to freeze the Plan in preparation for termination was adopted. No participants were allowed to enter the Plan after the date of Plan termination. All participants were fully vested in their account balances, and such balances were liquidated and distributed to participants by June 28, 2024.

Eligibility – Employees of the Company were eligible to participate in the Plan upon reaching age 21 and after completing one year of service in which at least 1,000 hours were worked. Eligible employees could become participants in the Plan on the first day of the first and seventh months of the plan year following completion of all eligibility requirements.

Contributions

Participant contributions – Each year, participants could contribute between 1% and 100% of pretax annual compensation, as defined in the Plan. Participants could also elect to make Roth contributions utilizing after-tax contributions. Participants who had attained age 50 before the end of the Plan year were eligible to make catch-up contributions. Participants could also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans.

Employer matching and nonelective contributions – The Company could elect to make discretionary matching and nonelective contributions to the Plan. Nonelective contributions were to be allocated to participants based on the allocation group as outlined in the Plan Agreement. There were no discretionary matching or nonelective contributions for the period ended June 28, 2024.

Employer safe harbor – The Company also made an annual safe harbor contribution equal to 100% of the participant’s elective deferrals, not to exceed 3% of the participant’s compensation, plus 50% of the participant’s elective deferrals exceeding 3%, not to exceed 5% of eligible compensation, regardless of the employee’s hours of service or employment on the last day of the Plan year. The safe harbor contribution for the period ended June 28, 2024, was \$168,695. Effective April 1, 2021, the Plan Sponsor funded safe harbor contributions each pay period.

Contributions were subject to regulatory limitations.

Participant accounts – Each participant’s account was credited with the participant’s contributions, Company matching and safe harbor contributions, as well as allocations of the Company’s nonelective contributions and Plan earnings. Participant accounts were charged with an allocation of administrative expenses paid by the Plan. Allocations were based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant was entitled was the benefit that could be provided from the participant’s vested account. Participants directed the investment of their account into various investment options offered by the Plan.

Vesting – Participants were vested immediately in their contributions and any Company safe harbor matching contributions plus actual earnings thereon. Vesting in the Company’s match and nonelective portion of their accounts was based on years of continuous service. A participant was vested 20% with each year of credited service, beginning in year two, and was fully vested after six years of service.

Notes receivable from participants – Participants could borrow from their accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The loans were issued by the Plan and secured by the balance in the participant’s account. All loans were required to be repaid within a period of five years, unless the loan was used to purchase a principal residence, in which case, the loan was required to be repaid within a reasonable period of time. Under the terms of the Plan Agreement, plan loans bore a rate of interest of one percentage point above the prime rate. Principal and interest was paid ratably through payroll deductions.

Payment of benefits – On termination of service due to death, disability, retirement, or termination of service for other reasons, a participant received a lump-sum amount equal to the value of the participant’s vested interest in his or her account. The Plan also automatically distributed amounts to terminated participants with balances less than \$5,000 into an individual retirement account.

2. Summary of Significant Accounting Policies

Basis of accounting – The accompanying 2023 financial statements have been prepared in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP), using the accrual basis of accounting.

The accompanying 2024 financial statements have been prepared under the liquidation basis. This basis was adopted when liquidation was deemed imminent in accordance with Accounting Standards Update ("ASU") 2013-07, *Liquidation Basis of Accounting*. Plan management determined that liquidation was imminent upon adoption of the resolution to terminate the Plan on April 15, 2024. Under the liquidation basis of accounting, assets are measured

at their net realizable value, estimated by fair value reduced by surrender charges, penalties and redemption charges, and disposal expenses, to reflect the estimated amount of cash expected to be collected in settling or disposing of the assets during the liquidation process. Any liabilities would be measured using the accrual basis of accounting, including any expected costs of the disposal of assets and other costs expected to be incurred during the liquidation process.

As of June 28, 2024, the date of the final Plan participant benefit payment pursuant to the resolution to terminate the Plan, all Plan assets had been liquidated and Plan liabilities paid in accordance with such resolution and the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

Use of estimates – The preparation of financial statements in conformity with U.S. GAAP requires the use of estimates and assumptions that may affect certain amounts and disclosures. Accordingly, actual results could differ from those estimates.

Investment valuation – The investments were reported at fair value and contract value. The Plan's custodian, Empower Trust Company, LLC (ETC), certified the contract value of the guaranteed investment contract and the fair value of all other investments. If available, quoted market prices were used to value investments.

Fair value is the price that would be received to sell an asset or paid to transfer a liability (the "exit price") in an orderly transaction between market participants at the measurement date. See Note 3 for discussion of fair value measurements.

Contract value is the relevant measurement for assets invested in fully benefit-responsive investment contracts because contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the Plan.

Income recognition – Purchases and sales of securities were recorded on a trade-date basis. Interest income was recorded on the accrual basis. The net appreciation in fair value of investments consists of both the realized gains and losses and unrealized appreciation and depreciation of those investments.

Notes receivable from participants – Notes receivable from participants were measured at amortized cost, which represents unpaid principal balance plus accrued but unpaid interest. Delinquent notes receivable from participants are reclassified as distributions upon the occurrence of a distributable event, based on the terms of the Plan Agreement. No allowance for credit losses was recorded as of June 28, 2024 (Liquidation), and December 31, 2023 (Ongoing).

Payment of benefits – Benefits were recorded when paid.

Administrative Expenses – Certain expenses of maintaining the Plan were paid directly by the Plan, unless otherwise paid by the Company. Expenses paid by the Company were excluded from these financial statements. Fees related to participant-initiated transactions were charged directly to the participant's account and included in administrative expenses. Investment-related expenses were included in net appreciation in fair value of investments.

The framework for measuring fair value provides a hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3).

The three levels of the fair value hierarchy are described as follows:

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities the Plan has the ability to access.

Level 2 – Inputs to the valuation methodology include quoted prices for similar assets or liabilities in active markets; quoted prices for identical or similar assets or liabilities in inactive markets; inputs other than quoted prices that are observable for the asset or liability; and inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value:

Registered investment companies (mutual funds) – Valued at the daily closing price as reported by the fund. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The funds held by the Plan are deemed to be actively traded. Mutual funds held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission.

Pooled separate accounts – Units held in pooled separate accounts (PSAs) are valued using the net asset value practical expedient (NAV practical expedient) of the PSA as reported by the account managers. The NAV practical expedient is based on the fair value of the underlying assets owned by the PSA, minus its liabilities, and then divided by the number of units outstanding.

Collective trusts – Units held in collective trusts (CTs) are valued using the NAV practical expedient of the CTs as reported by the CT managers. The NAV practical expedient is based on the fair value of the underlying assets owned by the CTs, minus its liabilities, and then divided by the number of units outstanding.

Below are the investment strategies for investments that represent more than 5.0% of net assets as of December 31, 2023 (Ongoing):

Fidelity Mid Cap Index Fund: The fund seeks to provide investment results that correspond to the total return of stocks of mid-capitalization United States companies. It normally invests at least 80% of its assets in securities included in the Russell Midcap Index Lending securities to earn income for the fund.

MassMutual RetireSmart by JPM 2030: The fund seeks total return through its asset allocation, which is designed to become more conservative over time. As the fund approaches and passes the target retirement date, the fund's objective will shift to seeking current income and some capital appreciation.

MassMutual S&P 500 Index: The fund seeks to approximate as closely as practicable the capitalization-weighted total rate of return of that portion of the U.S. market for publicly-traded common stocks composed of larger-capitalized companies.

American Funds Growth Fund: The fund seeks growth of capital. The fund invests primarily in common

stocks and seeks to invest in companies that appear to offer superior opportunities for growth of capital. It may invest up to 25% of its assets in securities of issuers domiciled outside the United States.

MassMutual 40/60 Allocation Fund: The fund seeks long-term capital growth and current income primarily through investments in non-U.S. stocks.

Loomis Sayles Core Plus Bond: The fund follows a fixed income strategy and seeks to outperform the Bloomberg US Aggregate Bond Index through investments in US Treasuries, mortgage-backed securities, and other corporate grade bonds.

State Street Equity 500 Index: The fund seeks to follow the performance of the S&P 500 through investment in various stock exchanges across 24 separate industry groups.

The valuation methods used by the Plan may have produced a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments may have resulted in a different fair value measurement at the reporting date.

4. Guaranteed Investment Contract with Insurance Company

The Plan had a fully benefit-responsive investment contract (FBRIC) with ETC who maintained the contributions in a general account. The account was credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The contract issuer was contractually obligated to repay the principal and a specified interest rate guaranteed to the Plan based on a formula established by the contract issuer which could not be less than 3%. The crediting rate was reviewed on a semi-annual basis for resetting. The FBRIC did not permit the insurance company to terminate the agreement prior to the scheduled maturity date.

The contract met the FBRIC criteria and was therefore reported at contract value. Contract value is the relevant measure for FBRICs because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value, as reported to the Plan by ETC, represented contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants could ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

The Plan's ability to receive amounts due was dependent on the issuer's ability to meet its financial obligations, which could be affected by future economic and regulatory developments.

Certain events might have limited the ability of the Plan to transact at contract value with the issuer. Such events included the following: (1) amendments to the plan documents (including complete or partial plan termination or merger with another plan), (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the Plan sponsor or other Plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the plan, (4) the failure of the trust to qualify for

exemption from federal income taxes or any required prohibited transaction exemption under ERISA, or (5) premature termination of the contract. Although the Plan was terminated April 15, 2024 and subsequently liquidated, the Plan continued to transact at contract value with both the contract issuers and the participants.

In addition, certain events allowed the issuer to terminate the contract with the Plan and settle at an amount different from contract value. Examples of such events included the following: (1) an uncured violation of the Plan's investment guidelines, (2) a breach of material obligation under the contract, (3) a material misrepresentation, or (4) a material amendment to the agreements without the consent of the issuer.

In connection with the termination and liquidation of the Plan, all amounts owed to participants pursuant to the FBRIC were settled with participants at no less than contract value at the date of liquidation and distribution.

5. Tax Status

The Plan document is a volume submitter defined contribution plan that received a favorable opinion letter from the Internal Revenue Service on June 30, 2020, which stated that the Plan, as then designed, was in accordance with applicable sections of the Internal Revenue Code (IRC). Although the Plan has been amended since the date of the opinion letter, the plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC.

In accordance with guidance on accounting for uncertainty in income taxes, the plan administrator has evaluated the Plan's tax positions and does not believe the Plan has any uncertain tax positions that require disclosure or adjustment to the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

6. Risks and Uncertainties

The Plan invested in various investment securities, which, in general, were exposed to various risks, such as interest rate risk, credit risk, and overall market volatility. Due to the level of risk associated with certain investment securities, it was at least reasonably possible that changes in the values of the investments in the near term could have materially affected a participant's account balance and the amounts reported in the statement of net assets available for benefits.

7. Information Certified by the Custodian

The plan administrator elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, ETC, the custodian of the Plan, certified to the completeness and accuracy of:

- Investments reflected on the accompanying statements of net assets available for benefits as of June 28, 2024 and December 31, 2023.

8. Party-in-Interest Transactions

The Plan paid expenses related to plan operations and investment management to various service providers. Certain Plan investments were managed by ETC, the custodian of the Plan and, therefore, these transactions with this entity qualify as exempt party- in-interest transactions.

9. Plan Termination

The Wawona Packing Company Retirement Savings Plan had the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions set forth in ERISA. On April 3, 2024, as described in Note 1, the Wawona Packing Company Retirement Savings Plan resolved to terminate the Plan effective April 15, 2024. Participants became 100% vested in their accounts as of the termination date.

10. Reconciliation to Form 5500

The Form 5500 has certain items that differ from amounts shown on the accompanying financial statements. These differences relate to classification only and have no effect upon net assets available for benefits for either period.

11. Delinquent Participant Contributions

As disclosed in the accompanying supplemental schedule, certain employee deferrals were not remitted to the Plan within the timeframe required by the Department of Labor. Plan management has determined the amount of related lost earnings and has remitted these amounts to participants' accounts.

12. Subsequent Events

The Plan has evaluated subsequent events through November 20, 2024, which is the date the financial statements were available to be issued, and has determined that, there are no subsequent events which need to be disclosed.
