### **Emphasis of Matter – Plan Termination and Liquidation Basis of Accounting**

As discussed in Note 8 to the financial statements, the Plan Trustees of the Wood-River Industries Company Hourly Employees' Pension Plan approved a plan liquidation effective November 15, 2023, and management liquidated the Plan on December 7, 2023. As a result, Wood-River Industries Company Hourly Employees' Pension Plan changed its basis of accounting from the going-concern basis of accounting used in presenting the 2023 financial statements to the liquidation basis of accounting used in presenting the 2024 financial statements. Our opinion is not modified with respect to this matter.

### **Responsibilities of Management for the Financial Statements**

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

## **WOOD-RIVER INDUSTRIES COMPANY HOURLY EMPLOYEES' PENSION PLAN NOTES TO FINANCIAL STATEMENTS**

### **1. DESCRIPTION OF PLAN**

The following description of the Wood-River Industries Company Hourly Employees' Pension Plan (Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions. Effective November 15, 2023, the Plan was terminated and all of the plan assets were transferred to United of Omaha Life Insurance Company as of December 7, 2023. See Note 8.

#### **General**

The Plan was a qualified, noncontributory defined benefit pension plan providing retirement benefits to eligible employees of Wood-River Industries Company (Company). The Company was a wholly owned subsidiary of Sea Gull Lighting Products, LLC, which is a wholly owned subsidiary of Visual Comfort & Co. (formerly known as Generation Brands & Affiliates). An employee was ineligible to participate if not covered under the collective bargaining agreement between the Company and the Local #155, United Electrical, Radio and Machine Workers of America. The Plan was subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

The Company adopted an amendment to freeze the Plan effective at October 31, 2013. No new participants were admitted to the Plan, and there were no additional benefit accruals allowable under the Plan subsequent to October 31, 2013.

#### **Funding Policy**

Contributions from the employer to the Plan were accrued, based upon amounts required to be funded under the provisions of ERISA or, if greater, amounts actually contributed relating to the current year. Contributions were designed to provide for normal cost on a current basis and prior service costs over 18 years, while ensuring that the contributions were in compliance with the minimum funding requirements of ERISA. The yield (interest, dividends, and net realized and unrealized gains and losses) on investments of the Plan served to reduce future contributions that would otherwise be required to provide for the defined level of benefits under the Plan. The minimum funding requirement set forth by ERISA for the Plan period beginning November 1, 2023 amounted to \$13,763.

#### **Pension Benefits**

Eligible participants were entitled to annual pension benefits beginning at normal retirement age (65), equal to an amount based on the date of the pension credit. The pension credit ranged from \$9.50 to \$12.25 per month, multiplied by the years of credited service, as defined in the Plan. Participants received their benefit in the form of a life annuity, paid in monthly installments. Optional forms of payment may have been elected in advance of retirement. Benefit accruals under the Plan were frozen as of October 31, 2013.

#### **Vesting**

Until the Plan was frozen and upon three years of service, a participant vested at 20%. For each additional year of service, the participant vested an additional 20% up to 100%. If employees terminate with non-vested benefits, they forfeit the right to receive the portion of their accumulated plan benefits attributable to the Company's contributions.

### 1. DESCRIPTION OF PLAN - Continued

#### Death Benefits

A benefit equal to the value of the participant's accumulated pension benefit was payable to the surviving spouse of either a pensioner or of an employee who had already qualified for a pension benefit.

#### Disability

Participants who became permanently disabled prior to retirement were eligible to receive Plan benefits equal to the value of their accumulated pension benefit.

### 2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

#### Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting through October 31, 2023 and on liquidation basis thereafter.

#### Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and when applicable, disclosure of contingent assets and liabilities and the actuarial present value of the accumulated plan benefits at the date of the financial statements and changes therein. Actual results could differ from those estimates.

#### Investment Valuation and Income Recognition

The Plan's investments were stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 5 for discussion of fair value measurement. Purchases and sales of securities were recorded on a trade-date basis. Interest income was recorded on the accrual basis. Dividends were recorded on the ex-dividend date. Net appreciation in fair value of investments included realized and unrealized gains and losses on investments.

#### Payment of Benefits

Benefits were recorded when paid.

#### Administrative Expenses

The Plan's expenses were paid either by the Plan or the Company, as provided by the Plan document. Expenses that were paid directly by the Company were excluded from these financial statements. Certain expenses incurred in connection with the general administration of the Plan that were paid by the Plan were recorded as deductions in the accompanying statement of changes of net assets available for benefits. In addition, certain investment related expenses were included in net appreciation of fair value of investments presented in the accompanying statement of changes in net assets available for benefits.

**Subsequent Events**

The Plan has evaluated subsequent events through November 19, 2024, the date the financial statements were available to be issued.

**3. ACTUARIAL PRESENT VALUE OF ACCUMULATED PLAN BENEFITS**

Accumulated plan benefits were those future periodic payments, including lump-sum distributions that were attributable under the Plan's provisions to the service the employees had rendered. Accumulated plan benefits included benefits expected to be paid to (a) retired or terminated employees or their beneficiaries, (b) beneficiaries of employees who have died, and (c) present employees or their beneficiaries. Benefits paid ranged from \$9.50 to \$12.25 per month, based on the number of years of credited service pursuant to the provisions of the union agreement. Benefits payable under all circumstances, retirement, death, disability, and termination of employment, were included, to the extent they were deemed attributable to employee service rendered to the valuation date.

The actuarial present value of accumulated plan benefits was determined by an independent actuary, and was the amount that resulted from applying actuarial assumptions to adjust the accumulated plan benefits to reflect the time value of money (through discounts for interest) and the probability of payment (by means of decrements such as for death, disability, withdrawal or retirement) between the valuation date and the expected date of payment.

The significant actuarial assumptions used in the valuation at October 31, 2023 were as follows:

Actuarial Value of Assets	Market Value Method
Discount Rate	7.00% compounded annually
Mortality	2023 Combined Static Mortality Tables at October 31, 2023 for males and females, as appropriate
Retirement age	Later of attainment of age 65 or 3 years of participation

The foregoing actuarial assumptions were based on the presumption that the Plan was to continue. The Plan was terminated effective November 15, 2023. See Note 8 related to termination of the plan. The computations of the actuarial present value of accumulated Plan benefits were made as of November 1, 2023. Had the valuations been performed as of October 31, 2023 there would be no material differences.

### 4. CERTIFIED INFORMATION

The Standard Insurance Company has provided certification for the money market account as of April 30, 2024 and October 31, 2023. Transamerica Life Insurance Company has provided certification for the Transamerica insurance contract account as of April 30, 2024 and October 31, 2023. These certifications provide that the following information which is contained in or used to develop the financial statements or schedules is complete and accurate:

- Details (cost and fair values) and summaries of investments held at April 30, 2024 and October 31, 2023. No investments are held at April 30, 2024.
- Summaries of investment asset transactions for the six months ended April 30, 2024.
- Investment earnings for the six months ended April 30, 2024.

### 5. FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1), and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) 820 Fair Value Measurements, are described as follows:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 – Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets,
- Quoted prices for identical or similar assets or liabilities in inactive markets,
- Inputs other than quoted prices that are observable for the asset or liability, and
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

**5. FAIR VALUE MEASUREMENTS - Continued**

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value.

*Insurance contract account*– Valued at fair value by the insurance company by discounting the related cash flows based on current yields of similar instruments with comparable durations considering the credit-worthiness of the issuer. The account balance is \$0 at April 30, 2024.

*Money market fund* - Valued at the daily closing price as reported by the fund. The fund balance is \$0 at April 30, 2024.

### **6. PENSION PROTECTION ACT**

On August 17, 2006, the Pension Protection Act (Act) was signed into law. Included in its many provisions are numerous revisions to rules surrounding defined benefit plans, including rules that govern plan funding. The Act established minimum funding standards for defined benefit plans and limited benefit increases and accruals for underfunded plans. Pursuant to the Act, each year actuaries are required to certify to a plan's funded percentage. The Plan received such certification for the October 31, 2023 Plan year for the Adjusted Funding Target Attainment Percentage (AFTAP), which is one way of measuring the funded status of a plan using actuarial assumptions mandated by the IRS, and the actuary determined that the AFTAP as of November 1, 2023 for the Plan was 96.73%.

### **7. PARTY-IN-INTEREST AND RELATED PARTY TRANSACTIONS**

Investments were managed by Standard and Transamerica, the custodians of the plan. The Plan's investments in Standard and Transamerica insurance contract qualified as party-in-interest transactions and were exempt from the prohibited transaction rules of ERISA.

### **8. PLAN TERMINATION**

The Board of Trustees of the Wood-River Industries Company Hourly Employees' Pension Plan resolved to terminate the plan effective as of November 15, 2023. The Plan was transferred to United of Omaha Life Insurance Company in the amount of \$2,623,640 on December 7, 2023.

### **9. TAX STATUS**

The IRS has determined and informed the Plan Sponsor by a letter dated July 10, 2012, that the Plan and related Trust were designed in accordance with applicable sections of the Internal Revenue Code (IRC). Once qualified, the Plan was required to operate in conformity with the IRC to maintain its qualification. Although the Plan has been amended since the date of the letter, the plan administrator believes that the Plan was designed and was being operated in compliance with the applicable requirements of the Internal Revenue Code.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination. The Plan was subject to routine audits by taxing jurisdictions; however, there are no audits for any tax periods in progress.

**10. RISKS AND UNCERTAINTIES**

Plan contributions were made, and the actuarial present value of accumulated plan benefits were reported, based on certain assumptions pertaining to interest rates, inflation rates and employee demographics, all of which were subject to change. Due to uncertainties inherent in the estimations and assumptions process, it was at least reasonably possible that changes in these estimates and assumptions in the near term could have materially affected the statement of net assets available for benefits and the accumulated plan benefits disclosed in the financial statements at April 30, 2024.
