NOTE 1 - DESCRIPTION OF THE PLAN

The following brief description of the MGM Savings Plan (the “Plan”) is provided for general information purposes only. Participants should refer to the Plan document for more specific provisions.

A. General

The Plan is a defined contribution plan subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (ERISA). The Plan is sponsored by Metro-Goldwyn-Mayer Inc. (the “Company”) and is administered by the Retirement and Savings Plan Committee (the “Plan Administrator”). The net assets of the Plan are separate assets from the Company and are held by the trustee and custodian of the Plan.

B. Administrative Expenses

Most of the administrative expenses are paid by the Company or by utilizing forfeitures in the Plan. Forfeitures were not used to offset expenses in 2023 or 2022.

C. Eligibility

An employee is eligible to participate in the Plan on the first day of the month coinciding with, or next following, such employee’s first day of service.

An employee is defined as any employee of the Company, excluding any person who renders services such as, without limitation, actor, cameraman, composer, director, musician, producer, singer, or writer.

The Plan covers substantially all nonunion employees of the Company, which adopted the Plan.

D. Contributions

Participants may contribute up to 75% of their annual compensation before bonus and overtime on a pre-tax, after-tax and/or Roth basis. All contributions are subject to certain limitations of the Internal Revenue Code (the “Code”). Catch-up contributions are permitted.

Effective January 1, 2018, after an employee completes three months of service, the Company makes matching contributions, on a bi-weekly basis, equal to 100% of the first 5% of the participant’s basic earnings contributed on either a pre-tax or after-tax basis, up to \$5,000 per participant, with certain exceptions.

The Plan allows for a Roth elective deferral contribution (“Roth”) to allow employees to make after-tax contributions into the Plan. Roth contributions are subject to the same annual contribution limitations, vesting, and Company matching contribution provisions as non-Roth contributions. The Plan has a Roth conversion option.

All employees who (i) first become eligible for participation into the Plan on or after January 1, 2013 and (ii) do not elect to contribute into the Plan shall be deemed to have elected 4% of their earnings as employee contributions into the Plan. Such provisions will be effective for pay periods beginning thirty (30) days after the date on which an employee first becomes eligible for participation into the Plan, unless the employee elects to change or stop such contribution. The Plan has an annual contribution accelerator feature at 1% each year up to a maximum of 10%.

D. Contributions (Continued)

Participants may rollover funds into the Plan from a previous employer's qualified benefit plan.

E. Participant Accounts

Each participant's account is credited with the participant's contributions, rollover contributions, Company matching contributions and earnings thereon. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. Participants direct the investment of their contributions and Company matching contributions into the investment options offered by the Plan. The assets of the Plan are valued daily.

F. Vesting

Participants are immediately 100% vested in their contributions, rollovers and any related earnings or losses thereon. Company matching contributions and earnings thereon for each employee are subject to 50% vesting after one year of service and 100% after two years of service. In addition, a participant is 100% vested upon the earlier of reaching normal retirement age while actively employed, or termination due to total disability. A participant's beneficiary will become 100% vested upon the death of an active participant.

G. Forfeitures

Participants who terminate employment during the year forfeit any non-vested Company matching and Company base and variable contributions. These forfeitures are used to reduce future Company matching contributions and pay administrative expenses. At January 11, 2023 and December 31, 2022, the Plan had \$0 and \$31, respectively, of unused forfeitures. Forfeitures in 2023 totaled \$1,811; forfeitures used to reduce Company matching contributions in 2023 totaled \$0.

H. Payment of Benefits

Upon termination of service, retirement age, death, or total disability, participants or their beneficiaries may receive a lump-sum distribution consisting of their contributions to the Plan and their vested portion of the Company's aggregate contributions. If the vested amount is less than \$5,000, the distribution will be made as soon as administratively practical. If the vested amount is greater than \$5,000, the distribution will be made upon the submission of a written request from the participant or participant's beneficiary. Financial hardship withdrawals are permitted. The Plan allows in-service distributions to participants who have attained age 59½.

I. Notes Receivable from Participants

The Plan allows participants to borrow not less than \$1,000 up to the lesser of \$50,000 or 50% of their vested account balance (reduced by the highest outstanding loan balance during the prior 12 months). A loan is secured by a participant's vested account balance, bears interest at the prime rate as of the loan approval date and must be repaid to the Plan in five years unless the loan is used for the purchase of a principal residence. The plan administrator establishes the specific terms and conditions of loans to participants. Notes receivable from participants at December 31, 2022 carry an interest rate ranging from 3.25% to 6.25%.

NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

A. Basis of Accounting

The financial statements are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America.

B. Estimates

The preparation of financial statements requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from these estimates.

C. Investment Valuation and Income Recognition

Investments are participant directed. Participants may change their investment options at any time during the period.

Accounting principles establish a fair value hierarchy that prioritizes valuation inputs into three levels based on the extent to which inputs used in measuring fair value are observable in the market:

Level 1 – Inputs are quoted prices in an active market.

Level 2 – Inputs are quoted prices for similar instruments and model-based valuation techniques for which all significant assumptions are observable in the market or can be corroborated by observable market data.

Level 3 – Inputs are generally unobservable and typically reflect management’s estimates of assumptions that market participants would use in pricing the asset or liability.

The guaranteed income fund and pooled separate accounts were reported at net asset value. Shares may be redeemed any time at net asset value.

The income fund does not specify any events which would limit the ability of the Plan to transact at contract value with the issuer or any events which would allow the issuer to terminate the contract and settle for an amount different from contract value. The income fund provides payment options of the contract value for surrendering the investment contract; however, the Company does not intend to surrender the income fund. The income fund contract value approximates fair value.

D. Risks and Uncertainties

Plan investments are exposed to various risks such as interest rate, market fluctuations, and credit risks. Due to the level of risk associated with investments, it is at least reasonably possible that changes in value of investments will occur in the near term and such changes could materially affect participant accounts and amounts reported in the financial statements.

NOTE 3 - PARTY-IN-INTEREST TRANSACTIONS

Empower or one of its affiliates provide investment options offered under the Plan. Transactions in these funds, while considered party in interest transactions under ERISA regulations, are permitted under the provisions of the Plan and are specifically exempt from the prohibition in interest transactions under ERISA.

NOTE 4 - FINANCIAL INFORMATION CERTIFIED BY THE TRUSTEE AND CUSTODIAN

The plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Information regarding investments held at January 11, 2023 and December 31, 2022 and investment income for the period January 1, 2023 to January 11, 2023 that is disclosed in the accompanying financial statements was obtained or derived from information supplied to the plan administrator and certified as complete and accurate by Empower Retirement, LLC and Empower Annuity Insurance Company of America, the trustee and custodian of the Plan, respectively.

NOTE 5 - INCOME TAX STATUS

The Plan received a determination letter from the Internal Revenue Service (IRS) dated October 31, 2017, stating that the Plan is qualified, in form, under Section 401(a) of the Code and, therefore, the related trust is exempt from taxation. The Plan has since been amended. However, the plan administrator believes the Plan is currently being operated in compliance with the applicable requirements of the Code and, therefore, believes that the Plan is qualified and the related trust is exempt. The plan administrator has indicated that it will take any steps necessary to maintain the tax qualified status of the Plan.

GAAP requires management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken a tax position that more likely than not would not be sustained upon examination by a tax authority. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE 6 - PLAN TERMINATION

The Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts and Plan assets will be distributed based upon the participants' account balances at that time.

NOTE 7 - PLAN MERGER

The Company merged the Plan into the Amazon 401(k) Plan effective January 1, 2023. Plan assets were transferred to the Amazon 401(k) Plan on January 11, 2023.

NOTE 8 - SUBSEQUENT EVENTS

Management has evaluated subsequent events through October 17, 2024, the date on which the financial statements were available to be issued. There were no material subsequent events that required recognition or additional disclosures in these financial statements.
