Independent Auditor's Report

To the Participants and Board of Trustees

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed the audits of the financial statements of the CBIGG Management, LLC 401(k) Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits (in liquidation) as of June 7, 2024 and December 31, 2023, the related statement of changes in net assets available for benefits (in liquidation) for the period January 1, 2024 to June 7, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of June 7, 2024 and December 31, 2023 and for the period January 1, 2024 to June 7, 2024 stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section:

- The amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP).
- The information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Emphasis of Matter

As discussed in Note 6 to the financial statements, the Plan Administrative Committee of CBIGG Management, LLC, the Plan's sponsor, adopted an amendment on January 4, 2024 to terminate the Plan, effective December 31, 2023, and management determined liquidation was imminent as of December 31, 2023. As a result, the Plan has presented the financial statements using the liquidation basis of accounting. Our opinion is not modified with respect to this matter.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with U.S. GAAP, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern within one year after the date that the financial statements are issued or available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the Plan, and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditor's Responsibilities for the Audit of the Financial Statements

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

In performing an audit in accordance with GAAS, we:

- Exercise professional judgment and maintain professional skepticism throughout the audit.

Our audits did not extend to the certified investment information, except for obtaining and reading the certifications, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of U.S. GAAP.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with U.S. GAAP.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Notes to Financial Statements

Note 1. Description of the Plan

The following description of the CBIGG Management, LLC 401(k) Plan (the Plan) provides only general information. Participants should refer to the Plan Document for a more complete description of the Plan's provisions.

The following description of the Plan was prior to the amendment to terminate the Plan, effective December 31, 2023. As of June 7, 2024, the Plan was liquidated.

General

The Plan is a defined contribution plan covering all eligible employees of CBIGG Management, LLC (the Company or Plan Sponsor) who have completed one year of service. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended. The Plan excludes non-resident aliens and union employees.

Participant Accounts

Participants direct the investment of their contributions into various investment options offered by the Plan. Participants may change their investment options any time throughout the year. Each participant's account is credited with the participant's contributions, and the Company's discretionary matching contributions, as well as allocations of the Company's discretionary profit-sharing contributions and plan earnings (losses). Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Notes Receivable

Under the provisions of the Plan, participants are not allowed to borrow from their individual accounts.

Vesting

As a result of the decision to terminate the Plan effective December 31, 2023, all participants became fully vested in their account balances as of this date.

Prior to December 31, 2023, participants were immediately vested in their elective contributions plus actual earnings/losses thereon. Vesting in the Company's contributions portion of their accounts plus actual earnings thereon is based on years of continuous service based on the following schedule:

Note 1. Description of the Plan (Continued)

Payment of Benefits

On termination of service due to death, disability, or retirement, a participant may elect to receive a lump sum or amount equal to the value of the participant's vested interest in his or her account. After attainment of age 59½, in-service withdrawals can be made from the participants' salary deferral portion of their account. Additionally, under certain circumstances of financial hardship, the participant is also allowed to withdraw funds from their account. Any balance less than \$5,000 is automatically paid out as soon as administratively possible.

Forfeited Accounts

When certain terminations of participation in the Plan occur, the non-vested portion of the participant's account, as defined by the Plan, represents a forfeiture. Forfeitures will be used to first reduce administrative expenses of the Plan with remaining amounts to offset future employer contributions. There were no forfeited amounts used during 2024 and no forfeited non-vested accounts at June 7, 2024 and December 31, 2023.

Note 2. Summary of Significant Accounting Policies

Basis of Accounting

Due to the decision to terminate the Plan, effective December 31, 2023, management determined that liquidation of the Plan was imminent, and the financial statements for 2024 and 2023 have been prepared using the liquidation basis of accounting.

Investment Valuation and Income Recognition

Investments at December 31, 2023 are reported at liquidation value due to the Plan termination discussed in Note 6. There were no investments remaining at June 7, 2024.

Purchases and sales of securities are recorded on a settlement-date basis. Interest income and dividends, if any, are recorded on the liquidation basis for 2024, including amounts expected to be earned through the final liquidation.

Payment of Benefits

Benefits are recorded when paid.

Distributions pursuant to the Plan termination were paid at the participants' election by: (a) rolling their account to an IRA, (b) rolling their account to the Company's new qualified retirement plan, or (c) taking a lump-sum cash distribution. Final distributions of the participant's account occurred in 2024.

Administrative Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Administrative expenses include certain recordkeeping fees paid by the Plan. Investment-related expenses are included in net appreciation (depreciation) in fair value of investments.

Note 2. Summary of Significant Accounting Policies (Continued)

Use of Estimates

The preparation of the Plan's financial statements in accordance with accounting principles generally accepted in the United States of America requires the Plan Administrator to make estimates and assumptions that affect the reported amounts of net assets available for benefits and changes therein. Actual results could differ from those estimates.

Note 3. Information Certified by John Hancock Life Insurance Company

The following is a summary of the Plan's asset information as of June 7, 2024 and for the period January 1, 2024 to June 7, 2024, and as of December 31, 2023, included throughout the Plan's financial statements and obtained by management and agreed to or derived from information certified as complete and accurate by John Hancock Life Insurance Company (John Hancock), a qualified institution:

John Hancock also certified to the completeness and accuracy of \$123,693 of net appreciation in fair value of investments related to the aforementioned assets for the period January 1, 2024 to June 7, 2024.

Note 4. Fair Value Measurements

The Financial Accounting Standard Board (FASB) Accounting Standards Codification (ASC) Topic 820, *Fair Value Measurements and Disclosures* (ASC 820) establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority. Level 2 inputs consist of observable inputs other than quoted prices for identical assets (Level 1 measurements). Level 3 inputs are unobservable and have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. Level 2 inputs are used for investments for which Level 1 inputs were not available. Level 3 inputs would only be used if Level 1 or Level 2 inputs were not available.

Note 4. Fair Value Measurements (Continued)

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques that are used need to maximize the use of observable inputs and minimize the use unobservable inputs.

There have been no changes in the methodology used at June 7, 2024 and December 31, 2023. The following is a description of the valuation methodology used for assets measured at fair value:

Pooled Separate Accounts: Valued at the unit value calculated based on the observable net asset value (NAV) of the underlying mutual fund investment as adjusted for the Plan's units of participation in the pooled account. Units are established for each investment division (sub-account) of the pooled separate account. The value of these units are determined at the close of the stock exchange each day the exchange is open for regular trading. The values increase or decrease based on the investment performance of the corresponding underlying portfolios.

In accordance with Subtopic 820-10, certain investments are measured at fair value using the NAV per share (or its equivalent) practical expedient. The NAV, as provided by the custodians, is used as a practical expedient to estimate fair value and has not been classified in the fair value hierarchy.

The preceding method may produce a fair value calculation that may not be indicative of the net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation method is appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Note 5. Related-Party and Party-in-Interest Transactions

Certain plan investments are managed by John Hancock. John Hancock is the current custodian and recordkeeper of the Plan, and therefore, these qualify as party-in-interest transactions. Fees paid by the Plan for the recordkeeping services amounted to \$19,656 for the period January 1, 2024 to June 7, 2024.

Note 6. Plan Termination

In January 2024, the Company's Plan Administrative Committee adopted a resolution to terminate the Plan effective December 31, 2023. As a result, management determined that liquidation was imminent as of December 31, 2023.

In January 2024, communication was sent to all participants notifying them of the Plan termination. All participants became fully vested in their participant account balances on December 31, 2023. All of the Plan assets were distributed or transferred, as elected by each participant, by June 7, 2024.

Note 7. Tax Status

The Plan has adopted a preapproved plan document that has received an opinion letter from the IRS dated June 30, 2020, stating that the form of the preapproved plan document was in compliance with applicable requirements of the Internal Revenue Code (IRC). The Plan has been amended since adopting the preapproved plan document; however, the Plan Administrator believes the Plan is designed, and is being operated, in compliance with the applicable requirements of the IRC.

Note 8. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near-term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

Note 9. Subsequent Events

Management has evaluated subsequent events through the date that the financial statements were available to be issued, November 11, 2024, and determined that no events occurred that require disclosure.
