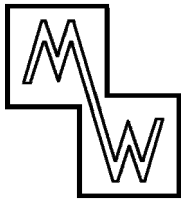

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Fayette Resources, Inc. Tax Sheltered Annuity Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2023 (in Liquidation) and 2022 (Ongoing), and the related statement of changes in net assets available for benefits in liquidation for the year ended December 31, 2023, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2023 and 2022, and for the year ended December 31, 2023, stating that the certified investment information, as described in Note 5 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditors' Responsibilities for the Audit of the Financial Statements section:

- The amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- The information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditors' Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for one year after the date that the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the plan, and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditors' Responsibilities for the Audit of the Financial Statements

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditors' report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if, there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Other Matters—Supplemental Schedules Required by ERISA

The supplemental schedule of Schedule H, Line 4i-Schedule of Assets (Held at End of Year) as of December 31, 2023, is presented for purposes of additional analysis and are not a required part of the financial statements but is supplementary information required by the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audit of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS. For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including their form and content, are presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

In our opinion:

- The form and content of the supplemental schedule, other than the information in the supplemental schedule that agreed to or is derived from the certified investment information, are presented, in all material respects, in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA, and
- The information in the supplemental schedule related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Plan Termination

As further discussed in Note 7 to the financial statements, the governing body of Fayette Resources, Inc., the Plan's Sponsor, resolved to begin termination of the Plan in 2021. During the 2023 year, it then became imminent that the Plan would terminate. In accordance with accounting principles generally accepted in the United States of America, the Plan has changed its basis used in presenting the 2023 financial statements. Our opinion is not modified with respect to this matter.

DOL Transitional Enforcement Relief

As more fully disclosed in Note 1A to the financial statements, the plan sponsor has not included annuity contracts issued to current and former employees prior to January 1, 2009, in its definition of plan assets. This definition is in accordance with the transitional enforcement relief issued by the DOL in Field Assistance Bulletin 2009-02. Our opinion has not been modified with regard to this definition.

NOTE 1: DESCRIPTION OF PLAN:

The following description of Fayette Resources, Inc. (the Company) Tax Sheltered Annuity Plan (the Plan) provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

A. GENERAL:

The Plan is a tax-sheltered annuity plan covering all employees of the Company. The Plan, as amended, is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Plan was instituted by the Company effective January 1, 1992. However, in accordance with transitional enforcement relief issued by the Department of Labor in Field Assistance Bulletin 2009-02, the Plan does not consider contracts issued prior to January 1, 2009, and held by Sun America Life Insurance Company, the former custodian, to be part of the Plan. The Company ceased to have any obligation to make contributions to those contracts prior to January 1, 2009, all rights and benefits are legally enforceable against the insurer by the individual contract owners, and each individual contract owner was fully vested in the contracts prior to January 1, 2009.

As further disclosed in Note 7, the plan sponsor resolved to terminate the Plan in 2021 and began offering a new 401(k) Plan.

B. ELIGIBILITY:

Prior to the resolution to terminate the Plan in 2021, to be eligible to begin elective deferrals and to receive employer matching contributions to the Plan, one must have been an eligible employee expected to work at least 20 hours per week and have met the age requirement of 18. In order to have continued receiving employer matching contributions, a participant must have completed 1,000 hours of service in the preceding year.

C. CONTRIBUTIONS:

Prior to the resolution to terminate the Plan in 2021, under the terms of the plan agreement, participants may have elected to defer 1% to 100% of eligible compensation subject to IRS limitations. Participants may have also contributed amounts representing distributions from other qualified defined benefit or contribution plans. Participants directed the investment of their contributions into various investment options offered by the Plan. The Plan previously offered various pooled separate accounts and two guaranteed interest contracts as investment options for participants. The Plan provided for employer matching contributions, which were invested in the same manner as employee matching contributions. The Company contributed a nondiscretionary 100% match on the first 5% of compensation that a participant had contributed to the Plan.

D. NOTES RECEIVABLE FROM PARTICIPANTS:

Prior to the resolution to terminate the Plan in 2021, participants may have borrowed from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their account balance. Loan transactions were treated as a transfer to (from) the investment fund from (to) the participant loans fund. The loans were secured by the balance in the participant's account. Any such loan must have been repaid in level payments, not less often than quarterly, over not more than five years, except that a loan to purchase a primary residence may have been paid back over a

longer period. Loan proceeds were withdrawn pro rata from the funds in which the participant's account balances were then invested; repayments were to be allocated amongst the funds in accordance with the manner in which the participant's contributions were then allocated. The interest that a participant paid to the Plan was not deductible for tax purposes, even if the participant borrowed in connection with buying a home. The interest rate applied to participant loans was 8%.

E. PARTICIPANT ACCOUNTS:

Each participant's account is credited with the participant's contribution and Company matching contributions, plus an allocation of plan earnings, and fund value increases or decreases. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

F. VESTING:

Participants are immediately vested in their voluntary contributions plus actual earnings thereon. Participants are also immediately vested in the Company's matching contribution portion of their accounts plus actual earnings thereon.

G. PAYMENT OF BENEFITS:

On termination of service due to death, disability, or retirement a participant may elect to receive the value of their accumulated plan benefits, in accordance with the provisions of the Plan, in a lump-sum distribution or IRA rollover. The Plan makes required minimum distributions in accordance with IRS regulations.

H. FORFEITURES:

Forfeitures of non-vested Company contributions are not anticipated by the Plan due to the fact that participants are immediately vested in both their elective deferrals as well as employer matching contributions.

NOTE 2: SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES:

A. BASIS OF ACCOUNTING:

The accompanying financial statements for the year ended December 31, 2022, are presented on the accrual basis of accounting. However, the December 31, 2023, financial statements are presented on the liquidation basis of accounting as a result of the imminent plan termination approved by the board.

B. INVESTMENT VALUATION AND INCOME RECOGNITION:

The investments in all of the funds are presented at fair value, based on the quoted market prices of the underlying securities within each fund at December 31, 2023. Fair value of the investment in the Fixed Accounts is estimated using discounted cash flows.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on an accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

C. NOTES RECEIVABLE FROM PARTICIPANTS:

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2023 and 2022. If a participant ceases to make loan repayments and the plan administrator deems the participant loan to be in default, the participant loan is reduced and a benefit payment is recorded in accordance with the terms of the plan document.

D. EXCESS CONTRIBUTIONS PAYABLE:

Amounts payable to participants for contributions in excess of amounts allowed by the IRS are recorded as a liability with a corresponding reduction to contributions.

E. PAYMENT OF BENEFITS:

Benefits are recorded when paid.

F. USE OF ESTIMATES:

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities, and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

G. EXPENSES:

Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Fees related to the administration of note receivable from participants are charged directly to the participant's account and included in administrative expenses. Investment related expenses are included in net appreciation of fair value of investments.

H. SUBSEQUENT EVENTS:

In 2021, the plan sponsor began offering a 401(k) Plan for active participants currently in the Tax Sheltered Annuity Plan. It is expected that a significant number of participants will continue to elect to transfer their investments to the 401(k) Plan in the upcoming years.

The Plan has evaluated subsequent events through November 22, 2024, the date the financial statements were available to be issued.

NOTE 3: FAIR VALUE MEASUREMENTS:

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability; and
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2023 and 2022.

Pooled Separate Accounts: PSA's are similar to mutual funds except that they are issued by insurance companies and are not publicly traded like mutual funds. Each share of a PSA is determined on a participation-unit basis based upon the underlying value of the investments held in the separate account. Each participant's equity account provides a cumulative record of the number of participation units credited to the account and the number of units allocated or withdrawn from the account. The balance of participation units credited to the account, multiplied by the current participation-unit value, equals the amount of equity account assets held on behalf of the participant at any given time. The participation-unit value is adjusted each business day to reflect the investment results of the assets held under the separate account.

Guaranteed investment contract: Guaranteed investment contracts are valued at fair value by the insurance company by discounting the related cash flows based on current yields of similar instruments with comparable durations considering the creditworthiness of the issuer. Because the participants transact at contract value, fair value is determined annually for financial statements reporting purposes only. In determining the reasonableness of the methodology, the custodian evaluates a variety of factors including review of existing contracts, economic conditions, industry and market developments, and overall credit ratings. Certain unobservable inputs are assessed through review of contract terms (for example, duration or payout date) while others are substantiated utilizing available market data (for example, swap curve rate).

The preceding methods may produce a fair value calculation that may not be indicative of net realizable value or reflective of future values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

NOTE 4: INVESTMENT CONTRACT WITH INSURANCE COMPANY:

The Plan entered into an investment contract with ReliaStar Life Insurance Company, totaling \$108,399 for 2023 and \$119,138 for 2022. ReliaStar maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The guaranteed investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan. The crediting rate is based on a formula established by the contract issuer but may not be less than 2 percent. The crediting rate is reviewed on a quarterly basis for resetting. The guaranteed investment contract does not permit the insurance company to terminate the agreement prior to the scheduled maturity date. The guaranteed investment contract is presented on the face of the statement of net assets available for benefits at fair value. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract or surrender value.

The Plan's ability to receive amounts due is dependent on the issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

Certain events limit the Plan's ability to transact at contract value with the issuer. Such events include (1) amendments to the plan documents (including complete or partial plan termination or merger with another plan), (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the plan sponsor or other plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the plan, (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA, or (5) premature termination of the contract. No events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuers and that also would limit the ability of the Plan to transact at contract value with the participants.

In addition, certain events allow the issuer to terminate the contract with the Plan and settle at an amount different from contract value. Such events include (1) an uncured violation of the Plan's investment guidelines, (2) a breach of material obligation under the contract, (3) a material misrepresentation, and (4) a material amendment to the agreement without the consent of the issuer.

NOTE 5: INFORMATION CERTIFIED BY THE CUSTODIAN (UNAUDITED):

Certain information related to investments disclosed in the accompanying financial statements and supplemental schedules, including investments held at December 31, 2023 and 2022, and net appreciation/depreciation in fair value of investments, interest, and dividends for the year ended December 31, 2023, was obtained or derived from information supplied to the plan administrator and certified as complete and accurate by ReliaStar Life Insurance Company (the custodian of the Plan).

NOTE 6: RELATED PARTY TRANSACTIONS:

Certain plan investments are pooled separate accounts managed by ReliaStar Life Insurance Company and offered through VOYA Financial Partners, LLC. ReliaStar Life Insurance Company is the custodian as defined by the Plan; and therefore, these transactions qualify as exempt party-in-interest transactions. Fees incurred by the Plan for these investment management services are included in net appreciation in fair value of the investment, as they are paid through revenue sharing, rather than a direct payment. Other fees paid by the Plan for investment management and administrative services amounted to \$7,686 for the year ended December 31, 2023. The plan sponsor pays directly any other fees related to the Plan's operations.

NOTE 7: PLAN TERMINATION:

The plan sponsor resolved to terminate the Plan in 2021, with its last contribution to the Plan being made on July 28, 2021. The Company now offers a 401(k) Plan in which employees are eligible to participate in and contribute to. Participants were requested to transfer assets from the Plan into the new 401(k) Plan. There are currently no requirements for participants to transfer assets. The termination is subject to the provisions set forth in the Employee Retirement Income Security Act of 1974. During 2023, \$196,544 of plan assets were transferred to the 401(k) Plan.

NOTE 8: TAX STATUS:

The Plan has been designed to qualify under Section 403(b) of the Internal Revenue Code (Code). The plan administrator believes that terms of the Plan have been prepared to conform with the written plan requirements of Regulations 1.403(b)-3 of the Code. The Plan is required to operate in conformity with the Code to maintain the tax-exempt status for plan participants under Section 403(b).

NOTE 9: RISKS AND UNCERTAINTIES:

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

The participants are notified by the plan investment advisor when the fees for transferring assets are eligible to be waived. The transfer amount of \$196,544 is composed of individuals who either did not have substantial fees to transfer assets or elected to transfer assets with a fee associated with the transaction. The transfers were treated and reported as rollovers by VOYA Financial Partners, LLC.
