The financial statements comprise the statement of net assets available for benefits as of February 24, 2022 (in liquidation) and December 31, 2021 (in liquidation), and the related statement of changes in net assets available for benefits (in liquidation) for the period January 1, 2022 to February 24, 2022, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of State Mutual Insurance Company Employees' Retirement Plan's 2022 financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained a certification from a qualified institution as of February 11, 2022 and December 31, 2021 and for the period ended February 11, 2022, stating that the certified investment information, as described in Note 4 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the 2022 Financial Statements section

- the amounts and disclosures in the accompanying financial statements (in liquidation), other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- the information in the accompanying financial statements (in liquidation) related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of State Mutual Insurance Company Employees' Retirement Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about State Mutual Insurance Company Employees' Retirement Plan's ability to continue as a going concern for one year after the date that the financial statements are issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the plan, and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditor's Responsibilities for the Audit of the Financial Statements

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit of the Financial Statements section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if, there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

In performing an audit in accordance with GAAS, we:

Accordingly, no such opinion is expressed.
- Evaluate the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluate the overall presentation of the financial statements.
- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about State Mutual Company Employees' Retirement Plan's ability to continue as a going concern for a reasonable period of time.

Our audit did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Emphasis of Matter

As discussed in Note 1 to the financial statements, the Trustee of the plan approved termination of the Plan effective June 1, 2021. In accordance with accounting principles generally accepted in the United States of America, the Plan financial statements were prepared using the liquidation basis. Our opinion is not modified with respect to this matter.

Other Matters

Supplemental Schedules Required by ERISA

The supplemental schedules of assets (held at end of year) and reportable transactions, are presented for purposes of additional analysis and are not a required part of the financial statements but are supplementary information required by the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial

statements. The information included in the supplemental schedules, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audit of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS. For information included in the supplemental schedules that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedules, we evaluated whether the supplemental schedules, other than the information agreed to or derived from the certified investment information, including their form and content, are presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

NOTE 1 – DESCRIPTION OF PLAN

The following brief description of the State Mutual Insurance Company Employees' Retirement Plan (the "Plan") is provided for general information purposes only. Participants should refer to the Plan document for more complete information.

General

The Plan is a defined benefit pension plan covering all employees of State Mutual Insurance Company (the "Company") who had completed one year of service and had attained age 21 as of December 31, 2008. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA"). The Company serves as the Plan Administrator.

The Plan Sponsor and Board of Directors froze the Plan as of December 31, 2008. The Plan no longer accepted new participants nor did the Plan accrue any future benefits beyond December 31, 2008. The term Employee shall not include any individual hired by State Mutual Insurance Company (the "Company") after December 31, 2008. An Employee shall receive no additional years of service for any period of employment after December 31, 2008. The Plan was restated effective January 1, 2020 and a volume submitter plan of Principal Life Insurance Company was adopted.

Termination

The Trustees of the Plan elected to terminate the Plan effective June 1, 2021. In accordance with generally accepted accounting principles in the United State of America, the plan changed its basis of accounting used to value the Plan assets from the ongoing basis to the liquidation basis for the year ended December 31, 2021 and the period ended February 24, 2022. See Note 11 for more details.

Pension Benefits

Employees with 5 or more years of service are entitled to annual pension benefits beginning at normal retirement age (65), the tenth anniversary of the employee's entry date, or the date the employee terminates service with the employer, whichever date comes latest. Normal retirement benefits are monthly income equal to 0.65% of average monthly compensation (the total compensation averaged over the highest three consecutive years of service within the last ten completed years of employment), plus 0.65% of monthly compensation in excess of covered compensation, all multiplied by years of service. Covered compensation is the average of the Social Security taxable wage base for the 35 years ending with the participant's 65th birthday. The Plan permits early retirement beginning at age 55 with ten or more years of service. Benefits are paid as a straight life annuity, a single life annuity with a certain period of ten years, survivorship life annuities with survivorship percentages of 50%, 75%, or 100%, or a single sum payment.

Following the restatement of the Plan as of June 1, 2021, the amount allocated to each participant is the present value of each participant's benefit, determined by the amount equal to 1% of a participant's average compensation and multiplied by their accrual service as of May 31, 2021. Benefit payments are to be provided in the form of deferred annuities, immediate annuities, and single sum payments.

NOTE 1 – DESCRIPTION OF PLAN

Vesting

A deferred annuity is payable at the participant's normal retirement date, in the amount of a percentage of the accrued benefit at the date of termination based upon the years of service in accordance with the following schedule:

<u>Years of Service</u>	<u>Vested Percentage</u>
Less than 5 years	0%
5 years or more	100%

As of June 1, 2021, participants became fully vested in their accounts due to termination of the Plan.

Death and Disability Benefits

If an active employee dies on or after their normal retirement date, a death benefit equal to the value of the employee's accumulated pension benefits is paid to the employee's beneficiary. If an active employee dies before their normal retirement date, a death benefit equal to the value of the employee's accumulated pension benefits is paid to the employee's beneficiary if the active employee's vested percentage was greater than zero. Active employees who become totally and permanently disabled receive monthly disability benefits equal to the normal retirement benefits they have accumulated as of the time they become disabled.

NOTE 2 – SUMMARY OF ACCOUNTING POLICIES

Basis of Accounting

The Plan was terminated effective June 1, 2021. At that time, management considered liquidation imminent and converted from the ongoing basis of accounting to the liquidation basis of accounting, in accordance with generally accepted accounting principles in the United States of America (US GAAP).

Valuation of Investments and Recognition of Income

Investments are reported at fair value. Fair value is the price which would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 5 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on an accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

NOTE 2 – SUMMARY OF ACCOUNTING POLICIES

Payment of Benefits

Benefits are recorded when paid.

Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires the Plan Administrator to make estimates and assumptions which affect the reported amounts of assets, liabilities, and changes therein, disclosures of contingent assets and liabilities and the actuarial present value of accumulated plan benefits. Accordingly, actual results may differ from those estimate.

NOTE 3 – ACCUMULATED PLAN BENEFITS

Accumulated plan benefits are those future periodic payments attributable under the Plan's provisions to the service employees have rendered. Accumulated plan benefits include benefits expected to be paid to (a) retired or terminated employees or their beneficiaries, (b) beneficiaries of employees who have died, and (c) present employees or their beneficiaries. Benefits under the Plan are based on employees' compensation during their highest three consecutive years of service within the last ten completed years of employment. Benefits payable under all circumstances (retirement, death, disability, and termination of employment) are included in accumulated plan benefits, to the extent deemed attributable to employee service rendered to the valuation date.

As of February 24, 2022, all assets of the Plan were paid out to participants. The Plan's assets were valued as of February 11, 2022 by Principal Trust Company, and paid out on February 24, 2022. There is no accumulated plan benefit.

NOTE 4 – CERTIFIED INVESTMENT INFORMATION

Certain information related to investments disclosed in the accompanying financial statements and ERISA-required supplemental schedules, including investments held at February 11, 2022 and December 31, 2021, and net appreciation in fair value of investments, interest and dividends for the period ended February 11, 2022, was obtained by management and agreed to or derived from information certified as complete and accurate by Delaware Charter Guarantee & Trust Company d/b/a Principal Trust Company (the custodian of the Plan). This information has not been audited by the Plan's independent auditors.

NOTE 5 – FAIR VALUE MEASUREMENTS

The Plan utilizes Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) 820, *Fair Value Measurements*. ASC 820 establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority, Level 2 inputs consist of quoted prices for similar assets or identical assets that are not active, and Level 3 inputs are unobservable and have the lowest priority. The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1

Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2

Inputs to the valuation methodology include: a) quoted prices for similar assets or liabilities in active markets; b) quoted prices for identical or similar assets or liabilities in inactive markets; c) inputs other than quoted prices that are observable for the asset or liability; and d) inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specific (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3

Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at February 24, 2022 and December 31, 2021.

Pooled separate accounts: Investments are valued at net asset value and held in pooled separate accounts through sub-accounts of an insurance company. The underlying securities in pooled separate accounts are listed on national securities and valued on the basis of year-end closing prices. While the underlying assets are actively traded on an exchange, the pooled separate accounts are not and, therefore, are classified as Level 2 investments.

The methods described above may produce a fair value calculation that is not indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

NOTE 6 – TAX STATUS

The Company adopted a volume submitter plan. The volume submitter plan received a favorable determination from the Internal Revenue Service, as of March 30, 2018, that it is acceptable under section 401 of the Internal Revenue Code (IRC). Therefore, the Plan Administrator believes the Plan was qualified and the related trust was tax-exempt as of the financial statement date.

U.S. GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the applicable taxing authorities. The Plan Administrator has analyzed the tax positions taken by the Plan and has concluded as of February 24, 2022, there are no uncertain positions taken or expected to be taken which require recognition of a liability or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE 7 – PARTIES-IN-INTEREST

Certain Plan investments are managed by Principal Life Insurance Company, and, therefore, these transactions qualify as exempt party-in-interest transactions.

NOTE 8 – FUNDING POLICY

For each Plan year, the Company shall contribute to the Plan such amounts as are required in order to meet the funding requirements imposed by law and to provide the benefits granted by this Plan, such determinations being based on the funding method and the reasonable actuarial assumptions which may be adopted and utilized from time to time by the Plan. The Plan has met the minimum funding requirements of ERISA. Contributions from employees are neither required nor permitted. Due to the Plan's underfunded status at February 24, 2022 and December 31, 2021, the minimum required contributions were \$913,867 and \$2,000,000, respectively.

NOTE 9 – COSTS OF PLAN ADMINISTRATION

The Company absorbs all significant costs of Plan administration. Expenses that are paid directly by the Company are excluded from these financial statements. The Company contracts with Principal Life Insurance Company to provide benefit payments and manage plan investments. Principal Life Insurance Company is also the Plan Actuary.

NOTE 10 – RISKS AND UNCERTAINTIES

The Plan utilizes various investment instruments, which are exposed to various risks, such as interest rates, credit, and overall market volatility. Due to the level of risk associated with certain investment securities, it is reasonably possible changes in the values of investment securities will occur in the near term and such changes could materially affect the amounts reported in the statements of net assets available for benefits.

Plan contributions are made and the actuarial present value of accumulated plan benefits are reported based on certain assumptions pertaining to interest rates, inflation rates, and employee demographics, all of which are subject to change. Due to uncertainties inherent in the estimations and assumptions process, it is at least reasonably possible changes in these estimates and assumptions in the near term would be material to the financial statements.

NOTE 11 – PLAN TERMINATION

The Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions set forth in ERISA. The Company elected to terminate the Plan effective June 1, 2021.

The residual assets will be allocated to individuals who were active participants on the day before June 1, 2021. The amount allocated to each participant was determined as follows: First, by determining an amount equal to 1% of the participant's average compensation multiplied by his accrual service on such date. Second, by determining the Present Value of the benefit determined above. Last, by multiplying the residual assets by the ratio of (i) the present value of the participant's benefit determined above, to the total of the present values of all such participants determined above.
