Report on the Audit of the Financial Statements

Opinion

We have audited the accompanying financial statements of Transport Workers Union of America Local 513 Retirement Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), which comprise the statements of net assets available for benefits (modified cash basis) as of June 30, 2024 and 2023, and the related statement of changes in net assets available for benefits (modified cash basis) for the year ended June 30, 2024, and the related notes to the financial statements.

In our opinion, the financial statements referred to above present fairly, in all material respects, the net assets available for benefits (modified cash basis) of Transport Workers Union of America Local 513 Retirement Plan as of June 30, 2024 and 2023, and the changes in its net assets available for benefits (modified cash basis) for the year ended June 30, 2024, in accordance with the modified cash basis of accounting described in Note 2.

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditors' Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of Transport Workers Union of America Local 513 Retirement Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our audit opinion.

Emphasis of Matter – Basis of Accounting

We draw attention to Note 2 to the financial statements, which describes the basis of accounting. The financial statements are prepared on the modified cash basis of accounting, which is a basis of accounting other than accounting principles generally accepted in the United State of America. Our opinion is not modified with respect to this matter.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with the modified cash basis of accounting described in Note 2, and for determining that the modified cash basis of accounting is an acceptable basis for the preparation of the financial statements in the circumstances. Management is also responsible for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the Plan, and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditors' Responsibilities for the Audit of the Financial Statements

Our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditors' report that includes our opinion. NOTE 1 DESCRIPTION OF PLAN

Plan Description

The following description of the Transport Workers Union of America Local 513 Retirement Plan (the Plan) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

General

The Plan is a multiemployer defined contribution plan formed on July 27, 1978, covering all employees of the participating employers who have one year of service. The Union became a participating employer on January 1, 1989, electing coverage for secretarial employees only.

The Plan is the result of collective bargaining agreements (CBA) between Allied Aviation Fueling Company of Texas, Inc., and effective February 9, 2022, Aircraft Service International, Inc., dba: Menzies Aviation (the Participating Employers) and Transport Workers Union. The Plan is subject to changes negotiated during periodic revisions to the CBA.

On October 9, 2008, a nonbargaining agreement was reached that allows the Plan to make contributions on behalf of eligible Plan employees. An "eligible employee" is one working at least 20 hours a week with at least one year of service.

The Plan governance consists of four trustees, two elected by the Union and two designated by the Employer. The Plan is administered and managed by the board of trustees.

The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Contributions

The Participating Employers are obligated by the terms of the collective bargaining agreement to make Plan contributions equal to one dollar and fifteen cents (\$1.15) per hour for each compensated hour of service of a Plan participant. A "Plan participant" is any union employee with a minimum of one year of service or a secretarial employee with a minimum of 90 days of service.

Contributions made for the Transport Workers Union Local 513 secretarial employees and the Plan's secretarial employees are equal to one dollar and fifteen cents (\$1.15) per hour for each compensated hour of service.

Participant Accounts

Each participant's account is credited with an allocation of (1) the participating employer's contribution, (2) Plan earnings, and (3) forfeitures of terminated participants' nonvested accounts. No forfeitures were allocated to participant accounts during the year ended June 30, 2024. Allocations are based upon participant earnings or account balances, as defined, and are limited to amounts prescribed by the Internal Revenue Code (IRC), as amended. The benefit to which a participant is entitled is the benefit that can be provided from the participant's account.

NOTE 1 DESCRIPTION OF PLAN (CONTINUED)

Vesting and Plan Forfeitures

Plan participants become fully vested in their account balances upon receiving credit for three years of service with the Employer provided they have been credited with at least one hour of service after July 1, 2010, or upon death, disability, or the attainment of normal retirement age (age 65). Prior to 2008, a participant was not fully vested until five years' service was credited to their account. In the event of the Plan's termination, participants become fully vested in their accounts. If a participant is terminated prior to accruing three years of service, the nonvested or "forfeitures" of their account are pooled into a fund within the Plan. The forfeitures are then allocated annually to the active participants' balances based on contributions made during the period or used to pay Plan expenses.

Administrative Expenses

Administrative expenses are allocated proportionately to each participant's account. Total administrative expenses for the year ended June 30, 2024 were \$77,254, including retirement contributions for Plan employees of \$2,611.

Benefit Payments

Plan participants' nonforfeitable accrued benefits are payable as soon as administratively feasible upon receipt of final contributions posting to their account balance. Vested benefits are payable at the election of the participant in a lump sum. The Plan does not provide for annuity distributions to Participants or surviving spouses.

Forfeited Accounts

At June 30, 2024 and 2023, forfeited nonvested accounts which had not been re-allocated to participant accounts are insignificant.

NOTE 2 SUMMARY OF ACCOUNTING POLICIES

Basis of Accounting

The financial statements of the Plan are prepared on the modified cash basis of accounting, which is a basis of accounting other than accounting principles generally accepted in the United States of America. Under that basis, certain additions are recognized when received and certain deductions are recognized when paid. Investments are stated at fair value. The modified cash basis of accounting differs from accounting principles generally accepted in the United States of America primarily because the effects of outstanding contributions and outstanding expenses are not included in the financial statements.

Use of Estimates

The preparation of financial statements in accordance with the modified cash basis of accounting requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

NOTE 2 SUMMARY OF ACCOUNTING POLICIES (CONTINUED)

Investment Valuation and Income Recognition

The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a settlement-date basis. Interest income is recorded on the cash basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Property and Equipment

Property and equipment is stated at cost. Depreciation is provided using the straight-line method over the estimated useful lives of the related assets. Office equipment and software is depreciated over five-years.

Benefit Payments

Benefits are recorded when paid.

Subsequent Events

The Plan has evaluated subsequent events occurring through November 14, 2024, the date the financial statements were available to be issued.

NOTE 3 FAIR VALUE OF INVESTMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy are described as follows:

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 – Inputs other than quoted prices included within Level 1 that are observable for the asset or liability, either directly or indirectly, such as:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

NOTE 3 FAIR VALUE OF INVESTMENTS (CONTINUED)

Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair market value measurement.

The asset or liability’s fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the valuation methodologies used at June 30, 2024 and 2023.

Mutual Funds – Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

NOTE 4 RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of the investment securities will occur in the near term and that such changes could materially affect participants’ account balances and the amounts reported in the statements of net assets available for benefits (modified cash basis).

NOTE 5 PLAN TERMINATION

In the event the Plan is terminated, the board of trustees shall liquidate the Plan and Trust and distribute the assets thereof, after deduction of all Plan expenses, to the participants and beneficiaries in accordance with their respective accounts as then constituted. All participants will be immediately and fully vested in their accounts in such an event.

NOTE 6 PLAN TAX STATUS

The Plan is placing reliance on a determination letter received from the IRS indicating that the Plan is designed in accordance with the applicable section of the IRC and, accordingly, the related trust's net investment income is exempt from income taxes. The Plan has been amended since receiving the determination letter. However, the Plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified, and the related trust is tax-exempt.

The modified cash basis of accounting requires Plan management to evaluate if the Plan has taken as uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE 7 PARTY-IN-INTEREST TRANSACTIONS

Investments are managed by T. Rowe Price, the Plan's custodian; therefore, the investment transactions qualify as party-in interest transactions. The Plan administrator, who is also a Plan participant, received \$32,065 to administer the Plan in accordance with the guidelines provided by the Plan Trustees. These party-in-interest transactions are exempt from the prohibited transaction rules of ERISA.
