Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of the Symmetry Surgical Inc. 401(k) Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the Plan, and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditors' Responsibilities for the Audit of the Financial Statements

Except as described in the *Scope and Nature of the ERISA Section 103(a)(3)(C) Audit* section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditors' report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if, there is substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

In performing an audit in accordance with GAAS, we:

- Exercise professional judgment and maintain professional skepticism throughout the audit.
- Identify and assess the risks of material misstatement of the financial statements, whether due to fraud or error, and design and perform audit procedures responsive to those risks. Such procedures include examining, on a test basis, evidence regarding the amounts and disclosures in the financial statements.
- Obtain an understanding of internal control relevant to the audit in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of the Plan's internal control. Accordingly, no such opinion is expressed.

- Evaluate the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluate the overall presentation of the financial statements.

Our audits did not extend to the certified investment information, except for obtaining and reading the certifications, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of GAAP.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with GAAP.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audits, significant audit findings, and certain internal control-related matters that we identified during the audits.

Other Matter - Supplemental Schedule Required by ERISA

The supplemental schedule of delinquent participant contributions for the period ended January 1, 2024, is presented for the purpose of additional analysis and is not a required part of the financial statements but is supplementary information required by the DOL's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audits of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS. For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including its form and content, is presented in conformity with the DOL's Rules and Regulations for Reporting and Disclosure under ERISA.

In our opinion

- the form and content of the supplemental schedule, other than the information in the supplemental schedule that agreed to or is derived from the certified investment information, are presented in all material respects, in conformity with the DOL's Rules and Regulations for Reporting and Disclosure under ERISA.

(1) Description of plan

The following description of the Symmetry Surgical Inc. 401(k) Plan (the "Plan") provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

Effective January 1, 2024, the Plan was closed to new participants and no additional contributions were allowed. The Plan's participants became eligible to participate in the Aspen Surgical Products Holdings, Inc. 401(k) Plan ("Aspen Plan") as of January 1, 2024. The Plan was merged into the Aspen Plan effective January 1, 2024.

(a) General

The Plan was a defined contribution plan which was adopted on February 1, 2015, to provide retirement benefits for employees of Symmetry Surgical Inc. (the "Plan Sponsor"). The Plan covered substantially all employees who were age twenty-one or older and had completed three months of service (participants). Participants were credited with service completed with Symmetry Medical, Inc. prior to the Plan Sponsor's spin-off for eligibility and vesting purposes. The Plan was subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

(b) Contributions

Prior to the merger, participants were able to voluntarily make qualified pre-tax retirement contributions to the Plan which were deductible by the participants for federal income tax purposes under Section 401(k) of the Internal Revenue Code (IRC) or could have been made after-tax in the form of a Roth 401(k) contribution. Participants could also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans. Participants directed the investment of their contributions into various investment options offered by the Plan. Participants were permitted to defer between 1% and 80% of compensation subject to certain IRC limitations.

Participants were automatically enrolled in the Plan when eligible, with a 5% deferral rate, unless the participant elected not to participate in the Plan or elected another deferral rate. The deferral rate was not adjusted prospectively until otherwise elected by the participant. Participants who notified the Plan Sponsor of their election not to participate within 90 days after the automatic deferral commenced were eligible to receive a refund of deferrals made prior to this election.

The Plan Sponsor made discretionary matching contributions of 50% of the participant's contributions up to 6% of eligible compensation, limited to a maximum of \$4,200 each plan year. The Plan Sponsor did not make any matching contributions during 2024.

The Plan also allowed the Plan Sponsor to make non-elective contributions each year in an amount authorized by the Plan Sponsor's Board of Directors; however, an annual non-elective contribution by the Plan Sponsor was not required. The Plan Sponsor did not make any non-elective contributions during 2024.

(c) Participant accounts

Each participant's account was credited (charged) with the participant's and Plan Sponsor contributions, and allocations of investment earnings (losses) and administrative expenses. Allocations were based on participant's compensation or account balances as defined in the plan agreement. The benefit to which a participant was entitled was the benefit that could be provided from the participant's vested account.

(d) Vesting

Participants were immediately vested in their elective salary deferrals plus actual earnings (losses) thereon. Vesting in the Plan Sponsor's matching and non-elective contributions was based on years of continuous service. A participant was 25% vested after one year of credited service and vested 25% each year until fully vested after four years.

(e) Notes receivable from participants

Participants borrowed from their accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The notes receivable from participants were secured by the balance in the participant's account with fixed interest rates, which were commensurate with local prevailing rates as determined quarterly by the plan administrator. Principal and interest were paid ratably through payroll deductions.

(f) Payment of benefits

On termination of service due to death, permanent disability, retirement or other reasons a participant with an account balance that exceeded \$5,000 was eligible to receive either a lump-sum payment or annual installments over a specified period equal to his or her entire vested account. If the vested value of a participant's account was less than \$1,000 the total vested balance was distributed as an automatic lump sum payment in cash. For participant accounts greater than \$1,000 but less than \$5,000, the vested value of the participant's account could be automatically rolled into an individual retirement account on behalf of the participant. On termination of service due to death or permanent disability a participant was 100% vested. In-service withdrawals were available for a participant upon attainment of age 59½.

(g) Forfeited accounts

Forfeitures were created when participants terminate employment prior to becoming fully vested in the Plan Sponsor contribution portion of their accounts. Such forfeitures were used to reduce the Plan Sponsor's contributions to the Plan or to pay Plan administrative expenses. At December 31, 2023, forfeited nonvested accounts totaled \$22,511.

(h) Hardship withdrawals

The Plan permitted distributions in the event of a hardship, as defined in the plan agreement. These distributions were taxable and subject to a tax penalty equal to 10% of the hardship distribution amount if the participant was younger than age 59½. Hardship withdrawals were limited to the participant's elective account balance and vested portion of the Plan Sponsor matching contributions and Plan Sponsor nonelective contributions.

(i) Administrative expenses

Certain expenses of maintaining the Plan were paid directly by the Plan Sponsor and were excluded from these financial statements. Fees related to recordkeeping, investment advisory services, benefit payments administration and the administration of notes receivable from participants were charged directly to the participant's account and were included in administrative expenses. Investment related expenses were included in net depreciation in fair value of investments.

(2) Summary of significant accounting policies

(a) Basis of accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

(b) Investment valuation and income recognition

Investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Finance and Systems Committee determines the Plan's valuation policies utilizing information provided by Delaware Charter Guarantee & Trust Company d/b/a Principal Trust Company ("Principal"). See Note 4 for discussion of fair value measurements.

Purchases and sales of securities were recorded on a trade-date basis. Interest income was recorded on the accrual basis. Net depreciation included the Plan's gains and losses on investments bought and sold as well as held, during the year.

(c) Notes receivable from participants

Notes receivable from participants were measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent notes receivable from participants were reclassified as distributions based upon the terms of the plan document.

(d) Payment of benefits

Benefits were recorded when paid.

(e) Events occurring after reporting date

The Plan Sponsor has evaluated events and transactions that occurred between January 1, 2024, and November 15, 2024, which is the date that the financial statements were available to be issued, for possible recognition or disclosure in the financial statements.

(3) Certified information

Certain information reported and disclosed in the accompanying financial statements, including investments and notes receivable from participants held at January 1, 2024 and December 31, 2023, and net depreciation in fair value of investments and interest income on notes receivable from participants, for the period ended January 1, 2024, was obtained or derived from information supplied to the plan administrator and certified as complete and accurate by Principal.

(4) Fair value measurements

Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) 820, *Fair Value Measurements*, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described below:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodology used for assets measured at fair value.

- (i) *Mutual funds*: Valued at the net asset value (NAV) of shares held by the Plan at year-end in an active market.

The method described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan's management believes its valuation method is appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

(5) Income tax status

The Plan Sponsor adopted a non-standardized pre-approved profit sharing plan which received a favorable advisory letter from the Internal Revenue Service (IRS) dated June 30, 2020, which stated that the non-standardized pre-approved profit sharing plan was designed in accordance with the applicable sections of the IRC. The Plan has not received a determination letter from the IRS stating that the Plan is qualified under Section 401(a) of the IRC. The plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and is therefore qualified and exempt from taxation.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability or asset if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of January 1, 2024 and December 31, 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability or asset or disclosure in the financial statements. The Plan was subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

(6) Untimely remittance of participant contributions

The Plan Sponsor is required by Department of Labor regulation to remit participant contributions and participant loan repayments as soon as practicable, but by no later than the fifteenth business day following the end of the month in which the amounts were withheld from wages. Certain contributions withheld in 2022 were not remitted timely and have been reflected in the supplemental schedule of delinquent participant contributions.

(7) Related party transactions

As described in Note 1, the Plan paid expenses to various service providers which also qualified as party-in-interest transactions. The Plan also held notes receivable from participants which qualify as party-in-interest transactions.
