As discussed in Note J to the financial statements, the Trustees voted to merge the Plan into the AHEAD, Inc. 401(k) Plan effective February 1, 2024. Substantially all plan assets were transferred to the AHEAD, Inc. Plan on February 1, 2024, with the remainder being transferred on February 21, 2024. Our opinion is not modified with respect to this matter.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with U.S. GAAP, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern within one year after the date that the financial statements are issued or available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the Plan, and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditors' Responsibilities for the Audit of the Financial Statements

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit of the Financial Statements section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditors' report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if, there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

In performing an audit in accordance with GAAS, we:

- Exercise professional judgment and maintain professional skepticism throughout the audit.
- Identify and assess the risks of material misstatement of the financial statements, whether due to fraud or error, and design and perform audit procedures responsive to those risks. Such procedures include examining, on a test basis, evidence regarding the amounts and disclosures in the financial statements.
- Obtain an understanding of internal control relevant to the audit in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of the Plan's internal control. Accordingly, no such opinion is expressed.
- Evaluate the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluate the overall presentation of the financial statements.
- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for a reasonable period of time.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of U.S. GAAP.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with U.S. GAAP.

NOTE A - DESCRIPTION OF THE PLAN

The following description of the MBX Systems 401(k) Plan (the Plan) provides only general information. Interested parties should refer to the plan document for a more complete description of the Plan's provisions.

1. **General**

The Plan was a defined contribution profit sharing and 401(k) plan covering eligible employees of MBX Systems (the Company). Employees were eligible to participate and receive Company contributions upon completion of two months of eligible service and attaining age 18. Non-resident aliens and interns were not eligible to participate in the Plan. The Plan was subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). On February 1, 2024, the Plan merged into the AHEAD, Inc. 401(k) Plan (see Note J).

2. **Contributions**

The Plan was funded by voluntary contributions of participants and discretionary matching and profit sharing contributions of the Company. Participants could contribute to the Plan, through regular payroll deductions, and participants who have attained age 50 before the end of the calendar year were eligible to make catch-up contributions. Participants could also roll over amounts representing distributions from other qualified employee benefit plans. There were no discretionary matching or profit sharing contributions to the Plan for the period January 1, 2024 through February 21, 2024. Contributions are subject to certain IRS limitations.

Effective January 1, 2023 (see Note I), the Plan included an auto-enrollment provision whereby all newly eligible employees were automatically enrolled in the Plan unless they affirmatively elected not to participate in the Plan. Automatically enrolled participants had their deferral rate set at 3% of eligible compensation and their contributions invested in a designated balanced fund until changed by the participant. A participant could also elect a different deferral percentage. Automatically enrolled participants had their deferral rate increased at a rate of 1% per year, beginning on the third year of participation, on January 1, up to a maximum of 6% of eligible compensation, unless otherwise elected by the participant. As a result of the Plan Sponsor being acquired by AHEAD, Inc. in 2023, participant and Company contributions to the Plan ceased on June 30, 2023, when the participants became eligible to contribute to the AHEAD, Inc. 401(k) Plan.

3. Investment Options

Participants were requested to direct their salary deferral contributions and the Company's contributions into a variety of investment options made available and determined by the Plan Administrator. Participants may change their investment options at any time.

4. Participant Accounts

Each participant's account was credited with the participant's contribution, an allocation of the Company's contributions, and an allocation of plan earnings. The Company's matching contributions were allocated based on a percentage of the participant's contribution. Plan earnings were allocated to participants' accounts in direct proportion to their respective account balances, based on the performance of participants' investment selections. The benefit to which a participant was entitled is the benefit that can be provided from the participant's vested account balance.

5. Vesting

Participants were immediately fully vested in participant and rollover contributions plus the actual earnings thereon. Participants were also fully vested in the portion of the participant's account that was attributable to the Company's contributions.

6. Payment of Benefits

On termination of service, a participant could elect to receive a single, lump-sum payment equal to the value of his or her vested account balance, installments over a specified period of time, or a direct rollover distribution. In service withdrawals start at age 59 1/2 and hardship withdrawals were also permitted by the Plan.

7. Notes Receivable from Participants

Notes receivable from participants were measured at their unpaid principal balance, plus any accrued but unpaid interest. Participants were permitted to take loans from the Plan up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balances. The loans were collateralized by the borrowers' respective vested account balances and bore interest at rates ranging from 4.25% to 9.50%. Principal and interest were paid through payroll deductions over a period not to exceed five years, unless for the purchase of a primary residence.

8. Administrative Expenses

Certain expenses incurred maintaining the Plan were paid directly by the Company and were excluded from these financial statements. Investment-related expenses were included in net appreciation in fair value of investments.

9. Forfeitures

At February 21, 2024 and December 31, 2023, there were no unallocated plan assets resulting from forfeited nonvested accounts. Forfeitures were to be used to reduce discretionary Company contributions or pay the Plan's administrative expenses. No forfeitures were used during the period January 1, 2024 through February 21, 2024.

NOTE B - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

1. Basis of Accounting

The financial statements of the Plan were prepared on the accrual basis of accounting. The Plan recognized employee contributions and the related employer matching contributions in the period in which the related employee contribution was withheld.

Investments held by a defined contribution plan were required to be reported at fair value, except for fully benefit-responsive investment contracts. Contract value was the relevant measure for the portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the Plan.

2. Fair Value Measurements

Current accounting standards establish a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are described below:

Level 1 Inputs to the valuation methodology are unadjusted quoted market prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 Inputs to the valuation methodology include the following:

- * Quoted prices for similar assets or liabilities in active markets;
- * Quoted prices for identical or similar assets or liabilities in inactive markets;
- * Inputs other than quoted prices that are observable for the asset or liability;
- * Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodology used for the Plan's investments measured at fair value at December 31, 2023. As discussed in Note J, the Plan did not have any investments at February 21, 2024.

Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

3. Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan Administrator determines the Plan's valuation policies utilizing information provided by the custodians. See Note B-2 for description of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Net appreciation includes the Plan's gains and losses on investments purchased and sold as well as held during the year.

4. Use of Estimates

In preparing the Plan's financial statements, management is required to make estimates and assumptions that affect the reported amounts of assets and liabilities, the disclosure of contingent assets and liabilities at the date of the financial statements, and the reported amounts of changes in net assets during the reporting period. Actual results could differ from those estimates.

5. Payment of Benefits

Benefits were recorded when paid.

NOTE C - INFORMATION CERTIFIED BY DELAWARE CHARTER GUARANTEE & TRUST COMPANY D/B/A PRINCIPAL TRUST COMPANY

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements, including investments and notes receivable from participants held at February 21, 2024 and December 31, 2023, and net appreciation in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the period January 1, 2024 through February 21, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Delaware Charter Guarantee & Trust Company d/b/a Principal Trust Company (the custodian of the Plan).

NOTE D - FULLY BENEFIT-RESPONSIVE INVESTMENT CONTRACT WITH INSURANCE COMPANY

The Plan held a fully benefit-responsive investment contract with Principal Life Insurance Company through the Principal Fixed Income Guaranteed Option which was reported at contract value. Contract value represents contributions made to the contract, plus earnings, less participant withdrawals and administrative expenses.

Principal Life Insurance Company maintained the contributions in its general account. Principal Life Insurance Company guaranteed the Plan a return of principal and interest under the terms of the contract. The interest crediting rating was updated semi-annually based upon contract provisions, and it was not to be less than 6.05%. Principal Life Insurance Company's general account was credited with earnings on the underlying investments and was charged for participant withdrawals and administrative expenses. Participants could ordinarily direct the withdrawal or transfer of all or a portion of their investments at contract value.

The Plan's ability to receive amounts due in accordance with fully benefit-responsive investment contracts was dependent on the third-party issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations could be affected by future economic and regulatory developments.

Certain events could have limited the ability of the Plan to transact at contract value with the contract issuer. These events could have been different under each contract. Examples of such events include the following: (1) the Plan's failure to qualify under Section 401(a) of the Internal Revenue Code or the failure of the trust to be tax-exempt under Section 501(a) of the Internal Revenue Code, (2) premature termination of the contracts, (3) Plan termination or merger, (4) changes to the Plan's prohibition on competing investment options, or (5) bankruptcy of the Plan Sponsor or other Plan Sponsor events (for example, divestitures or spinoffs of a subsidiary) that significantly affect the Plan's normal operations. No events were probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuers and that also would limit the ability of the Plan to transact at contract value with the participants.

In addition, certain events allow the issuer to terminate the contracts with the Plan and settle at an amount different from contract value. Those events may be different under each contract. Examples of such events include the following: (1) an uncured violation of the Plan's investment guidelines, (2) a breach of material obligation under the contract, (3) a material misrepresentation, or (4) a material amendment to the agreements without the consent of the issuer.

NOTE E - TAX STATUS

Effective December 1, 2022, the Plan had adopted a volume submitter plan sponsored by Principal Life Insurance Company. The volume submitter plan had received an opinion letter from the Internal Revenue Service as to the volume submitter plan's qualified status. The volume submitter plan opinion letter has been relied upon by this Plan. The Plan Administrator believed that the Plan was currently designed and being operated in compliance with the applicable provisions of the Internal Revenue Code.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the plan and recognize a tax liability if the plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE F - PLAN TERMINATION

The Company had the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants would have become fully vested in their respective account balances. During the period January 1, 2024 through February 21, 2024, the Plan merged the remainder of its assets into another qualified 401(k) Plan (Note J).

NOTE G - RISKS AND UNCERTAINTIES

The Plan invested in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Because of the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities could occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

NOTE H - RELATED PARTY AND PARTY-IN-INTEREST TRANSACTIONS

Plan investments were managed by the custodian and therefore, these transactions qualify as party-in-interest transactions. Fees paid by the Plan for investment management services were included as a reduction of the return earned on each investment.

The Plan issued loans to participants, which were secured by the vested balance in the participant's accounts and certain administrative fees related to the administration of the Plan were paid by the Plan or by the Company. These transactions qualified as party-in-interest. Employees of the Company provided administrative services to the Plan for which no fees were charged.

NOTE I - PLAN AMENDMENT

Effective January 1, 2023, the Plan was amended to update certain eligibility requirements to participate in the Plan and to implement an automatic enrollment provision to the Plan. Significant provisions of the restated plan documents were consistent with those of the previous plan document. Interested parties should refer to the plan documents for a more complete description of the Plan's provisions.

NOTE J - PLAN MERGER AND TRANSFER ACTIVITY

Effective February 1, 2024, the Plan was merged into the AHEAD, Inc. 401(k) Plan (the "AHEAD Plan"), a Plan administered by AHEAD, Inc. Assets of \$8,578,650, including notes from participants, were transferred to the AHEAD Plan on February 1, 2024, at which time the AHEAD Plan assumed all fiduciary responsibility. The remaining assets of \$237,081, which represented the balance invested in the Plan's fully benefit-responsive investment contract with an insurance company at February 1, 2024, were transferred to the AHEAD Plan on February 21, 2024. The participants' vested account balances in the AHEAD Plan equaled the vested account balances in the Plan upon transfer. The merger did not impact participant benefits as the Plan's benefit provisions were incorporated in the AHEAD Plan. Interested parties should refer to the AHEAD Plan document for a complete description its provisions.

NOTE K - SUBSEQUENT EVENTS

Plan management has evaluated subsequent events through November 25, 2024, the date that these financial statements were available to be issued. Plan management has determined that no events or transactions have occurred subsequent to the statement of net assets available for benefits date that require disclosure in the financial statements.
