## INDEPENDENT AUDITORS' REPORT

To the Plan Administrator of  
Mountain West Financial, Inc. 401(k) Profit Sharing Plan:

### **Scope and Nature of the ERISA Section 103(a)(3)(C) Audit for the 2024 Financial Statements**

We have performed an audit of the accompanying financial statements of Mountain West Financial, Inc. 401(k) Profit Sharing Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of August 31, 2024 (liquidation basis), and the related statement of changes in net assets available for benefits for the final period then ended (liquidation basis), and the related notes to the financial statements (2024 financial statements).

Management, having determined it is permissible in the circumstances, has elected to have the audit of the Plan's 2024 financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audit need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained a certification from a qualified institution as of and for the final period ended August 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

### ***Opinion on the 2024 Financial Statements***

In our opinion, based on our audit and on the procedures performed as described in the Auditors' Responsibilities for the Audit of the 2024 Financial Statements section:

- The amounts and disclosures in the accompanying 2024 financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- The information in the accompanying 2024 financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

### ***Basis for Opinion on the 2024 Financial Statements***

We conducted our audit in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditors' Responsibilities for the Audit of the 2024 Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audit. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

### ***Emphasis of Matter — Plan Termination and Liquidation Basis of Accounting for the 2024 Financial Statements***

As further discussed in Note 1 to the financial statements, the board of directors approved a plan termination effective June 30, 2024, and liquidated all assets of the Plan in August 2024. As a result, the Plan used the liquidation basis of accounting in the 2024 financial statements. Our opinion is not modified with respect to this matter.

### ***Responsibilities of Management for the 2024 Financial Statements***

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the plan, and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

### ***Auditors' Responsibilities for the Audit of the 2024 Financial Statements***

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditors' report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and, therefore, is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if, there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

In performing an audit in accordance with GAAS, we:

- Exercise professional judgment and maintain professional skepticism throughout the audit.
- Identify and assess the risks of material misstatement of the financial statements, whether due to fraud or error, and design and perform audit procedures responsive to those risks. Such procedures include examining, on a test basis, evidence regarding the amounts and disclosures in the financial statements.
- Obtain an understanding of internal control relevant to the audit in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of the Plan's internal control. Accordingly, no such opinion is expressed.

Our audit did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

***Other Matter - Auditors' Report on the 2023 Financial Statements***

The 2023 financial statements of the Plan were audited by predecessor auditors. As permitted by ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA, the plan administrator instructed the predecessor auditor not to perform, and they did not perform, any auditing procedures with respect to the information certified by a qualified institution. Their report dated September 11, 2024, indicated that (a) because of the significance of the information that they did not audit, they were not able to obtain sufficient appropriate audit evidence to provide a basis for an audit opinion and accordingly, they did not express an opinion on the financial statements and supplementary information, and (b) the form and content of the information included in the financial statements and supplementary information other than that derived from the certified information were presented in compliance with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

**NOTE 1 – Description of the Plan**

The following description of the Mountain West Financial, Inc. 401(k) Profit Sharing Plan (the Plan) provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

***General***

The Plan was a defined contribution plan which covered substantially all employees of Mountain West Financial, Inc. (the Company) who had completed three months of service and were aged 18 or older. Union employees and non-resident aliens were excluded from the Plan. The Plan was subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Plan's management was responsible for oversight of the Plan. The Investment Committee determined the appropriateness of the Plan's investment offerings, monitored investment performance, and reported to the Plan's management and internal trustees.

***Plan Termination***

The board of directors of the Company approved the termination of the Plan effective June 30, 2024. Pursuant to the amendment to terminate the Plan, no participants were permitted to enter the Plan after the effective date, there were no benefit accruals after such date, and participants became fully vested in their accounts under the Plan. All assets of the Plan were distributed to the participants, rolled into another eligible plan, or converted to an individual retirement account during the final period ended August 31, 2024.

***Contributions***

Prior to June 30, 2024, participants could contribute up to 100% of pretax annual compensation, as defined in the Plan. In addition, participants could elect to make after-tax (Roth) contributions to the Plan of up to 100% of eligible compensation. Participants who had attained age 50 before the end of the plan year were eligible to make catch-up contributions. Participants could also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover). Participants directed the investment of their contributions into various investment options offered by the Plan.

**NOTE 1 – Description of the Plan (Continued)**

***Contributions (Continued)***

The Plan included an auto-enrollment provision whereby all newly eligible employees hired prior to June 30, 2024, were automatically enrolled in the Plan unless they affirmatively elected not to participate in the Plan. Automatically enrolled participants had their deferral rate set at 4% of eligible compensation and their contributions invested in a designated fund until changed by the participant.

Prior to June 30, 2024, the Plan provided for company discretionary matching contributions and discretionary nonelective contributions. During the final period ended August 31, 2024, the Company did not make any contributions. Contributions were subject to certain Internal Revenue Service (IRS) limitations.

***Participant Accounts***

Each participant's account was credited with the participant's contributions, as well as allocations of the Company's discretionary matching contributions, discretionary nonelective contributions, and plan earnings. Participant accounts were charged with an allocation of administrative expenses that were paid by the Plan. Allocations were based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant was entitled was the benefit that could be provided from the participant's vested account.

***Vesting***

Participants were vested immediately in their contributions plus actual earnings thereon. Vesting in the Company's contribution portion of their accounts was based on years of continuous service. A participant was 100% vested after three years of credited service. Upon termination of the Plan, all active participants became 100% vested in all company contributions.

***Notes Receivable from Participants***

Participants could borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The loans were secured by the balance in the participant's account. The loan interest rate was set at 2% above the prime rate, as defined. Principal and interest was paid ratably through payroll deductions.

***Payment of Benefits***

On termination of service due to death, disability, or retirement, a participant could elect to receive either a lump-sum amount equal to the value of the vested interest in the participant's account, partial, or nonperiodic payments. Upon termination of the Plan, participants could also elect to receive a lump-sum payment of the value of the vested interest in their account balance.

***In-Service Withdrawals***

Participants who were at least 59-½ years of age were entitled to receive a distribution of all or any portion of their vested account balance.

Hardship withdrawals, which met a hardship purpose of immediate and heavy financial need, were permitted as provided in the plan agreement. Such amounts could be drawn from participant rollover contributions and employer matching contributions and could be subjected to certain income tax penalties.

***Forfeited Accounts***

At August 31, 2024 and December 31, 2023, forfeited nonvested accounts totaled \$0 and \$61,781, respectively. These accounts were used to reduce future employer contributions or to pay administrative expenses. During the final period ended August 31, 2024, administrative expenses of \$43,815 were paid from forfeited nonvested accounts. Also, in 2024, \$36,704 in forfeited nonvested accounts were allocated to participant accounts.

**NOTE 2 – Summary of Accounting Policies**

***Basis of Accounting***

As described in Note 1 to the financial statements, on June 30, 2024, the plan was terminated. As a result, in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP), the Plan used the liquidation basis of accounting. The use of the liquidation basis of accounting did not have a significant impact on the financial statements.

***Use of Estimates***

The preparation of financial statements in accordance with U.S. GAAP required management to make estimates and assumptions that affected the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

***Investment Valuation and Income Recognition***

Investments were reported at fair value. Fair value was the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's management determined the Plan's valuation policies utilizing information provided by the investment advisers, custodians, and insurance company. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities were recorded on a trade-date basis. Interest income was recorded on the accrual basis. Dividends were recorded on the ex-dividend date. Net appreciation included the Plan's gains and losses on investments bought and sold as well as held during the year.

***Notes Receivable from Participants***

Notes receivable from participants were measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income was recorded on the accrual basis. Related fees were recorded as administrative expenses and were expensed when they were incurred. No allowance for credit losses was recorded as of August 31, 2024 or December 31, 2023.

***Payment of Benefits***

Benefits were recorded when paid.

***Expenses***

Certain expenses of maintaining the Plan were paid by the Plan, unless otherwise paid by the Company. Expenses that were paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants were charged directly to the participant's account and were included in administrative expenses. Investment-related expenses were included in net appreciation of fair value investments.

***Subsequent Events***

The Plan has evaluated subsequent events through November 15, 2024, the date the financial statements were available to be issued.

**NOTE 3 – Certified Investments**

The plan administrator elected the method of annual reporting compliance permitted by ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Voya Retirement Insurance and Annuity Company (Voya), the custodian of the Plan, certified that the following data included in the accompanying financial statements was complete and accurate with respect to investments:

- Investments at fair value
- Net appreciation in fair value of investments
- Dividends

The Plan's independent public accountants did not perform auditing procedures with respect to this information, except for comparing such information to the related information included in the financial statements.

**NOTE 4 – Fair Value Measurements**

The framework for measuring fair value provided a fair value hierarchy that prioritized the inputs to valuation techniques used to measure fair value. The hierarchy gave the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under Topic 820 were described as follows:

**Level 1** Inputs to the valuation methodology were unadjusted quoted prices for identical assets or liabilities in active markets that the Plan had the ability to access.

**Level 2** Inputs to the valuation methodology included:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that were observable for the asset or liability; and
- inputs that were derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability had a specified (contractual) term, the level 2 input must have been observable for substantially the full term of the asset or liability.

**Level 3** Inputs to the valuation methodology were unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy was based on the lowest level of any input that was significant to the fair value measurement. Valuation techniques maximized the use of relevant observable inputs and minimized the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There had been no changes in the methodologies used at December 31, 2023.

***Interest-bearing cash:*** Valued at cost plus accrued interest, which approximated fair value.

**Mutual funds:** Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan were open-end mutual funds that were registered with the U.S. Securities and Exchange Commission. These funds were required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan were deemed to be actively traded.

**Collective trust funds:** Valued at net asset value (NAV) of units of a collective trust. The NAV was based on the fair value of the underlying investments held by the fund, less its liabilities. Participant transactions (purchases and sales) may have occurred daily. Were the Plan to initiate a full redemption of the collective trust, the investment adviser reserved the right to temporarily delay withdrawal from the trust in order to ensure that securities liquidations were carried out in an orderly business manner.

**NOTE 5 – Related-Party Transactions and Party-in-Interest Transactions**

Certain plan investments were managed by Voya. Voya was the custodian and recordkeeper for the Plan and, therefore, these transactions qualified as party-in-interest transactions. Fees incurred by the Plan for investment management services were included in net appreciation in fair value of the investment, as they were paid through revenue sharing, rather than a direct payment. As described in Note 2, the Plan made a direct payment to the custodian and recordkeeper of \$64,439, which was not covered by revenue sharing. The plan sponsor paid directly any other fees related to the Plan’s operations.

As described in Note 1, the Plan was terminated effective June 30, 2024 and all participants became 100% vested in their account balances.

**NOTE 7 – Tax Status**

On June 30, 2020, the IRS stated that the non-standardized pre-approved profit-sharing plan adopted by the Plan, as then designed, qualified under Section 401(a) of the Internal Revenue Code (IRC). The Plan had not received a determination letter specific to the Plan itself; however, the plan administrator believed that the Plan was designed and was being operated in compliance with the applicable requirements of the IRC. Therefore, no provision for income taxes had been included in the Plan's financial statements.

U.S. GAAP required plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan had taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan was subject to routine audits by taxing jurisdictions; however, there was currently no audits for any tax periods in progress.

**NOTE 8 – Risks and Uncertainties**

The Plan invested in various investment securities. Investment securities were exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it was at least reasonably possible that changes in the values of investment securities would occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits (liquidation basis).
