Emphasis-of-Matter

As discussed in Note 1 to the financial statements, the Board of Directors of ADAPT Community Network, sole member of The New York League for Early Learning, Inc., voted in December 2023 to terminate the NYL 403(b) Plan and merge the remaining assets of the Plan into the Tax Deferred Annuity Plan of ADAPT Community Network as of December 31, 2023. Our opinion is not modified with respect to that matter.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with the modified cash basis of accounting described in Note 2; this includes determining that the modified cash basis of accounting is an acceptable basis for the preparation of the financial statements in the circumstances. Management is also responsible for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

NOTES TO FINANCIAL STATEMENTS DECEMBER 31, 2023 AND 2022

1. DESCRIPTION OF PLAN

The following brief description of NYL 403(b) Plan (the "Plan") provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

The Board of Directors of ADAPT Community Network, sole member of The New York League for Early Learning, Inc., voted in December 2023 to terminate the Plan and merge the remaining assets of the Plan into the Tax Deferred Annuity Plan of ADAPT Community Network as of December 31, 2023. As a result, all investments were transferred from the Plan into the Tax Deferred Annuity Plan of ADAPT Community Network Plan as of December 31, 2023.

General and Eligibility

The Plan was an employee salary reduction contribution plan covering all employees of The New York League for Early Learning, Inc. (the "Agency"). Employees could contribute to the Plan immediately following employment at the Agency. The Plan was subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA"). The Plan was administered by ADAPT Community Network, the sole member of the Agency, through a management service agreement. Mutual of America Life Insurance Company (Mutual of America), Nationwide Life Insurance Company (Nationwide), were custodians and recordkeepers of the Plan during 2023 and 2022.

Effective April 1, 2019, all employees of the Agency became employees of ADAPT Community Network (ADAPT) and all contributions into this Plan ceased. As a result, there were no employee contributions into this plan as of that date. All contributions on wages earned after April 1, 2019 were made into the Tax Deferred Annuity Plan of ADAPT Community Network.

Employee Contributions

All contributions into the plan ceased on April 1, 2019 as all employees became employees of ADAPT Community Network on that date and became eligible to participate in the Tax Deferred Annuity Plan of ADAPT Community Network. There were no employee contributions into the Plan for the year ended December 31, 2023 or 2022.

Prior to April 1, 2019, participants could contribute a portion of pretax annual compensation, as defined in the plan document, up to the maximum limits of the Internal Revenue Code ("IRC"). Participants who had attained age 50 before the end of the plan year were eligible to make catch-up contributions. Participants could also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover). Employer contributions to the Plan were prohibited. Participants directed the investment of all contributions into various investment options offered by the Plan and could change investments at any time.

Participant Accounts

Each participant's account is credited with the participant's contribution and plan earnings (losses). Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

1. DESCRIPTION OF PLAN (Continued)

Vesting

Participants were vested immediately in their contributions plus actual earnings thereon.

Payment of Benefits

Upon termination of service due to death, disability, retirement, or other reasons, a participant could receive a lump-sum distribution equal to the value of the participant's vested interest in their account. In addition, the Plan allowed for hardship distributions if certain criteria were met.

Group Annuity Loan

Participants could borrow directly through Mutual of America, subject to certain limitations. Group annuity loans were issued from the funds owned by Mutual of America and loan proceeds were not removed from a participant's account balance. When group annuity loans were initiated, 120% of the loan amount was reserved, or held in collateral, from the participant's account to cover the outstanding loan amount for the period of time the loan was outstanding. Collateral was held in the participant's account in the Mutual of America Interest Accumulation investment option.

The loans bear interest at rates commensurate with local prevailing rates at the time funds were borrowed as determined by the plan administrator. Principal and interest were paid by the participants directly to Mutual of America. Group annuity loans were not considered assets of the Plan. As of December 31, 2023 and 2022, there were no outstanding group annuity loan balance.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The accompanying financial statements are prepared on the modified cash basis of accounting, which is a comprehensive basis of accounting other than accounting principles generally accepted in the United States of America. As such, certain assets and the related additions to net assets available for benefits and certain liabilities and the related deductions from net assets available for benefits may not be recognized until cash is received or paid. The primary effects of the use of the modified cash basis of accounting on the accompanying financial statements are that deemed distributions are not recognized until cash is paid. Accordingly, the accompanying financial statements are not intended to be presented in accordance with accounting principles generally accepted in the United States of America.

Use of Estimates

The preparation of financial statements in accordance with the modified cash basis of accounting requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities, and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of revenues and expenses during the reporting period. Actual results could differ from those estimates.

Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits – modified cash basis. All plan assets were transferred to the Tax Deferred Annuity Plan of ADAPT Community Network as of December 31, 2023.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (Continued)

Investment Valuation and Income Recognition

Investments are reported at fair value (except for fully benefit-responsive investment contracts, which are reported at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Contract value is the relevant measure for the portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the Plan. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net (depreciation) appreciation of investments includes the Plan's gains and losses on investments bought and sold, as well as held during the year.

Fully Benefit Responsive Guaranteed Interest Accounts

Mutual of America General Account Fund

All amounts allocated to the Interest Accumulation Account become part of Mutual of America's general account. The amount in the Interest Accumulation Account at any time will be equal to the sum of all amounts that have been allocated to such account, including interest credited to the account, less the sum of all amounts that have been withdrawn from such account. Participants' principal and previously-credited interest are guaranteed. Mutual of America assumes the investment risk of the underlying investments of the Interest Accumulation Account. This guarantee is subject to Mutual of America's financial strength and claims-paying ability. Mutual of America's general account investment strategy is to maintain high-quality assets with excellent liquidity, strong capital adequacy, and a proper matching of assets and liabilities.

The general account is credited with interest at a rate determined by Mutual of America from time to time, and Mutual of America reserves the right to change the interest rates applicable to amounts held in this account at their discretion, but not below the minimum guaranteed interest rate. The crediting rate determined by Mutual of America was 1.00% as of December 31, 2023 and 2022.

Requests for withdrawal (subject to Plan provisions) can be made at any time and are processed on the day that they are received; they are not dependent on Mutual of America having to liquidate securities in order to generate a payment. The contract value is the redeemable value of the fund; there are no deferred sales charges, load assessments, interest rate adjustments, or surrender charges that would affect the value as a result of a withdrawal request. The amounts held in the general account are considered fully benefit responsive.

Payment of Benefits

Benefits are recorded when paid.

Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Agency. Expenses that are paid by the Agency are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation (depreciation) of investments.

3. FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under authoritative guidance are described as follows:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs other than quoted prices included within Level 1 that are observable for the asset or liability, either directly or indirectly, such as:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used as of December 31, 2023 and 2022:

Fixed Accounts - The Nationwide Fixed Accounts are carried at book value plus a market value adjustment less a contingent deferred sales charge, when applicable (none at December 31, 2023 or December 31, 2022). All unobservable inputs for Level 3 assets are developed by Nationwide Life (Level 3).

Investments Measured using the Net Asset Value per Share Practical Expedient

The Plan has financial instruments which are recorded at fair value in the accompanying statements of net assets available for benefits.

Pooled separate accounts - Valued using net asset value ("NAV") as a practical expedient to estimate fair value where NAV is based on the value of the underlying investment assets held through sub-accounts of a separate account of an insurance company. This practical expedient is not used when it is determined to be probable that the account will sell the investment for an amount different than the reported NAV. There are currently no redemption restrictions or unfunded commitments on these investments. The pooled separate accounts are privately managed through investment companies and are not publicly quoted. Pooled separate accounts are comprised primarily of shares of registered investment companies.

4. FULLY BENEFIT-RESPONSIVE INVESTMENT CONTRACTS

The Plan's ability to receive amounts due in accordance with fully benefit-responsive investment contracts disclosed in Note 2 is dependent on the third-party issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments. Certain events might limit the ability of the Plan to transact at contract value with the contract issuer. These events may be different under each contract. Examples of such events include the following:

1. The Plan's failure to qualify under Section 401(a) of the Internal Revenue Code ("IRC") or the failure of the trust to be tax-exempt under Section 501(a) of the IRC.
2. Premature termination of the contracts.
3. Plan termination or merger.
4. Changes to the Plan's prohibition on competing investment options.
5. Bankruptcy of the Plan sponsor or other plan sponsor events (for example, divestitures or spinoffs of a subsidiary) that significantly affect the Plan's normal operations.

No events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuers and that also would limit the ability of the Plan to transact at contract value with the participants.

4. FULLY BENEFIT-RESPONSIVE INVESTMENT CONTRACTS (Continued)

In addition, certain events allow the issuer to terminate the contracts with the Plan and settle at an amount different from contract value. Those events may be different under each contract.

Examples of such events include the following:

1. An uncured violation of the Plan's investment guidelines.
2. A breach of material obligation under the contract.
3. A material misrepresentation.
4. A material amendment to the agreements without the consent of the issuer.

There are no reserves against contract values for credit risk of the contract issuer or otherwise. The crediting interest rate is based on a contractually guaranteed interest rate that may not be less than zero percent. Such interest rates are reviewed on a quarterly basis for resetting.

Generally, there are no events that could limit the ability of the Plan to transact at contract value. The contracts do not permit the insurance companies to terminate the agreements prior to the scheduled maturity dates. At December 31, 2023 and 2022, there are no unfunded commitments and investments are redeemed on a daily basis. The Plan merger with the Tax Deferred Annuity Plan of ADAPT Community Network did not impact the value of these contracts.

5. PARTY-IN-INTEREST TRANSACTIONS

Transactions between Mutual of America, Nationwide, and the Plan qualify as party-in-interest transactions since those organizations also provide custodial and recordkeeping services to the Plan.

6. PLAN TERMINATION

As noted in Note 1, all contributions into the Plan ceased as of April 2019. The Agency has the right to terminate the Plan, in whole or in part, at any time subject to the provisions set forth by ERISA.

The Board of Directors of ADAPT Community Network, sole member of The New York League for Early Learning, Inc., voted in December 2023 to terminate the Plan and merge the remaining assets of the Plan into the Tax Deferred Annuity Plan of ADAPT Community Network as of December 31, 2023. As a result, all investments were transferred from the Plan into the Tax Deferred Annuity Plan of ADAPT Community Network Plan as of December 31, 2023.

7. TAX STATUS

The Plan has been designed to qualify under Section 403(b) of the IRC. A prototype document was used by the Plan to obtain its latest determination letter on November 30, 2020, in which the Internal Revenue Service stated that the Plan, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code. Although the Plan has been amended since receiving the determination letter, the Plan administrator and the Plan's tax counsel believe that the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code. Therefore, no provision for income taxes has been included in the Plan's financial statements.

8. CERTIFIED FINANCIAL INFORMATION

The Plan administrator has elected the method of annual reporting compliance permitted by 29 CFR 2520.103-8 of the Department of labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, the custodians have certified that the following data included in the accompanying financial statements and supplemental schedule is complete and accurate as of and for the years ended December 31, 2023 and 2022. Mutual of America and Nationwide provided certifications as of and for the years ended December 31:
